## Eye on education

Hong Kong's tertiary surveying programmes are adapting to the evolving needs of the profession, training up graduates with the theoretical knowledge and practical experience required for success.

#### Today's surveyors need to face complex problems, work with other specialists as a team and communicate with different stakeholders.

The surveying profession requires stringent training and long-term practice, and Hong Kong's tertiary institutions were among the first in the world to provide common surveying programmes to achieve these aims. In this issue we take a look at some of these programmes by talking to five leading surveyors from the academic sphere, examining the rationale behind each programme's framework and the future prospects for graduates.

#### The University of Hong Kong

The University of Hong Kong (HKU) launched a revamped surveying programme in 1988, which in fact was the world's first common BSc (Surveying) degree combining most major sub-disciplines, excluding land surveying.

"Universities are all about being towers of intellectual inspiration rather than of technical training," says Sr Prof K W Chau, Head and Chair Professor, Department of Real Estate and Construction at HKU. "We accept top students and help build their professional knowledge with a theoretical foundation, training fast learners who can adapt to the ever-changing institutional environment. Rather than spending time on mastering technical skills that evolve over time and vary across markets, students acquire and apply transferrable knowledge to solve built environment problems from various perspectives. During practice, our graduates pick up technical skills quickly and perform fabulously in qualifying examinations."

The BSc programme's Surveying Studio allows students to integrate and apply theoretical knowledge to solve real-life problems in practical, yet creative, ways. "We encourage out-of-the-box solutions for challenging scenarios – it is fine to make mistakes in the Studio so that lessons can be learned," Chau says. "This does not mean that students are detached from the real world, as the programme's Professional Workshop and Internship components are also important parts of the degree."

In recent years, professional elements from other built environment disciplines have been introduced into the programme. "Today's surveyors need to face complex problems, work with other specialists as a team and communicate with different stakeholders to solve externality problems such as sustainability and conservation," Chau says. "Our common surveying programme nurtures graduates with these qualities which employers look for, while helping graduates and employers adapt to fluctuations in job demand across sub-disciplines."

#### The Hong Kong Polytechnic University

With close to 80 years of experience delivering surveying

education under the former Government Trade School, the Hong Kong Polytechnic University (PolyU) now runs a four-year BSc (Hons) in Surveying degree. The programme is one of the university's most popular among high achievers and offers advanced subjects in the third and fourth years with electives in Building Surveying, General Practice Surveying, Planning and Development, Property and Facility Management, and Quantity Surveying. It is also one of the few programmes that feature substantial teaching on the subject of measurement.

"What is most important is that our graduates need to know the social, economic and political contexts of a project before tackling the surveying dimension and finally the project itself," says Sr Prof Yat-hung Chiang from the Department of Building and Real Estate at PolyU.

"Regarding the social context for instance, should housing be built in country parks so that people have places to live? From the industry perspective, Hong Kong sees high construction costs mostly due to high wages and labour shortages. At the project level, surveyors have to find solutions such as deploying less labour-intensive materials and increasing automation."

PolyU aims to nurture students' ability to identify issues, ask questions and work with multiple parties. Students go through Work-Integrated Education or credit-bearing internships in the workplace, as well as participate in sessions on subjects such as problem-solving to ensure they have a broad perspective that is well-connected to real issues.

"Surveying students are sometimes called jacks of all trades," Chiang says. "Our goal is to nurture them to become masters of all. In the long run, a broad-based education is more important for long-term employability than technical knowledge. In the fast-changing world of surveying, adaptability is the key."

#### City University of Hong Kong

City University of Hong Kong (CityU) runs a four-year BSc in Surveying degree under its Department of Architecture and Civil Engineering. The four-year common surveying programme, granted cognate degree status by HKIS's Building Surveying and Quantity Surveying divisions, includes courses for accreditation as cognate degree specified by these divisions. Aiming for a balance between intellectual, professional and practical elements, the programme aims to nurture skilled surveyors with the ability to reflect on their own decisions and those of others.

Meanwhile, CityU's Division of Building Science and

Technology runs a two-year ASc (Associate of Science) in Surveying. "The programme prepares students for real work right after graduation," says Sr Dr Lawrence Wingcheung Poon, Senior Lecturer of CityU's Division of Building Science and Technology, and Chairman of HKIS's Board of Education. "The final-year project requires students to tackle real cases, with presentations being judged by distinguished industry practitioners. And as students select the area they want to specialise in from Building Surveying, Estate Surveying and Quantity Surveying after the first semester, they will develop a profound understanding of their specialisation."

Upon graduation, Poon adds, some students go straight into employment or study full-time for local top-up surveying degrees while many others study part-time towards Bachelor degrees at the University College of Estate Management, UK. "Our graduates have the advantage of having years of substantial work experience when entering qualifying examinations."

#### **Institute of Vocational Education**

The VTC Group's IVE runs a two-year Higher Diploma in Surveying featuring final-year electives including Building Surveying and Quantity Surveying. The highlight of the vocation-based programme is a three-month industrial attachment in the final year, which is also a credit-bearing graduation requirement.

"After the industrial attachment, more than 50 per cent of graduates seek long-term employment in the same company as assistant surveyors or surveying trainees," says Sr Dr Ken Hui, Senior Lecturer, Department of Construction at IVE. "Many study towards part-time top-up Bachelor degrees offered by our partners – including the UK's University of Central Lancashire and Australia's RMIT University – while working towards professional qualifications. Our programme has been complimented by employers for being practical and strong, especially in the measurement of building works, and our graduates are ready for work."

#### Technological and Higher Education Institute of Hong Kong

Also a part of the VTC Group, the Technological and Higher Education Institute of Hong Kong (THEi) launched a self-funded four-year full-time BSc (Honours) in Surveying this September. In the third and fourth years, the degree programme offers two multiple specialisation streams: (1) Quantity Surveying and Property & Facility Management; and (2) Building Surveying, General Practice Surveying and Planning & Development.

"We strike a balance between the integrated and the specialised approaches and we have considered feedback from employers in order to train up work-ready graduates who have knowledge of, for instance, both valuation and renovation to meet real working needs," says Sr Prof Daniel C W Ho, Associate Dean, Faculty of Design and Environment at THEi. "The skill-based BSc (Honours) in Surveying programme thrives on work-integrated learning and includes an internship scheme that focuses on solving real-life problems. Our studio projects and graduation project address problems raised by the profession."

Ho adds that THEi will inject new elements into the curriculum as the profession requires. "This could include, for example, the application of advanced technology for surveying, e.g. BIM, to provide a down-to-earth professional education – an alternative which should be equally respectable and attractive to students and employers."

#### **Looking forward**

The five surveyors mostly agree that while the standard of Hong Kong's surveying students and educators/instructors are higher than those of their UK and Australian counterparts, there is still room for improvement. HKU's Chau, for instance, thinks that Hong Kong needs to invest more in surveying research to help bridge the gap between research and practice, and encourage local surveying graduates to pursue PhDs.

THEi's Ho considers local surveying training relatively conservative and thinks that local students are not taking full advantage of opportunities in the world's emerging economies. More importantly, he is concerned that universities nowadays are keen on achieving high international rankings through excellence in research, thus resulting in a gap with professional needs.

"Whereas research is invaluable, for professional degrees it is important that teachers with industry experience train up graduates with practical and professional knowledge," Ho says. "A cultural change and a closer link with the profession are needed to bridge the gap. In Europe, there are highly respected technical or applied sciences universities with top-notch professional training and applied research."

PolyU's Chiang stresses the need for a greater focus on automation. "Hong Kong is lagging behind Mainland China regarding automation technologies. With our high construction costs, surveyors should attempt to turn the situation into an opportunity by developing automation technologies."

## 著眼教育

香港的測量學大專課程配合業界不斷變化的需求,為畢業生增進成功所需的理論知識及實際經驗。

測量專業需要嚴格訓練及長期實踐,為達致這些目的,香港 大專院校是全球第一批提供一般測量學課程。今期我們訪 問五位來自學術界的頂尖測量師,以了解其中一些課程的面 貌,探討每個課程架構的理念及畢業生的出路。

#### 香港大學

香港大學(港大)於 1988年開辦改革後的測量學課程,亦 是全球第一個結合各大領域(不包括土地測量)的一般理學 士(測量學)課程。

港大房地產及建設系主任兼講座教授鄒廣榮教授測量師表示:「大學是知識啟發的殿堂,而不是培訓技術的場所。我們錄取優秀的學生,以理論基礎幫助他們學習專業知識,培育他們適應多變環境而迅速學習。學生汲取和應用可轉移的知識,從不同角度解決建築環境的各種問題,而不是花時間去精通隨時間演進、因市場而異的技術。在實踐過程中,我們的畢業生可迅速掌握技術,並於專業考試中表現優異。」

理學士課程的「測量工作室」讓學生整合並應用理論知識, 以實用而創新的方法解決現實生活中的問題。鄒廣榮指:「面 對具挑戰性的情境,我們鼓勵學生突破思想界限,解決難題。 在工作室犯錯無妨,如此方能汲取教訓。這不表示學生脱離 真實世界,測量學課程的專業工作坊及實習亦是相當重要的 部分。」

此課程近年引入其他建築環境學科的專業元素。鄒廣榮說:「今日的測量師需要面對複雜的問題,與其他專家通力合作,並與各持份者溝通,以解決可持續發展及保育等外在問題。本校的一般測量學課程為畢業生培養僱主欣賞的這些特質,同時幫助畢業生及僱主適應不同領域就業需求的變動。」

#### 香港理工大學

香港理工大學(理大)的前身香港官立高級工業學院,提供 測量學教育近80年;今天,理大設有四年制地產及建設測 量學(榮譽)理學士學位,是最受優異生歡迎的理大課程之 一,學生可於三年級和四年級選修進階科目,包括建築測量、 產業測量、規劃及發展、物業設施管理及工料測量,該課程 亦是少數著重教授量度知識的課程之一。

理大建築及房地產學系蔣日雄教授測量師指出:「我們的畢業生最重要首先了解一個項目的社會、經濟及政治背景,然後處理測量層面的問題,最後才是項目本身。」

「以社會背景為例,房屋應建於郊野公園,讓市民居有定所嗎?站在業界的角度來看,香港建築成本高是由於工資高昂及勞工短缺;以項目的層面而言,測量師必須找出解決辦法,如減少使用勞力密集的材料,增加自動化。」

理大希望培養學生識別問題、提問及與多方合作的能力。學 生透過「校企協作教育」或學分制實習,以及參加有關解決 問題的講座,以建立與現實生活息息相關的宏觀視角。

蔣日雄表示:「測量系學生有時被視為『萬事通』,而我們的目標正是培養學生精通十八般武藝。長遠而言,對就業能力來說,廣泛教育比技術知識較為重要。測量業瞬息萬變,適應力才是關鍵。」

#### 香港城市大學

香港城市大學(城大)建築學及土木工程學系設有四年制的 測量學理學士學位,這個一般測量學課程獲香港測量師學會 建築測量組及工料測量組認可為測量專業學位,課程包括由 學會這些組別認可為測量專業的科目。課程旨在於知識、專 業及實用之間取得平衡,培養具備熟練技能的測量師,並有 能力思考自己和他人的決定。

城大建築科技學部同時開辦兩年制的測量學副理學士課程, 城大建築科技學部高級講師兼香港測量師學會教育委員會主 席潘永祥博士測量師表示:「該課程讓學生畢業後就能進入 職場。畢業專題習作要求學生處理真實個案,並發表簡報, 由傑出的業界人士評價。學生完成第一個學期後,從建築測 量、產業測量及工料測量中選擇專修領域,從而深入了解相 關範疇。」

潘永祥補充道,有些學生畢業後立刻進入職場,或修讀本地 全日制測量學銜接學位,許多則於英國的 University College of Estate Management 兼讀學士學位。「本校畢業生參加專業考 試時已具有數年工作經驗,有明顯優勢。」

#### 香港專業教育學院

職業訓練局轄下的香港專業教育學院開辦兩年制測量學高級 文憑,最後一年級的選修科包括建築測量及工料測量。該職 業課程的重點是學生在課程最後一年需進行三個月實習,亦 為畢業的學分條件之一。

香港專業教育學院建造工程系高級講師許亦鈞博士測量師 指:「逾五成畢業生於實習後希望在同一間公司繼續工作, 擔任助理測量師或測量學員。許多人修讀我們的夥伴大學 (包括英國中央蘭開夏大學及澳洲墨爾本皇家理工大學) 開 設的兼讀制學士學位銜接課程,同時致力取得專業資格。我 們的實用課程深受僱主讚賞,當中的建築工料量度科目尤其 如是,而學生畢業後便馬上投入工作。」

#### 香港高等教育科技學院

香港高等教育科技學院亦為職業訓練局的機構成員,於今年 九月開辦四年全日制自資測量學(榮譽)理學十。該學位課 程在三年級及四年級提供兩個多重專修科: (一) 工料測量 和物業及設施管理,以及(二)建築測量、產業測量和規劃 及發展。

香港高等教育科技學院環境及設計學院副院長何志榮教授測 量師説:「我們在綜合與專門範疇中尋找平衡,並參考僱主 的意見,以培訓能立刻投入工作並具備數項專門知識的畢業 生,滿足實際工作需要。以技能為本的測量學(榮譽)理學 士課程中將工作融入學習,著重如何解決現實專業問題。我 們的工作室項目及畢業項目針對解決測量業界提出的問題。」

何志榮亦提及,香港高等教育科技學院的課程將注入新元 素,以應對業界需求。「課程包括測量專業的先進技術應用, 如建築信息模型,提供實用的專業教育,給學生及僱主多一 個選擇, 並獲他們認可及青睞。」

#### 展望未來

以上五位測量師都認為,雖然就測量系學生和導師的水平而 言,香港較英國及澳洲高,但仍有進步空間。舉例而言,港 大的鄒廣榮教授認為,香港需要進行更多測量學研究,協助 縮小研究與實踐的差距,並鼓勵本地測量系畢業生攻讀博士 學位。

香港高等教育科技學院的何志榮教授認為本地測量訓練相對 保守,而本地學生亦未充分把握全球新興經濟體的各種機 遇。他擔心大學紛紛透過卓越的研究成果爭取國際排名,因 而與專業需求產生差距。

何志榮教授説:「雖然研究很重要,但就專業學位而言,有 業界經驗的教師需要教授畢業生實用的專業知識。我們要改 變文化,緊貼專業領域,以縮小差距。歐洲有備受推崇的科 技或應用科學大學,他們提供頂尖的專業訓練及應用研究。」

理大的蔣日雄教授強調加強自動化的重要性。「香港的自動 化技術已落後於中國內地。本港建築成本高,測量師應發展 自動化技術,致力化危為機。」

#### Think globally and maintain competitive advantage

The government has just started the public consultation of "Hong Kong 2030+: Towards a Planning Vision and Strategy Transcending 2030" and your views are important. Hong Kong has overcome many challenges to transform itself from an entrepot after the Second World War to a world class city and a leading global financial centre. To think globally is important to maintain the competitive advantage of Hong Kong.

Throughout 2016, the HKIS has achieved significant milestones in cementing its global standing and exerting influence in Asia-Pacific and the Greater China region through exchange, partnership and active participation.

### Contributing to international and regional professional organisations and best practices

Many of our members have been spending considerable amount of time in driving the activities of various international and regional professional organisations.

Past President Sr T T Cheung has been officially appointed as the 2016-2018 Chairman of the International Cost Engineering Council (ICEC) in the 10<sup>th</sup> ICEC World Congress 2016 in Rio, Brazil in mid-October, ICEC is a worldwide confederation

of cost engineering, quantity surveying and project management societies with member societies in more than 40 countries. Chairman of General Practice Division (GPD) Sr K K Chiu has taken up the membership of the Nomination Committee of the International Valuation Standards Council (IVSC) recently and he has been a member of its Advisory Forum Working Group for many years. IVSC is the global valuation standards setter for the valuation profession.

We have on-going dialogues with the Royal Institution of Chartered Surveyors (RICS). Two Presidents of RICS, Mr Martin Brühl (2015/2016) and Ms Amanda Clack (2016/2017) met with us this year respectively to continue our dialogue on mutual recognition arrangements and professional standards.

Playing a proactive role in setting international standards, the HKIS has joined the International Construction Measurement Standards Coalition (ICMSC) and among others, while actively exploring the International Land Measurement Standards (ILMS) and the International Ethics Standard (IES).

On the regional front, the HKIS is proud to maintain a strong presence in Asia Pacific as our delegates shared insights at the 20<sup>th</sup> Pacific Association of Quantity Surveyors Congress 2016 in Christchurch, New Zealand.

#### **Building closer ties with the Mainland**

With the blessings of the Mainland and Hong Kong Closer Economic Partnership Arrangement (CEPA) as well as the Belt and Road initiative, the HKIS continues to strengthen its ties with the Mainland. Among them, the Land Surveying Division (LSD) will take part in the Guangdong-Hong Kong-Macau Surveyors Meeting in Mei-chau (梅州), Guangdong in November, the same month when LSD and its China counterparts showcase their technological advancement at the 8<sup>th</sup> Cross-Strait Geomatics Conference in Xiamen, Fujian. The GPD stepped up its China engagement as its working group led by Vice Chairman (External Affairs) Sr Alex Lam has communicated with representatives of the China Institute of Real Estate Appraisers and Agents (CIREA), China Real Estate Valuers and

Agents Association (CREVA), and China Appraisal Society (CAS) on reciprocity arrangements and a discussion forum for GPD members in November has been arranged to discuss the same. Further to the reciprocity agreement, the Quantity Surveying Division followed up with the China Engineering Cost Association (CECA) with regard to the application arrangements for PRC-Registered Cost Engineers qualification.

To help steering partnerships under CEPA, the Institute has sent several delegations to Mainland cities. Our delegation to Beijing and Shanghai received high-level reception from the Central Government. We have recently sent an invitation to the Development Bureau for their representatives to join us in next year's CEPA visit.

#### Focusing on active participation

With these exchanges, visits and partnerships, HKIS continues to build a wide range of collaborations globally, regionally and in Greater China to aim at making a profound impact. Rather than waiting passively to be advised, we play key roles in global professional bodies and the setting up of international standards. With the enduring efforts of the HKIS and our fellow members, we continue to consolidate our global leading position in surveying to facilitate best international practice.

綜觀 2016 年,學會透過交流合作、積極參與業界活動等舉措,成功提升學會的國際地位,以及增加在亞太及大中華地區影響力。

#### 為國際和地區專業組織及最佳作業準則作貢獻

本會眾多會員為推動國際性和地區性專業組織的活動投入不少寶貴時間。

前會長張達棠測量師於十月在巴西里約舉行的第十屆國際造價工程聯合會世界大會上正式獲委任為該會 2016 至 2018 年

度主席。國際造價工程聯合會是一個世界性的造價管理、工料測量及工程策劃組織聯合會,會員組織來自超過 40 個國家。另一方面,產業測量組主席趙錦權測量師最近亦成為國際評價準則委員會的提名委員會成員,他已擔任諮詢論壇工作小組委員多年。國際評價準則委員會為評價專業制訂國際評價準則。

我們與皇家特許測量師學會保持緊密溝通。該會兩位會長, Martin Brühl 先生 (2015/2016 年度 ) 和 Amanda Clack 女士 (2016/2017 年度 ) 分別在本年與本會會面,繼續商討資格互 認安排及專業準則。

學會積極參與制訂國際標準,包括加入國際建造量度標準聯盟等組織,亦積極研究國際土地測量標準 (International Land Measurement Standards, ILMS) 和國際操守準則 (International Ethics Standard, IES)。

在亞太地區工作方面,學會此前率領代表團遠赴紐西蘭基督城,出席第20屆2016年度亞太區工料測量師協會國際會議,在會上分享見解及經驗,進一步鞏固本會在亞太地區的地位。

#### 與內地拉近聯繫

藉著「內地與香港更緊密經貿關係安排」(CEPA)及「一帶一路」的倡議,學會多個組別持續加強與內地的連繫。土地測量組將參加11月於廣東省梅州市舉辦的粤港澳土地測量師學術交流會。同月,土地測量組和中國的相關單位亦將於福建省廈門市第八屆海峽兩岸測繪發展研討會中展示技術發展成果。另一方面,由產業測量組副主席(對外事務)林增榮測量師帶領的工作小組,與中國房地產估價師與房地產經紀人學會、中國土地估價師與土地登記代理人協會及中國資產評估協會的代表,就探討互認安排作出交流。產業測量組亦於11月舉辦論壇予產業測量組會員作相關討論。此外,工料測量組根據互認協議,與中國建設工程造價管理協會跟進申請中華人民共和國註冊造價工程師資格的安排。

在 CEPA 框架下,為推動夥伴合作關係,本會年內有多個代表團到訪內地多個城市。其中北京及上海的代表團獲中央政府高規格的接待。本會最近已邀請發展局派代表一同參加明年的 CEPA 交流訪問活動。

#### 積極參與

透過與不同的組織交流、訪問及合作,學會致力建立全球性、 區域性及在國內的廣泛合作,務求發揮深遠影響。我們不坐 待業界表示意見,而是主動在全球專業團體中作出貢獻,在 制訂國際標準的工作上發揮關鍵作用。有賴學會及眾多會員 不懈努力,我們會繼續鞏固本港在測量業的國際先驅地位, 推動國際標準。

## Mentors moulding minds

With its perils and pitfalls, youth can be a turbulent, troubling period for anyone. That's why two quantity surveyors are volunteering some of their own free time to give youngsters a helping hand in blossoming into mature and responsible young adults.

In a busy city like Hong Kong, many people are too preoccupied with their own lives to think of sparing time for others. Yet many youngsters are urgently in need of life mentors to give them advice and guidance in their formative years. Sr Joe Wu and

Sr Oky Chan, both of whom have long been active in volunteer work, took up this role with two youngsters as part of "Growing Partners II - Child Development Fund (Batch 4)", an initiative organised by The Boys' & Girls' Clubs Association of Hong Kong (BGCA).

Wu, the co-founder of QnS Consultancy, is a seasoned volunteer who particularly enjoys working with youngsters. "It's mutually beneficial for the mentors and mentees," he says. "Through interaction with innocent kids, we have learned how to leave behind our stress and anxiety. I feel a surge of positive energy after meeting the kids."

Wu is also involved in Project SPARKLE, a mentorship programme for children from grassroots households in Tin Shui Wai organised by HKIS. In 2014, he joined the BGCA's "Growing Partners II – Child Development Fund (Batch 4)" Programme at HKIS's recommendation. "A mentor is paired up with a mentee for a mentorship period of three years," he explains. "Initially, I was unsure about the commitment. But it turned out that it does not take up too much time."

For Chan, a desire for a mentor and role model during her adolescence motivated her to volunteer to help youngsters now. "I lacked a mentor or role model in my teenage years, and mainly talked to friends or overcame difficulties by myself when I encountered problems," she says. "I have a passion for helping young people. I think I can share my experiences with them on the things I have done correctly and mistakes I made." Like Wu, Chan, who works for a local developer, also participates in Project SPARKLE.

Wu and Chan have had a similar experience in mentoring young people. Their involvement began with providing advice and guidance to young graduates who were taking their surveyor qualifying examinations, and then evolved into mentoring youngsters, many of whom were from disadvantaged households.

BGCA's "Growing Partners II – Child Development Fund (Batch 4)" was launched in 2014. Its goals are to help participating children – many from underprivileged households – build a positive self-image. This is done by helping them discover their skills and abilities; giving them more life experiences; building up their social and support networks; setting personal goals; and imparting advice on personal finance and saving habits.

To optimise the positive impact, BGCA matches individual mentors with mentees based on their personality traits and interests, says Wong Waiyin, a project officer for Kwun Tong District. "The mentors are like role models and life companions for the youngsters," she adds.

Wu says that it took a while for his mentee, 16-year old Heung Hang-tai, to warm to him nearly three years ago. "Hang-tai is reticent in the company of strangers," he says. "But after we had built up trust with each other, he opened up. He sometimes asks me for advice on various things. He's like a friend or younger brother to me." Wu adds that he and Hang-tai, a Secondary Three student at Po Chiu Catholic Secondary School in Yau Tong, share a passion for building models and robots.

The two mentors derive satisfaction from having seen their mentees grow over the years. "Hangtai and I meet approximately once a month," Wu says. "We also join gatherings with other mentors and their mentees, and go to places such as country parks and boat trips as a group. As Hang-tai has matured, I find it easier to get along with him. His mother and younger sister say they have observed positive changes in him. He is now more outgoing and talkative. He takes the

initiative in telling me the extracurricular activities he enjoys at school. My aspiration for him is that he continues to be optimistic and outgoing."

Hang-tai has fond memories of a squid fishing trip in Sai Kung, and how Wu helped him catch one. He admires Wu's enthusiasm for helping others. "Joe has inspired me to respect others. I sometimes ask his advice about my family. He will guide me in analysing issues that I struggle with. I have also started to set aside part of my allowance as savings."

Wu has also inspired Hang-tai with his choice of future career. "My aspiration is to enter the architecture or construction profession after graduation," he says.

Shek Hiu-tong, a first-year nursing student at the Caritas Institute of Higher Education, has been Chan's mentee for almost three years. Chan says mentors and mentees are expected to set the goals they want to achieve together, based on the mentees' needs and the mentors' capabilities. "The organisers put a lot of effort into holding a diverse range of activities," she says. "There is a high degree of flexibility. Briefings are arranged beforehand so that mentors can be more effective in giving guidance."

Hiu-tong, she adds, has grown up to become a mature and analytical individual. "At the beginning, I volunteered some advice. As our relationship deepened, she grew more mature. My approach changes after observing Hiu-tong's character traits and needs. I now mainly share my experience as I do not want to make her feel as if I'm lecturing her. I hope to help her develop a sound mind so that she can independently tackle problems in the future. I also hope that when she needs help from someone, she knows I will be there for her."

Hiu-tong says she appreciates the warmth that infuses her friendship with Chan. They sometimes have meals together and go hiking. "Although we do not meet very frequently, we stay in touch constantly via WhatsApp," Hiu-tong says. "I received lots of encouragement from Oky when I was taking the Diploma for Secondary Education exams. Our interaction is like that of friends. For me, it's relaxing. Oky is knowledgeable about many things and willing to share her perspectives. I am less self-centred now, and have become more confident when interacting with people."

Wong of BGCA says it is not an easy job to commit to the mentorship, as each period lasts three years. "The mentors keep the mentees company during the latter's growth. It has a negative effect on some mentees if their mentors do not show up for a long period of time. When the mentors face any challenges or there are changes in a mentor's circumstances, we encourage them to let us know so that we can support and assist them because we care about the development and the living conditions, of both mentees and mentors." she says.

"We are heartened by the feedback from the mentors, mentees and parents, who all say that the three-year life companionship is a fulfilling and mutually beneficial experience."

Chan thinks those who are interested in being mentors should take a deep look at themselves to see if they can really make a difference before making any commitment. "Because they should be positive role models for the youngsters, potential mentors first require some self-assessment to see whether they are suitable," she

says. "Then they need to look at the commitment and whether they are

able to observe the needs of the mentees and devote their time in it. It's also better that they have some working experience so that they have more to share."

青少年愛冒險,容易犯錯,他們可能會在 青春時期經歷重重困擾。因此,兩位工料 測量師自願奉獻私人時間,幫助年輕一代 成為逐漸成熟和敢於承擔的成年人。

在香港這個繁囂都市,許多人都為自己的生活忙得不可開交,無暇顧及他人;然而不少年青人在成長時期急需生活導師提供意見和指引。胡錦輝測量師及陳慧凌測量師一向積極參與義務工作,他們擔當藍朋(友師)的角色,與兩位青友(青少年)參加香港小童群益會舉辦的第四批「結伴再成長॥一兒童發展基金計劃」。

胡錦輝為科量顧問有限公司的共同創辦人,義工經驗豐富, 尤其喜愛接觸年輕人的工作。他說:「藍朋及青友的生命在 互相燃點和互相感染。與單純的青友相處,讓我們學會拋開 壓力及焦慮,每次與他們接觸後,我也會得到正能量。」

胡錦輝亦參與香港測量師學會舉辦的一項師友計劃一「擦亮童心」夥伴同行計劃,對象為天水圍基層家庭的小朋友。 2014年,他經學會推薦參加香港小童群益會第四批「結伴再成長॥一兒童發展基金計劃」。他表示:「一位藍朋與一位青友配對,進行為期三年的師友計劃。起初我不確定能否全心投入,但原來擔任藍朋不必花太多時間。」

陳慧凌在少年時期渴望有個啟蒙導師,因此她對幫助青少年 義不容辭。她說:「我在青少年時期沒有啟蒙導師,遇到問 題時都是向朋友傾訴或自行解決。我樂於幫助年青人,我想 我可與他們分享過往的種種對錯。」在本港地產發展商工作 的陳慧凌,亦加入「擦亮童心」夥伴同行計劃。

胡錦輝和陳慧凌在輔導年青人方面有相似的經驗,他們一開始都是為參加測量師專業考試的年輕畢業生提供意見及指導,繼而輔導其他青少年,當中有許多來自弱勢家庭。

香港小童群益會於 2014 年推行第四批「結伴再成長 II 一兒童發展基金計劃」,旨在協助參加計劃的兒童(很多來自弱勢家庭)建立正面的自我形象。內容包括協助他們發掘個人技能及能力、豐富他們的生活體驗、建立社交及支援網絡、訂立個人目標,以及提供個人財務及儲蓄習慣的建議。

觀塘區計劃主任黃慧妍姑娘指,香港小童群益會在配對藍朋和青友時,會考慮雙方的性格及興趣,以發揮最佳的師友同行效果。她亦表示:「藍朋的角色就像青友的榜樣和生活上的同伴。」

胡錦輝表示,約三年前,他花了好些時間才讓 16 歲的青友香亨泰放下戒心。他説:「亨泰面對陌生人時沉默寡言,但我們建立互信後,他終於敞開心扉。他有時會在各種事情上詢問我的意見,他就像我的朋友或弟弟一樣。」亨泰就讀油塘天主教普照中學三年級,胡錦輝補充説,他們都對建築模型及機械人感興趣。

兩位藍朋眼見青友多年來隨年漸長,都很有滿足感。胡錦輝 説:「我和亨泰大概每個月見面一次,我們亦與其他藍朋和 青友聚會,一起去郊野公園或乘船遊覽。我發現亨泰成熟後 較易相處,他的母親和妹妹亦察覺到他有良好的改變。現在 的他外向健談,會主動告訴我他喜歡的課外活動。我希望他 能繼續保持樂觀開朗。」

西貢釣墨魚之旅為亨泰留下美好回憶, 他記得當時胡錦輝如何幫他釣到一隻墨魚。他欣賞胡錦輝熱心助人,他表示:「胡錦輝讓我學會尊重他人,有時我會問他關於與家人相處的意見,他會引導我分析難題。我亦開始培養儲蓄的習慣。」

亨泰在就業路向方面亦受胡錦輝啟發。他謂:「我希望畢業 後能投身建築業或建造業。」

明愛專上學院護理學一年級學生石曉彤,已成為陳慧凌的青 友近三年。陳慧凌表示,雙方會根據青友的需要及藍朋的能 力,訂立共同達成的目標。她說:「計劃同事會事先安排簡 介會,讓藍朋在指導時獲得更大成效;亦會盡心盡力舉辦各 種活動,這做法彈性很大。」

她亦表示,曉彤已成為一個成熟、善於分析的青年。「起初 我會提出意見,但隨著我們的關係變得密切,她思想越趨成 熟。在觀察曉彤的性格特質及需要後,我改變了相處方式。 其後,我大多與她分享個人經驗,因為我不想令她覺得我在

曉彤説,她很珍惜與陳慧凌那份温暖的友誼,她們有時會一 起吃飯、遠足。曉彤説:「雖然我們不常見面,但我們常透 過 WhatsApp 保持聯絡。我應付香港中學文憑考試時,陳慧凌 給我很多鼓勵。我們之間的相處就像朋友,我覺得很自在。 陳慧凌學識豐富,並樂意分享她的看法。現在我不再那麼自 我,與人相處亦更有自信。」

香港小童群益會計劃主任黃慧妍姑娘表示,師友計劃為期三 年,能夠堅持擔當三年的藍朋實在不容易。她指:「若果藍 朋少接觸青友,有些青友會誤以為藍朋不喜歡自己,這會對 某些青友造成負面影響。假如藍朋遇上任何困難或生活狀況 上有轉變,我們鼓勵他們讓我們知道,因為我們同時關心青 友和藍朋的發展和生活狀態,希望為藍朋提供適切的支持和 支援。」

「我很開心聽到一些藍朋、青友及青友的家長分享他們經歷 了一個充實和有意義的三年。,

陳慧凌認為,有意擔任藍朋的人在作出決定之前,應檢視自 己是否有能力。「因為藍朋是青年的榜樣,要成為藍朋,首 先應自我評估,看自己是否勝任,有沒有洞察力可注意到青 友的需要,然後要確認自己能否投入時間,一旦加入計劃, 就應履行責任完成。為增強人生閱歷,藍朋宜有一定的工作 經驗。」她說。

## Promotion of the Surveying Profession to the Younger Generation

In order to enhance the understanding of the surveying profession among young people, the HKIS collaborated with the Education Bureau Business-School Partnership Programme and organised a thematic talk by the BSD and a large-scale career talk on 14 and 19 October, respectively, at the Surveyors Learning Centre.

#### **BSD Thematic Talk**

The talk titled, 《樓宇解密:全方位樓宇醫生》, was held on 14 October and attracted around 30 secondary school students. Please refer to the report by the BSD chairman for more details.

#### Large-scale Career Talk

The career talk with the theme of 《把握未來大方 向探視專業測量前景》 was well-received by 110 senior secondary school students and teachers from 15 secondary schools. The speakers from the six divisions and YSG included Sr Thomas Ho, Sr Tang Chi Wang, Sr Edward Au, Sr Lam Lit-yin, Sr Dr Ken Hui, Sr Prof James Pong, Sr Gary Yeung, and Sr Refeal Leung. They introduced the different aspects of surveying such as its development, the opportunities for surveyors in Hong Kong, the jobs and responsibilities of surveyors, the route to HKIS membership, requirements for becoming a surveyor, and career prospects. The students showed an interest in surveying and actively participated during the Q&A session afterwards.



## The HKIS Outstanding Dissertation/ Thesis Awards 2015 Executive Summary of Winning Papers

## LEVEL OF CITIZEN PARTICIPATION IN URBAN RENEWAL IN HONG KONG

Undergraduates Category – Top Award (PDD) Awardee: Wong Ka Chun The University of Hong Kong

In recent years, although the Urban Renewal Authority has started to increase community engagement in its urban renewal projects, is the participation pseudo or genuine? What was the level of participation of local residents? In this study, I intend to answer these questions.

This study examines the current situation of resident participation in the urban renewal process in four districts in Hong Kong through a structured survey and by looking into the relationship between various socio-economic factors and participation levels through the regression of survey data.

The results showed that the most recent actual participation level was rather passive and 80% of the respondents agreed with the insufficiency of participation in the urban renewal process. Wan Chai residents were the most active in their participation followed by residents in Kwun Tong, Sai Wan, and Sham Shui Po.

The regression analysis revealed that the two most significant factors that affected the participation level of a neighbourhood's residents were ITS (intention to stay) and INC (monthly household income). Wan Chai respondents have the highest actual and expected participation level. Wan Chai residents are affluent and more educated. According to the multiple regression analysis, higher income groups and more educated people tend to have higher actual and expected participation level. Also, there have been many urban renewal projects (for example, the Lee Tung Street Project) in this part of Hong Kong. Such favorable individual and situational factors had a multiplying effect on the participation level of Wan Chai's residents.

On the contrary, there have been fewer redevelopment projects in Sham Shui Po, where residents tended to be poorer and less educated and, hence, less interested in participation. The multiplying effect of low income and education level, as well as a lack of urban renewal projects, made Sham Shui Po's participation level the lowest.

Based on the results and discussion, the existing participation level is not adequate. Some recommendations, such as improving the distribution of information, a more proactive approach to urban planning, and community education, may increase participation in less proactive areas.

As a famous maxim goes, two heads are better than one. With more of its residents participating, an older urban area can become a better place for them to reside.

#### THE EFFECTIVENESS OF THE SAFE WORKING CYCLE IN IMPROVING THE SAFETY CULTURE IN HONG KONG'S CONSTRUCTION INDUSTRY

Undergraduates Category – Top Award (QS)
Awardee: LEUNG Kin Yeung
The University of Hong Kong

Construction safety is a contentious issue in occupational health and safety, as the accident rate for Hong Kong's construction industry is still high compared to that for other developed societies. Building scholars have suggested safety culture and climate as the critical factors for consideration in safety management when they warned stakeholders of the risks that could result in accidents.

Safety culture is described as a summation of individual and group values and attitudes that determine the style of an organiation's health and safety management. Within the dimensions covered, there are six major elements: (1) safety rule adhesiveness; (2) communication between management and operatives; (3) a reporting culture; (4) safety training and inspection; (5) risk awareness and planning; and (6) a just and caring culture.

The Safe Working Cycle (hereafter the Cycle) was introduced to Hong Kong in 2005. It incorporates safety concepts into daily, weekly, and monthly work routines. The theoretical basic components include: (1) safety morning talks & exercises; (2) hazard identification activities; (3) pre-work checks; (4) safety inspections; (5) safety management meetings; and (6) housekeeping.

This study aims to find out the Cycle's effectiveness in improving the Hong Kong construction industry's safety culture. It wants to determine the extent of the improvements in the six elements of the safety culture through the Cycle's major constituents.

What is known so far is that the Cycle is capable of improving safety culture. Significant improvements have been noted in safety rule adhesiveness, safety training, and inspections, as well as in risk awareness and planning due to repeated occurrences of safety-related issues and the obligatory nature of the Cycle. Partial improvements have been made in communications between management and operatives, as more chances have been made available for both parties to meet and express their ideas. However, communications remain top-down in general. Furthermore, the Cycle has been negligible in creating the reporting and just and caring cultures, as these two atmospheres mainly depend on a company's organisation. The Cycle does not include significant elements to address these two factors.

Another observation was that both managerial and frontline workers shared a somewhat similar impression of the Cycle – except for in those areas that were related to their jobs. For instance, frontline workers gave more positive feedback on the improvements in safety rule adhesiveness, while managers gave a higher weighting to improvements in communication.

For stakeholders to better comprehend the Cycle, technological and systematic advancements could help. For instance, the use of Building Information Modelling and communication apps on smartphones provide extra channels for risk planning and communication. Moreover, the early involvement of workers and the incentive scheme can help mitigate the problems in top-down communication. Since the Cycle is preliminarily designed for construction sites, its power could be extended through derivatives for addition and alteration (A&A) works – so as to suit its quick and budget-oriented nature.

In summary, the Safe Working Cycle is generally effective for improving the Hong Kong construction industry's safety culture. But solely relying on it to change the industry is infeasible. However, by combining it with other safety initiatives, they can synergise and improve Hong Kong's safety culture even more.

#### IVSC 2016 AGM

The International Valuation Standards Council (IVSC) 2016 Annual General Meeting was held in Bali, Indonesia from 10-12 October. President Sr C K Lau and GPD Chairman Sr K K Chiu attended the meeting on behalf of the HKIS.

Sir David Tweedie, Chairman of the IVSC Board of Trustees, addressed the IVSC's strategic vision, which emphasises:

- 1. the need for the IVSC to cooperate with other key stakeholders to serve its profession; and
- 2. demonstrating the IVSC's commitment to the public interest by expanding the use

of international valuation standards (IVSs) as a primary core set of standards used for tangible asset, business, and financial instrument valuation.


The IVSC aims to finalise the IVS 2017 soon after the AGM. The HKIS Valuation Standards Panel will follow the publication to review its own standards.

In accordance with the agreed-upon IVSC Strategy, the Standards Board will be reconstituted as a Standards Review Board with two sub-boards:

- the Tangible Assets Standards Board covering real estate, plant and machinery, and personal property; and
- the Business and Intangible Asset Standards Board.

Formation of the new Boards was confirmed at the IVSC's AGM. See the Organisation Chart below.

With the support of the Asia-Pacific Business Advisory Council (ABAC), work continues on the initiative to reinforce valuation architecture across the 21 APEC economies. This initiative is focused on the need for common valuation standards (IVS) across the region and the importance of a robust valuation profession to deliver those standards. The IVSC Task Force was set up and is led by Trustee Nicholas Brooke for input and advice on specialist valuation topics.

The next IVSC AGM will be held in Mexico in October 2017.





#### WAVO Board Meeting and the 8<sup>th</sup> WAVO Congress

The WAVO Board Meeting and the 8th WAVO Congress will be held from 1-4 November 2016 in Daegu, South Korea. GPD Council member Sr Edward Au will represent the HKIS there.

The theme this year is "Enhancing the Quality and Efficiency in Valuation". Quality and efficiency in valuation have become vital elements for stable taxation and the real estate market. Thus, more professional, legitimate, and accurate valuation is required for continuous professional development in the field. The Congress will discuss the methods for improving the credibility of valuation and enhancing the valuation profession.

#### HKIS Guidance Notes on the Valuation of Development Land

After the public consultation and final revision made by the Land Policy Panel, the Guidance Notes on the Valuation of Development Land were endorsed by the General Committee during its 22 September meeting. The Guidance Notes are subject to ratification at the HKIS's forthcoming General Meeting.

#### **HKIS Career Talk**

The HKIS Career Talk 《把握未來大方向 探視專業 測量前景》was held on 19 October. The talk was well-received by 110 secondary school students and teachers from 15 schools. GPD Council member Sr Edward Au delivered a presentation to the students to introduce the surveying profession from the general practice perspective.

#### LSD Annual Dinner



"Joint Force of Land Surveyors" was the theme of this year's Annual Dinner. Mr Eric Ma Shiu-cheung, JP, the Under Secretary for Development, led a toast with our President, Sr Lau Chun-kong; the HKIS General Council; and the LSD Council for our members in the Junior Ballroom I, Level 3, Royal Plaza Hotel. I could only thank him for his wholehearted concerns over our activities, particularly for his personal approval of the formation of and participation in the Land Boundary Committee. I also appreciate his extra patient work in handling the LSD's reservations over the professional qualifications of resident land surveyors in the industry.

#### PDD Annual Conference 2016

On 20 October, just two days before our scheduled Annual Conference, there was a warning from the Hong Kong Observatory that super strong Typhoon Haima would hit Hong Kong. On the early morning of 21 October, Typhoon Signal No.8 was issued and some PDD Council Members thought that the Annual Conference might need to be postponed. Thank God that Haima missed Hong Kong by some 100 km and left its vicinity very quickly by the late afternoon of 21 October, after which the No.8 signal was replaced by No.3 in the evening.

Although the morning of 22 October was cloudy with patches of rain, the PDD Annual Conference 2016 proceeded as scheduled in the presence of its distinguished guest speakers including the Secretary for Development, the Hon Paul Chan, and the Director of Planning, Mr K K Ling, at the Surveyors Learning Centre. This would not have happened without the support of over 100 participants and media friends.

During his half-hour Keynote Speech with a PowerPoint presentation, the Secretary for Development first reviewed the "Hong Kong 2030: Planning Vision and Strategy" before briefing the congregation on the new "Hong Kong 2030+: towards a Planning Vision and Strategy Transcending 2030". He emphasised that with the implementation of many infrastructure projects in the form of roads, bridges, and high-speed rail to link Hong Kong to its neighbours, the journey between Hong Kong and the rest of Asia, including Ho Chi Minh City in Vietnam, should take no more than five hours by car in the near future.

The Secretary for Development also appealed to the audience to redress the various salient

planning issues that could impact Hong Kong in the years ahead, including its growing, but ageing, population, increasing building stock, a shrinking labour force, pressing demand for developable land, imbalance in home-job spatial distribution, and the ever-challenging climate change.

The Keynote Speech was followed by presentations by other distinguished speakers: the Director of Planning, Mr K K Ling; Past President and immediate past Legislative Councillor for the Architectural, Surveying and Planning Sector, Sr Tony Tse; Director of C K Lau & Associates and Ex-Property Director of Henderson Land Properties, Ltd, Sr C K Lau; the President of the Hong Kong Institution of Engineers, Ir Joseph K H Choi; and Vice President of the Hong Kong Institute of Urban Design, Mr Charles Lee. They were well-received by the audience and I offer my heartfelt thanks to them for their valuable contributions and support. The conference was very successful and satisfactorily concluded at almost five o'clock in the afternoon.

This was the first time that the PDD ran a whole-day annual conference and I look forward to running it again next year in a bigger venue such as a hotel. Last, but not least, I sincerely thank all members of the Annual Conference Organising Committee and my PDD Council Members for their valuable contributions, without which the Annual Conference 2016 would not have been successful.

經過多年與政府商討,物業管理條例終於在本年 5 月 26 日三讀通過,這條例主要分為三部份,第一是成立物業管理業監管局來制定守則和懲罰機制;第二是物業管理公司發牌制度;第三是物業管理人發牌制度,這是分為第 1 級及第 2 級的牌照。條例的通過有助確保物業管理公司聘請之從業員擁有專業資格,從而提高物業管理行業的專業性。

## International Cost Engineering Council's 10<sup>th</sup> World Congress in Rio de Janeiro, Brazil



## Adjudication? from the Perspective of Hong Kong's Contractors

#### Introduction

Mr James Bowling, a barrister from 4 Pump Court, London, delivered a seminar, "Has the time come for mandatory adjudication in Hong Kong?" to members of the Society of Construction Law Hong Kong in June 2013. Afterwards, I attended a few seminars that discussed adjudication in Hong Kong followed by taking an adjudication course organised by the HKIA/HKIS from April-May 2016. All these events give me insights into adjudication in Hong Kong, especially from the perspective of contractors, since they could be one of the parties that will frequently use this means of alternative dispute resolution (ADR) in the future.

Before writing this article, I used questionnaire and telephone interviews to collect first-hand opinions from 16 professional and senior management practitioners (with an average of 23 years of work experience) working for 11 local major contractors (including main and sub-contractors) to answer the following five questions:

- 1. Have you heard of adjudication?
- 2. Have you encountered any dispute that required ADR to resolve?
- 3. In case a dispute arose, which parties were involved?
- 4. Which ADR(s) did you use to resolve the dispute(s)?
- 5. If adjudication were to be launched in Hong Kong, would you try to use it?

The results are below.

## **Contractors' Views on Adjudication**

#### 1. Have you heard of adjudication?

Most/nearly all respondents had heard of adjudication. Only one out of the 16 (6.3%), a QS with over ten years of experience, had not heard about it. This revealed that the majority of Hong Kong's major contractors were aware of the existence of adjudication as an ADR.

#### 2. Have you encountered any dispute that required ADR to resolve?

Among the 16 returned questionnaires, only eight (50%) experienced disputes that could not be resolved through negotiation, thereby requiring ADR to resolve, whilst the other eight (50%) did not have any dispute that required ADR. This was mainly due to the strategy employed by each contractor in reaction to the dispute it faced. Among the eight that had no dispute, they mentioned that their companies tried their utmost to resolve any dispute through internal negotiations, commercial settlements, etc, but never escalated to adopting ADR or litigation. This seemed a good sign for resolving disputes.

#### 3. In case a dispute arose, which parties were involved?

Disputes mainly arose between: 1) main contractors and their clients/consultants and 2) main contractors and sub-contractors. This was expected, as the contracting parties tended to be the main contractor and the client/consultant or the main and sub-contractors. In this way, adjudication may be a suitable ADR for disputes in the future, since it is suitable for all contracting party tiers, including clients, consultants, main contractors, and sub-contractors.

#### 4. What ADR(s) did you use to resolve the dispute(s)?

Among the eight replies that required ADR, one was resolved through commercial settlement. This is strongly recommended, since it is prompt, less costly than other common means of resolving disputes like mediation, arbitration, etc., and the best for maintaining a good relationship between the parties. Among the other seven, three were resolved through

mediation (43%) and four through arbitration (57%). These results were as expected, as most contractual conditions nowadays stipulate mediation as a first-tier ADR, although it may not be mandatory, while arbitration is usually a second-tier ADR. Thus, if contracting parties have disputes that require ADR to fix, their most common options are currently mediation and arbitration.

## 5. If adjudication were to be launched in Hong Kong, would you try to use it?

Among the 16 replies, one respondent said that depended on the extent of the dispute and the cost and time required for adjudication. From what I understand about adjudication, it is suitable for all payment disputes. Hence, no matter how big a dispute is, it is suitable for adjudication. Furthermore, its cost is nominal and the results are prompt, since it has a fixed time frame (i.e., a maximum of 55 working days to resolve the dispute). Hence, adjudication costs less and is faster than arbitration.

Two respondents hesitated to use adjudication. One claimed to have never encountered a dispute, while the other said that adjudication was "expensive and time-consuming". In my opinion, adjudication, when compared to mediation, may be a bit more expensive, but it is final and binding (only subject to minimal review through arbitration). While the time to reach a decision under adjudication (up to 55 working days) may be a bit longer than under mediation (which may take up to seven days), adjudication costs less in both money and time, even though it comes with the same binding decision and final award. Hence, the latter respondent might not have fully understood what adjudication involves. If she did, she might have changed her stance.

Thirteen out of the 16 (about 81%) respondents firmly supported adopting adjudication as an ADR because it usually ensures:

- (a) Faster/quicker cash flow
- (b) Prompt/immediate action
- (c) More concise decisions by an adjudicator

- (d) Preventing the disadvantage of like arbitration that could only start after the completion of a project
- (e) Low cost
- (f) The resolution of a dispute while it is still fresh
- (g) Simplicity
- (h) That both the client and consultant would not procrastinate in resolving the dispute(s)

One respondent raised the point that it was difficult for him to adopt adjudication because today's contracts do not state that adjudication is an option. Instead, mediation/arbitration are still the most commonly-stated choices for resolving disputes. This is a good point. As far as I know, when adjudication becomes mandatory under the relevant ordinance, the relevant contract provisions will very likely be amended accordingly to include it.

#### **Conclusions**

The above analysis noted that disputes exist at all tiers, as expected and revealed from the 11 local leading contractors. Furthermore, it found that local contractors (including main and subcontractors) were fully aware of the existence of adjudication, even though they might not have kept fully abreast of its mechanism and advantages when compared to other means of ADR. Most of the contractors experienced disputes at work and some used internal negotiations to resolve them, while the remainder employed mediation or arbitration. All of the respondents, when choosing ADRs, considered both the time consumed and costs encountered. They agreed that if there were another ADR apart from mediation and arbitration that could be simple, fast, less costly, final, and binding, they would definitely consider it. Adjudication could be that possible alternative.

Most of the respondents (13 out of 16, or around 81%) would consider using adjudication in the future, while taking into consideration my explanation of the advantages to it. Is this a good sign that Hong Kong's local leading contractors and sub-contractors are ready for the coming of adjudication? I can only hope so.
