HKIS Land Surveying Division gets a Professional Services Advancement Support Scheme (PASS) funding, HKSAR

Third time lucky for Land Surveying Division as it lands PASS funding, which it intends to put to use in a number of projects under the Belt and Road Initiative. But challenges remain.

In the past we could only afford to make presentations at international congresses, which was not all-rounded and couldn't focus on the target audience. Now we can push the boundary further to Belt and Road countries, stressing modern technologies and applications.

When the Government rolled out the HK\$200 million Professional Services Advancement Support Scheme (PASS) to provide funding support for non-profit-making industry-led projects in 2016, the HKIS's Land Surveying Division (LSD) spared no effort in the first and second round of applications, though it was ultimately unsuccessful. The team didn't give up and further refined the proposals with advice from HKIS President Sr Dick Kwok. This third application had better luck and clinched funding of HK\$1,739,000 early this year.

PASS aims at increasing the exchanges and cooperation of Hong Kong's professional services with their counterparts in external markets. Under the leadership of Chairman Sr Dr Conrad Tang, the LSD proposed a 24-month project with a theme to promote land surveying technological services in the aforementioned areas from 1 April 2018 onward. Proposed deliverables include four exhibitions on land surveying (LS) services in mainland China, Pakistan, Kazakhstan and Sri Lanka, with visits to relevant organisations in these countries; four translations and summaries of LS laws and regulations in the four areas; a conference in Hong Kong on land surveying technology in September 2019, followed by three workshops on technology transfer and surveying industry information in 2020 within Hong Kong. The LSD is also required to submit to the Government an interim audit report in March 2019 and a final audit in June 2020.

An expert in the cadastral system, Sr Dr Conrad Tang has formed a talented team by pulling in the Hong Kong Polytechnic University's Dr Charles Wong Man Sing, whose special field is remote sensors, and Star Vision Ltd. Managing Director Sr Thomas Lee, a leader in 3D model unmanned aerial vehicles (UAVs, or aerial drones).

"As we have strength in different surveying technology, there wouldn't be any overlapping of topics and these three subjects are the newest ones we wish to introduce," explains Sr Dr Tang. "In terms of funding, this grant is the biggest

ever in the LSD's history, though we originally requested more than HK\$3 million in the original proposal. Frankly, the funding meant a lot to us, since we hope to work with the industry to do more. In the past we could only afford to make presentations at international congresses, which was not all-rounded and couldn't focus on the target audience. Now we can push the boundary further to Belt and Road countries, stressing modern technology and application.

"Originally, we extended invitations to about eight countries which are undergoing a strong economic development cycle through the projects under the Belt and Road Initiative, so the land surveying technology would help their land development very much. Only the aforementioned four promptly expressed their interest while the others, like Brunei, got back to us after the deadline. As far as I know, the governments concerned have kept all surveying information in their hands so their countries lack the initiative to adopt high-tech skills like UAV. Therefore it's possible to showcase our techniques and help them set up a fast, accurate and affordable way to collect relevant data."

From an academic perspective, Sr Dr Tang hopes to leverage on this opportunity to nurture knowledge transfer in these developing countries. "Our proposal is more focused and in-depth," he says. "When preparing the programmes, the key challenge was to contact and persuade

he says. "When preparing the programmes, the key challenge was to contact and persuade local partners in respective countries to work together with us. Besides, there were many mutual agreements and mechanisms still to be worked out."

Dr Wong says that similar research topics regarding remote sensors were implemented before so his team will "ride" on those existing research resources. "We organise regular academic conferences and meetings so I don't see any difficulties about giving talks or meeting our local partners," he adds "We would treasure such a research collaboration because it's very hard to access surveying data in these developing countries."

Unlike Sr Dr Tang and Dr Wong, Sr Thomas Lee runs his own business on UAVs, which resulted in a balanced scope of view. In fact, he won Hong Kong Government Innovation and Technology Fund and his company contribution for a total of HK\$3 million three years ago to develop the 3D Mapping and Documentation System and ensure that the industry stays on the right hi-tech course. He said, "So far, I've sold my system to Macau government, offering training courses and certificates. I am also in talks with the Shenzhen Surveying Professionals and have given several talks in Beijing to businessmen and professionals. When Conrad approached me, I immediately said yes. I support taking the idea to the Belt and Road countries. If we succeed, not only will it bring business, but ensure professional service advancement there. I hope to introduce our hightech skills and professionals to them."

While Sr Dr Tang and Dr Wong cope with academic arrangements, Sr Lee is responsible for lining up with non-academic contacts like local professional bodies and commercial professionals to sign memoranda of understanding (MOUs) and to form interest groups to arrange a physical

forum. He will give talks, demonstrate and produce 3D maps and spatial big data of the cities. He is also committed to visiting all four cities, and has already started some preparatory work. "Our limited budget will only allow three of us to fly to each destination and handle the two-day exhibition and three-day visits to universities, commercial institutes or government departments," he adds. "For the last few months, I have been advertising in newspapers and universities to recruit a research project officer but in vain. We haven't been able to find exactly the right person – someone who is well versed in Al and able to relay our message to international audiences. Our 3D UAV documentation involves thousands of images/data for intelligence analysis so somebody with AI expertise will be an advantage. Meanwhile, I kept finding projects in town and about 30 pilot projects have been done for the exhibition/presentation. Nobody has covered them before. So, the industry feels very excited, as they haven't seen this before.

"In addition, it's hard to trace high-tech people as they are not so good at marketing themselves. So nobody knows how to source them. Matching them with interested parties looking for high-tech people is an issue. The media has a role to play and we hope the Government will fuel the supply by offering more training. Additionally, the funding requires us to promote our advancement proactively and we match Central Government's Belt and Road Initiative, which is not just purely commercial but stresses cultural exchange and sharing as well," Sr Lee added.

Being the first division of the HKIS to win the PASS, the trio have high hopes to roll out the programme on time and within budget. Apart from exporting the expertise, the other emphasis is to share their experience with members. Therefore, there will be a sharing session in the HKIS's annual conference in September 2019.

香港測量師學會土地測量 組成功獲取香港特別行政區 專業服務協進支援計劃的資助

土地測量組曾三度申請專業服務協進支援計劃,終於獲批資助,用於一帶一路所倡議的項目。即將展開的工作依然充滿挑戰。

香港政府撥款港幣兩億元,在二零一六年設立專業服務協進支援計劃,資助推行由業界主導的非牟利項目,香港測量師學會的土地測量組先後遞交兩次申請,但都失敗。土地測量組後來再接再厲,尤其參考了會長郭岳忠測量師的意見,再次調整計劃書內容。終於在第三次時申請成功,今年獲批資助港幣為一百七十三萬九千元。

此計劃旨在協進本港專業服務行業與一帶一路市場相關行業的交流和合作,以及推動相關活動。在土地測量組主席鄧康偉博士測量師的領導下,以推廣土地測量技術服務為主題,建議自二零一八年四月一日起,推行一個為期廿四個月的項目。其內容包括在中國內地、巴基斯坦、哈薩克和斯里蘭卡舉行四個關於土地測量服務的展覽,同時拜訪當地相關機構。另外還建議翻譯與綜合這四個地區的土地測量法例和法規、於二零一九年九月在香港舉行關於土地測量技術的交流會議,及後在二零二零年再舉辦三場工作坊,討論技術轉移和交流測量業資訊。土地測量組需在二零一九年三月向政府提交中期審計報告,之後在二零二零年六月提交最後報告。

土地測量組主席鄧康偉博士測量師本身是地籍測量的專家,他聯同遙感測量 專家,香港理工大學黃文聲博士,以及無人機與三維城市電腦模型專家,星 眺有限公司董事總經理李偉鵬測量師,組成三人團隊。

「在土地測量技術大家各有所長,不會重複專業協進的題目,我們希望介紹這三個業界最新的題目。」 鄧康偉博士測量師: 「雖然我們原先遞交計劃書時申請逾港幣三百萬資助,但今次獲批的資助金額仍是土地測量組有史以來最多的,有助我們做更多推廣業界的工作。在以往,我們曾受資金所限,只能在國際會議上做簡報,但內容仍不夠全面,而且無法與潛在團體傳達訊息。現在我們終可與一帶一路沿線國家互相交流,進一步協助推廣專業服務和應用。」

「原先我們計劃邀請八個經濟發展蓬勃的一帶一路沿線國家參與,希望利用 土地測量技術大大幫助當地土地發展。然而當時回覆邀請的只有前文所提及 的四個國家,其他國家如汶萊在截止日期過後才回覆我們。據我所知,部分 國家的測量數據資料由政府全權掌握,故此無意採用無人機等先進科技。因 此,我們有必要展示現行技術,協助他們以快捷、準確和成本低廉的方法收 集相關數據。」

從學術層面來看,鄧康偉博士測量師期望藉此機會,將知識轉移到這些發展中國家。他說:「我們計劃書的內容更集中和深入。在籌備活動時,最大的挑戰

在於與當地組織取得聯繫和游説他們取得合作夥伴關係。在取得聯繫後,就視乎他們是否願意參與活動。另外,我們還要努力與各國建立協議和機制。」

黃文聲博士指出,有關遙感應器的類似研究其實早已存在,他與其團隊將善用現有的研究資料。他說:「我們定期舉辦學術研討會和交流會議,我不認為在當地演說或與當地組織開會存在困難。我們很珍惜這些共同研究機會,因為取得這些發展中國家的測量數據不容易。」

有別於鄧康偉博士測量師和黃文聲博士,李偉鵬測量師自行開設無人機公司,為團隊帶來其他意見,平衡團隊內部的觀點。他之前成功申請香港政府創新及科技基金,其公司過去三年投資港幣三百萬元發展三維地圖製圖及文檔系統,提升業界技術。他說:「我將系統售予澳門特別行政區政府,提供培訓課程和頒發證書。另外,我正與深圳的測量專家商討合作機會,亦在北京發表了幾場演説,與各界企業家和專業人士交流。當鄧康偉博士測量師聯絡我,我立即答應。我支持向一帶一路沿線國家提供意見。如果成功的話,不但帶來商機,還可以推廣協進專業服務。我期望向這些國家推廣我們的高科技技術和專才。」

鄧康偉博士測量師和黃文聲博士專心處理學術上的安排,李偉鵬測量師則負責聯絡非學術機構,包括與當地專業組織和商界人士簽訂備忘錄,以及組織團體舉辦論壇。他的工作包括發表演說、展示各城市的三維地圖製圖和空間大數據。他將會訪問前文所提及的四個國家,準備工作正在進行中。「在有限的預算下,我們三人可前往每個國家,完成兩天展覽和花三天時間訪問當地大學、商業機構或政府部門。過去幾個月,我在報紙刊登廣告,又在大學招聘,希望能聘請一名研究項目主任,但都不成功。我們的理想人選是熟識人工智能,可以將我們的訊息傳遞給全球受眾。三維無人機收集的文檔包括數以千計用作分析的圖像或數據,精通人工智能技術無疑是優勢。同時,我在物色不同計劃,目前已展出或簡報了約卅個先導計劃。這些計劃過往未被提及過,所以業界對此都表現得很雀躍。」

李偉鵬測量師又說:「尋找高科技專才並不容易,因往往他們不擅於推廣自己的專長,以致外界不知如何與他們聯繫。配對科技專才和相關團體是一種挑戰。傳媒在當中可發揮作用,但我們亦希望政府能培訓更多科技專才。其計劃要求我們積極推廣協進專業服務,以及配合中央政府的一帶一路倡議,不光只是出於商業考慮,更是有助文化交流。」

ugust proved to be another busy month filled with forums and conferences. It also saw the Institute making history, with secondary school students who entered our "Create Your District" Competition busy preparing their models and videos to meet the submission deadline of 14 September and then the jury assessment presentation on 6 October. Also in October, our truck road show will take the event to the next level as it stages exhibition at the various participating schools and public area across the territory as it promotes the surveying industry.

Enhancing Construction Quality and Collaborating for Belt and Road Initiative

I was among members who attended the 2018 Mainland and Hong Kong Construction Industry Forum on 23 and 24 July in Guiyang, jointly organised by the Ministry of Housing and Urban-Rural Development, Guizhou Provincial People's Government and the Development Bureau. This year, the forum's topics covered construction planning, design and project management; construction technology, innovation and heritage, prefabricated building, and green building, as well as exploring business opportunities in the Belt and Road Initiative and Greater Bay Area (Guangdong, Hong Kong and Macau). This proved to be an excellent platform for fostering exchanges and learning more about China's advance technological developments in the construction sector. I was highly impressed by some presentations which illustrated the extensive use of prefabricated construction.

Outstanding Students Awarded in HKIS Scholarship 2018

My heartfelt congratulations to all 51 students from The University of Hong Kong, City University of Hong Kong, The Hong Kong Polytechnic University and the Hong Kong Institute of Vocational Education, who won our scholarships this year. For the award ceremony I was joined by Senior Vice-President, Sr Dr Tony Leung and the Chairman of the Board of Education, Sr Alan Sin. Since 1988, the scheme has been recognising outstanding academic performance by students taking surveying and surveying-related courses. I hope the awardees make good use of their prizes to unleash their professional potential. In view of the booming construction and property development market in Hong Kong and neighbouring regions, the industry requires a continuous influx of professional surveyors to nurture this growth

First Joint Event by the HKIS and the RICS

The first gathering between the HKIS and the RICS took place on 6 August. During the event, we first followed up our mutual recognition on GPD which was signed earlier and explored the possibility of joint examination/assessment for students as well as discussing our way forward on similar mutual recognition for other divisions. This proved a fruitful event for mingling and exchanging views. We hope to make it a regular event and the next round is tentatively set for November.

Views Expressed in Policy Address Consultation

With the 2018-19 Policy Address to be announced soon, the Financial Secretary invited the professional services sectors to share their views and ideas at a consultation forum on 10 August at Central Government Offices. During the 90-minute session, I specifically raised the need for an exit plan for the Government's stringent measures to cool down our over-heated property market. So far, the secondhand residential market has been distorted with a sharp drop in transactions with most buyers flocking to the first-hand property market. This is unhealthy and we hope Government will consider removing these barriers at a right time and set the market free without intervention. Secondly, I also advised that more should be done to nurture greater business opportunities for SMEs within the professional services. This is particularly an issue when most public works tenders issued by Government involve mega-size projects. Such tenders are too big for SMEs and beyond their eligibility for bidding, so it would be a big help if Government could give

more opportunities to SMEs to participate, thereby elevating their capacity to an international standard.

We wrote to the Financial Secretary early this year and proposed appointing an independent professional to write an inspection report before individuals or institutions buy second-hand property. The concept is widely adopted in the US, Europe and Australia, but not implemented in Hong Kong. As Government doesn't have an exit plan for its stringent property tax, this could be a short-term solution for needy buyers because, if a property bears no illegal structures or other faults, it means less risk for banks and relaxed mortgage clauses. We are awaiting the Government's reply.

Joint Press Conference on Land Supply in Hong Kong

Four professional institutes - The Hong Kong Institute of Architects, The Hong Kong Institute of Landscape Architects, The Hong Kong Institute of Planners and the HKIS - held a joint press conference on 22 August to share opinions on land supply issues in Hong Kong. We stated three key views: the shortage of supply for development, the need to build land reserves and the need to embark on full-scale planning with a 'livable city' as the target. We also agreed that it is vital to adopt an open and practical attitude to consider various land creation strategies.

提升建築品質、共建一帶一路

我與其他會員一同參與了「2018年內地與香港建築論壇」。有 關論壇於 7 月 23 及 24 日一連兩日在貴陽舉行,由國家住房和 城鄉建設部、貴州省人民政府和發展局合辦。今年論壇題材豐 富,涵蓋建築規劃、設計和項目管理、建築科技、創新和保育、 組合屋以及綠色建築,同時發掘更多與一帶一路倡議和大灣區 (廣東、香港和澳門)有關的商機。論壇提供一個有用的平台, 促進各方交流,同時讓業界更認識內地關於建築業的技術發展, 我尤其對當中提及的預製組件的建築模式留下深刻印象。

香港測量師學會獎學金 2018 嘉許優秀學生

恭喜 51 位今年獲頒本會獎學金的學生,他們來自香港大學、香 港城市大學、香港理工大學和香港專業教育學院。本人與高級 副會長梁家棟博士測量師、教育委員會主席洗國良測量師一同 出席頒獎典禮。本會自 1988 年推出獎學金計劃以來,已嘉許了 眾多修讀測量學或與測量學有關課程的學生,他們在學術上表 現優秀。我期望得獎者能善用獎學金,充份發揮所長。香港和 鄰近地區的建築和物業發展市場發展蓬勃,需要不斷有新晉專 業測量師支持行業發展。

與皇家特許測量師學會首次聯合舉辦活動

本會與皇家特許測量師學會於8月6日首次舉辦聚會。我們當 日的首要議程是跟進雙方早前同意有關產業測量的資格互認事 宜, 並探討雙方是否可以舉辦聯合考試或審核學生資歷, 以及 日後就其他組別達成類似的資格互認。今次活動收獲豐富,雙 方交換意見,更加了解彼此想法。我們期望雙方能定期舉辦類 似活動,下輪活動暫定於11月舉行。

就施政報告諮詢發表意見

政府即將發表 2018 至 2019 年度施政報告,財政司司長邀請專 業服務界別出席諮詢論壇發表意見和想法。有關論壇於8月10 日(星期五)假中區政府總部舉行。在90分鐘的論壇上,我特 別提到政府有需要放寬現行政策,為過熱的樓市降温。目前二 手住宅樓宇市場交投大幅下降,大部分買家傾向買入一手住宅 物業。這種情況不利長遠發展,我們促請政府考慮在適當時候 取消現行限制,放寬樓市自由發展。其次,我建議政府推出更 多措施,協助專業服務界別的中小企業擴展營商機會。現時大 部分政府投標的公共工程都屬於大型工程,中小企業無法承辦 有關工程,亦不符合投標資格。若政府能開放更多工程,讓中 小企業參與,此舉無疑可提升中小企的表現,與國際水平接軌。

我們早前致函財政司司長,建議個人或機構購買二手樓宇前, 先委任獨立專業人士撰寫調查報告。這種做法早已廣泛應用在 歐美、澳洲等地,但香港仍未實行。政府目前未有計劃放寬有 關樓宇的各種稅項,此舉可視作短期措施,協助有需要的買家。 因為若有關單位並無涉及僭建或其他問題,銀行可放寬貸款條 件。我們正在等待政府回覆。

就香港土地供應召開聯合記者會

四大專業學會,包括香港建築師學會、香港園境師學會、香港 規劃師學會及香港測量師學會,於8月22日舉行聯合記者會, 就香港土地供應事宜分享意見,包括以下三點:可發展土地供 應不足、建立土地儲備、以構建宜居城市為長遠目標進行全面 規劃。我們提議採取更開放和實際的態度去制定土地開發政策。

Flying high

Sr Kin-siu Ng, CEO of Fruit Design & Build, has worked his way up through the construction industry, establishing a successful firm that has won plaudits in high places.

Sr Kin-siu Ng, CEO of Fruit Design & Build, is a building surveyor with an entrepreneurial spirit. Hardworking and curious, he has over the years steadily built his profile to strengthen his professional and company portfolios, learning and innovating along the way. Investing in R&D while running a professional firm, he is fond of exploring the road less travelled to help the industry build a better future.

As a teenager in the late 1980s, Ng started working in a construction firm under the supervision of a building surveyor. After three years of exposure to different aspects of building and construction, he went to the Hong Kong Polytechnic and then the UK to complete a BSc in building surveying.

"I have always been intrigued by the different trades within building surveying and construction, as well as the satisfaction of

completing building projects and connecting with people," says Ng. Throughout the years of working since graduated, Ng has attained various experience in building and property development from his employment in both private and public sector.

Ng did not rest on his laurels. In 2008, he started his own business Fruit Design & Build to provide solutions to clients. "This is what I had always wanted to achieve: meet new challenges, try things out in a new environment and develop my strengths," he says.

Based on client needs and being marketoriented, the firm has gradually expanded to encompass a range of professional realms. Today, the company, which employs 200, focuses on more than just building and construction. It is also officially authorised to provide licensing, engineering, architectural and interior design services.

To take on further challenges, Ng oversaw the firm's public listing on GEM in 2015, and then on the Main Board of HKEx in 2017. "There are several factors leading to our public listing," he says. "Firstly, we want to gain wider recognition and have stronger financial support so as to work on bigger projects with major clients. Secondly, we would like to enhance our strengths and corporate governance by complying with HKEx' requirements. Thirdly, going public gives management and employees clear goals and parameters to work towards greater success."

And his firm has gained recognition from more than simply the market; it has won praise from the highest reaches of the Chinese government. Fruit Design & Build was the "legendary" firm behind the foreign-aid project of China in Nepal that received compliments from National People's Congress Chairman Zhang Dejiang. Zhang said in a speech at the Belt and Road summit in 2016, that "when the massive Nepal earthquake struck, a large number of structures collapsed, but projects supervised by Hong Kong companies basically remained intact." The firm was praised for being a showcase of the strengths Hong Kong's professional services sector under China's "One Belt, One Road" strategic initiative.

Humbly admitting that he was congratulated by many professionals in the industry after Zhang's public compliments, Ng recalls what happened in Nepal. "Thanks to the HKIS, our firm had the chance to work on one of China's foreign-aid projects in 2015. It was supposed to be a 22-month project, but a severe earthquake struck on a Saturday night during the second month, resulting in a breakdown in communications and great chaos."

"As we had staff members on secondment to Nepal, we immediately contacted their family members in Hong Kong to comfort them," Ng continues. "It was the first thing we did, because it was just the right thing to do."

The staff members were thankfully later found to be safe. Having been forewarned of the situation in Nepal, the employees stayed outdoors at night to avoid being caught in aftershocks.

Back in Hong Kong, Ng is proud to have contributed to urban redevelopment and revitalisation. From Hong Kong Island's Western district to Kwai Chung's factories, Ng and his people worked hard to come up with winwin solutions to enhance the experience of pedestrians, while at the same time negotiating better gross floor areas for developers.

Always willing to learn and embark on new adventures. Ng turns his words into actions by investing in R&D. "I don't mind not being able to make immediate or big profits through R&D. Instead, I encourage our colleagues to think outside the box: you will always learn a lot from your explorations and attempts to solve problems, even if they may not be financially rewarding at times," notes Ng with enthusiasm.

With the belief that there are gaps in the market to be filled, Ng gives employees intellectual space to explore formerly untapped areas, leading to potentially fruitful harvests. "To respond to the government's call for a smart city, we are developing an app-based system for the visually impaired," he says. "We hope to promote it to developers and other stakeholders to provide an alternative to the internationally recognised, physical tactile paving currently used." On top, the group helmsman is ready to get a foothold in property development in the near future.

As a leader who is both down-to-earth and visionary, Ng advises that young surveyors equip themselves with strong professional knowledge. "It is only when you cement your professional expertise and experience that you can develop your potential. Grasp opportunities to learn as much as you can. Do not be afraid of hard work or work that does not promise immediate returns. You may encounter good times or bad, but if you know your core responsibilities well and possess an in-depth understanding of the sectors, you can overcome challenges at all times."

豐展設計及營造有限公司行政總裁吳建韶測量師,本身是一位建築測量師,但具有企業家的精神。勤奮、好奇的他,這些年來慢慢建立了自己的事業,打造專業形象,增強公司的競爭力,學習和創新同步進行。投資科研,同時經營公司,他享受發掘各種機會,為行業建立更美好的未來。

回想 1980 年代後期,青少年時期的吳建韶測量師在一間 建築公司任職,並向公司的建築測量師匯報工作。他在三 年間接觸樓宇和建築各方面的事情,之後在香港理工學院 和英國完成建築測量學理學十課程。

吳建韶測量師說:「我對建築測量和樓宇建造的各方面 工作深感興趣,完成樓宇項目和與人交流令我很有滿足 感。」畢業後,他在公營機構和私人公司累積不同的工作 經驗,豐富了他在樓宇和物業發展方面的閱歷。

吳建韶測量師並未安於現狀。他在 2008 年成立豐展設計及營造有限公司,為客戶提供全面的設計及建築服務方案。他說:「我一直追求的目標就是迎接新挑戰,嘗試新環境和發揮所長。」

公司照顧客戶需要和緊貼市場趨勢,逐漸擴充業務至各專業領域。目前公司聘請了 200 名員工,集中處理樓宇和建築各方面的工作,另外提供牌照顧問服務、屋宇工程服務、建築設計和室內設計服務。

為迎接更多挑戰,吳建韶測量師帶領公司於 2015 年在創業板上市,兩年後在主板掛牌。他說:「公司上市出於多個考慮因素,第一我們期望取得市場的肯定,有更強大的資金來源,在處理大客戶的大型項目時更得心應手。第二我們上市必須符合香港交易所的要求,變相等同增強公司的競爭力和企業管理效能。第三公司上市為管理層和員工提供更清晰的發展目標,大家共同努力邁向成功。」

「我鼓勵員工創新:在探索和解決問題的過程中,你會有新的 體驗,哪怕是無法即時有金錢上的回報。」 公司不但在市場上取得成功,中國政府亦對此予以肯定。 豐展設計及營造有限公司有份參與中國在尼泊爾的一個援 建項目,被時任全國人大委員長張德江點名表揚。張德江 在2016年出席一帶一路高峰論壇並發表演說,他提到「尼 泊爾發生大地震,大量建築物倒塌,但香港公司監理的項 目完好無損」,充分體現香港專業服務的優良品質,也證 明香港專業服務對一帶一路建設貢獻良多。

吳建韶測量師謙虛地說,公司在獲得張德江表揚後,紛紛 收到同業的祝賀,他回憶當時在尼泊爾發生的種種,「在 香港測量師學會的協助下,我們公司有機會在 2015 年參 與由中國援助的項目。有關工程項目本身為期 22 個月, 但工程開始後的第二個月即發生大地震,當時對外通訊完 全中斷,情況非常混亂。」

「我們有員工借調到尼泊爾工作,於是我們立即通知他們在香港的家人,讓他們放心。」他說:「我們第一時間要做的就是這件事,因為這是必需要做的事情。」幸運地有關員工最後都安然無恙。因為當地發出餘震警告,員工當晚通宵留在室外以察安全。

吳建韶測量師對於參與香港的市區重建和活化感到自豪。 由港島西至葵涌的工廠大廈,吳建韶測量師和團隊努力提 供能達致雙贏的解決方案,在顧及行人需要的同時,亦為 發展商爭取較大的建築面積。

不斷學習和接受新挑戰,吳建韶測量師以行動證明自己, 投資科研。「我不在意投資科研無法立即取得回報或賺 大錢,相反我想藉此鼓勵員工創新:在探索和解決問題的 過程中,你會有新的體驗,哪怕是無法即時有金錢上的回 報。」對此,他充滿熱忱。

吳建韶測量師相信市場仍有許多未開發的潛力,他鼓勵員工多探索,把握潛在的發展機會。他說:「我們為回應政府提倡建設智慧型城市,開發了一個以應用程式為主的系統,協助視障人士。我們希望向發展商和其他持份者推廣這個系統,在盲人引路徑以外,為視障人士提供另一選擇。」吳建韶測量師亦有意在未來進軍地產發展。

作為一個兼具務實和有遠景的領袖,吳建韶測量師建議年輕測量師要時刻裝備自己,增強專業知識。他說:「你要鞏固自己的專業知識和經驗,才能發揮所長。盡量爭取學習機會。不要怕辛苦或抱怨工作沒有即時回報。順境和逆境都是必經階段,但只要你清楚自己的職責,深入了解這個行業,你一定能夠克服困難。」

国务院办公厅关于印发 《港澳台居民居住证申领 发放办法》的通知

港澳台居民居住证申领发放办法

第一条 为便利港澳台居民在内地 (大陆)工作、学习、生活, 保障港澳台居民合法权益,根据《居住证暂行条例》的有关 规定、制定本办法。

第二条 港澳台居民前往内地(大陆)居住半年以上,符合 有合法稳定就业、合法稳定住所、连续就读条件之一的, 根据本人意愿,可以依照本办法的规定申请领取居住证。

未满十六周岁的港澳台居民,可以由监护人代为申请领取居 住证。

第三条 港澳台居民居住证登载的内容包括:姓名、性别、 出生日期、居住地住址、公民身份号码、本人相片、指纹信息、 证件有效期限、签发机关、签发次数、港澳台居民出入境证

公民身份号码由公安机关按照公民身份号码国家标准编制。 香港居民公民身份号码地址码使用 810000,澳门居民公民身 份号码地址码使用820000,台湾居民公民身份号码地址码使 用 830000。

第四条 各级公安机关应当积极协调配合港澳事务、台湾事 务、发展改革、教育、民政、司法行政、人力资源社会保障、 住房城乡建设、交通运输、卫生健康等有关部门,做好居住 证持有人的权益保障、服务和管理工作。

第五条 各级公安机关应当建立完善港澳台居民居住证管理 信息系统,做好居住证申请受理、审核及证件制作、发放、 管理工作。

第六条 港澳台居民居住证的有效期限为五年,由县级人民 政府公安机关签发。

第七条 港澳台居民居住证采用居民身份证技术标准制作, 具备视读与机读两种功能,视读、机读的内容限于本办法第 三条规定的项目。

港澳台居民居住证的式样由公安部商国务院港澳事务办公室、 国务院台湾事务办公室制定。

港澳台居民居住证由省级人民政府公安机关统一制作。

第八条 港澳台居民申请领取居住证,应当填写《港澳台居 民居住证申领登记表》,交验本人港澳台居民出入境证件, 向居住地县级人民政府公安机关指定的公安派出所或者户政 办证大厅提交本人居住地住址、就业、就读等证明材料。

居住地住址证明包括房屋租赁合同、房屋产权证明文件、购 房合同或者房屋出租人、用人单位、就读学校出具的住宿证 明等;就业证明包括工商营业执照、劳动合同、用人单位出 具的劳动关系证明或者其他能够证明有合法稳定就业的材料 等;就读证明包括学生证、就读学校出具的其他能够证明连 续就读的材料等。

第九条 居住证有效期满、证件损坏难以辨认或者居住地变 更的,持证人可以换领新证;居住证丢失的,可以申请补领。 换领补领新证时,应当交验本人港澳台居民出入境证件。 换领新证时,应当交回原证。

第十条 港澳台居民申请领取、换领、补领居住证,符合办 理条件的,受理申请的公安机关应当自受理之日起20个工作 日内发放居住证;交通不便的地区,办理时间可以适当延长, 但延长的时间不得超过10个工作日。

第十一条 港澳台居民在内地(大陆)从事有关活动,需要 证明身份的,有权使用居住证证明身份,有关单位及其工作 人员不得拒绝。

第十二条 港澳台居民居住证持有人在居住地依法享受劳动 就业、参加社会保险、缴存、提取和使用住房公积金的权利。 县级以上人民政府及其有关部门应当为港澳台居民居住证持 有人提供下列基本公共服务:

- 义务教育;
- 基本公共就业服务;
- 基本公共卫生服务;
- (四) 公共文化体育服务:
- (五) 法律援助和其他法律服务;
- (六) 国家及居住地规定的其他基本公共服务。

第十三条 港澳台居民居住证持有人在内地大陆)享受下列便利:

- (一) 乘坐国内航班、火车等交通运输工具;
- (二) 住宿旅馆; (三) 办理银行、 办理银行、保险、证券和期货等金融业务;
- 与内地(大陆)居民同等待遇购物、购买公园及各类 文体场馆门票、进行文化娱乐商旅等消费活动;
- 在居住地办理机动车登记;
- 在居住地申领机动车驾驶证
- 在居住地报名参加职业资格考试、申请授予职业资格;
- 在居住地办理生育服务登记;
- (九) 国家及居住地规定的其他便利。

第十四条 国家机关及其工作人员对在工作过程中知悉的居 住证持有人个人信息,应当予以保密。

第十五条 港澳台居民居住证持证人有下列情形之一的,其 所持居住证应当由签发机关宣布作废:

- 丧失港澳台居民身份的;
- 使用虚假证明材料骗领港澳台居民居住证的;
- 可能对国家主权、安全、荣誉和利益造成危害的;
- 港澳台居民出入境证件被注销、收缴或者宣布作废的 (正常换补发情形除外)。

第十六条 违反规定办理、使用居住证的,依照《居住证暂 行条例》的有关规定予以处罚。

国家机关及其工作人员违反居住证管理相关规定的,依法给 予处分;构成犯罪的,依法追究刑事责任。

第十七条 首次申请领取居住证,免收证件工本费。换领、 补领居住证,应当缴纳证件工本费。具体收费办法参照 《居住证暂行条例》的有关规定执行。

第十八条 港澳台居民迁入内地(大陆)落户定居的,按照 有关规定办理,不适用本办法。

第十九条 本办法所称"港澳台居民"是"港澳居民"和"台 湾居民"的统称。其中,"港澳居民"是指在香港、澳门特 别行政区定居且不具有内地户籍的中国公民;"台湾居民" 是指在台湾地区定居且不具有大陆户籍的中国公民。

本办法所称"港澳台居民居住证",包括中华人民共和国港 澳居民居住证、中华人民共和国台湾居民居住证。 本办法所称"港澳台居民出入境证件",包括港澳居民来往 内地通行证、五年期台湾居民来往大陆通行证。

第二十条 省、自治区、直辖市人民政府可以结合本行政区 域综合承载能力和经济社会发展需要等因素,根据本办法制 定实施细则。

第二十一条 本办法自 2018 年 9 月 1 日起施行



The HKIS Outstanding Dissertation/ Thesis Awards 2017 Executive Summary of Winning Papers

THE IMPACT OF USER REVIEWS ON THE PRICING OF ONLINE TRAVEL ACCOMMODATIONS: THE CASE OF AIRBNB AND HOTEL ROOMS

Undergraduate – Second Award (GP) Awardee: LAM Shuk Fong (University of Hong Kong – REC)

Travel accommodations can be regarded as a bundle of goods and services, the pricing of which is affected by the quality of the accommodation and associated services. The former is generally easier to measure and subject to less information asymmetry, as the physical attributes (e.g. size, location, facilities, etc.) can be readily specified and measured. On the contrary, the latter tend to be more affected by asymmetric information, as accommodation suppliers know the quality of their associated services more than travellers. The information asymmetry problem intensifies when travel accommodations are booked online and trust and reputation issues come into play. Consequently, user ratings have been used by travel accommodation websites to address the problem. Unlike those for other goods and

services, user ratings on travel accommodation websites are mostly restricted to genuine users with verified identities, thereby making these ratings more reliable. If they can help mitigate information asymmetry, accommodations with better ratings should be of higher quality, which would be reflected in their prices. Currently, there has been little empirical research to investigate whether user ratings can serve as a proxy for the quality of travel accommodations. This study examines how user ratings affect the listing prices of Airbnb and hotel room rates.

The study's theoretical framework is based on the proposition that user ratings are more important for higher-end travel accommodations, as service quality is more difficult to measure. This is especially true for Airbnb, since there is no third party star rating system similar to those adopted for the hotel sector. The empirical results from Hong Kong, Taipei, Shanghai, Tokyo, London, and New York suggest a positive impact of user ratings on the listing prices of Airbnb units there and that the impact is stronger for high-end than low-end units. Travellers looking for basic accommodations with limited or basic service (low-end) do not care that much about user ratings. Therefore, compared to high-end units, the prices of low-end units are less sensitive to user ratings. These results are in stark contrast to previous findings, which suggested a null effect of user ratings on the listing prices of Airbnb. Such a difference could possibly be attributed to the modelling of the differential impact of user ratings on high-end and low-end units.

The empirical results for online hotel room rates were similar, despite the availability of star rating systems, which partly reflected service quality. The results were robust across different measures of high-end and low-end units.

CONVERSION OF IFC DATASETS TO LOD4 CITYGML BUILDING MODELS: DEVELOPMENT OF AN EXTENSION FOR CITYGMI

Undergraduate – Top Award (LS) Awardee: FU Xuan Di (The Hong Kong Polytechnic University – LSGI)

Evidence of growing interest in and demand for Integrating BIM and GIS has been found in recent years. Three-dimensional city models are the digital representation of urban areas and their related spatial objects including terrain surfaces, buildings, vegetation, landscapes, and infrastructure elements (Stadler & Kolbe, 2007). These models can be divided into two types: realistic and design models, which are mainly and separately produced by geographic information systems (GIS) and building information modelling (Pu & Zlatanova, 2006). Their integration should benefit main applications such as navigation, urban planning, disaster management, and energy consumption analysis.

City Geography Markup Language (CityGML) and Industry Foundation Classes (IFC) are seen as two prominent semantic models in the GIS and BIM domains, correspondingly. In the case of spatial semantics, IFC focus more on capturing building-related elements and information that may not be considered by CityGML - for instance, high-detailed geometric representation of building installations and semantic properties such as scheduling, cost, and owner. CityGML models support representing building geometry and other wide-ranging urban objects with five levels of detail. However, IFC does not possess corresponding definitions or characteristics (Deng, Cheng, & Anumba, 2016, pp.1-21). Much research has focused on the conversion between IFC and CityGML data in terms of different levels of detail (LOD) or conversion direction. However, there are still limitations to the current techniques, especially for the GeoBIM ADE (Berlo, 2010).

To facilitate the conversion from IFC datasets to LOD4 CityGML building models by solving the information loss caused by semantic noncorrespondence between two standards, this project has developed a new extension schema for the CityGML standards based on both theoretical and practical considerations. To fully address the issues, this paper compares the differences between two schemas in respect of feature types, properties, and relationships among objects. Through testing with open-sourced IFC example files, the author found that the developed extension of CityGML could significantly reduce information loss for the converted models. With the developed extension schema, the converted LOD4 CityGML models from the IFC datasets can preserve both the semantic and geometric information of the building entities sufficiently and correctly.

Visit to Hong Kong Kowloon West Station

The 26-km long Hong Kong Section of the Guangzhou-Shenzhen-Hong Kong Express Rail Link is scheduled to commence operations in late September. On 28 August, I was invited by the MTRC to represent the HKIS during a site visit to the Hong Kong Kowloon West Station. I want to share some photos and interesting facts here from the visit:

- A fire engineering approach was adopted for the fire safety design.
- About 8,000 tons of steel were used to build the roof structure and another 4,000 tons were used to temporarily prop it up during construction.
- The station's car park will connect to the future basement of the West
 - Kowloon Cultural District.
- The decorative lampposts inside the station comprise four functional layers from top to bottom: lighting, a public address system, heat detectors, and sprinklers.



Application Procedures for RICS-chartered Valuation Surveyors to Be Admitted as Professional Members of the GPD under a Memorandum of Mutual Recognition of Membership (MMRM)

Further to its reports on the MMRM in March and May, the working group reported to the GPD Council that since a candidate under the MMRM should have at least one year of local and relevant post-qualification experience, s/he should, upon applying for GPD membership, be required to submit a brief (~1,000 words) account of his/her past professional work experience and the key local or international projects s/he has handled. This would help the HKIS ascertain if the candidate is equipped with the relevant local experience.

The HKIS's Membership Department will soon inform each candidate in writing of the above requirements and deadline for submission.

HKIS Land Supply Task Force Meeting with the Hong Kong Federation of Trade Unions (FTU)

The Institute's Land Supply Task Force was invited by the Hong Kong Federation of Trade Unions (FTU) to discuss Hong Kong's potential land supply at the Legislative Council Building on 6 August. Sr Dr Tony Leung, Sr Alnwick Chan, Sr CK Lau, Sr Alex Lam, Sr KK Chiu, Sr Charles Chan, Sr Francis Lam, Sr Edmond Yew, and

Sr Bay Wong attended this forum. Both sides exchanged opinions and explored the options suggested by the HKSAR Task Force on Land Supply.

The discussions covered the Public-Private Partnership Scheme for developing agricultural land in the New Territories, relocating the Kwai Tsing Container Terminals, redeveloping brownfield sites in the New Territories, redeveloping the River Trade Terminal, reclamation, developing the periphery of country parks, etc. The HKIS representatives expressed that the government should, by all means, consider all possible options to increase land supply in Hong Kong. Increasing plot ratio that was not mentioned in the 18 options should be considered by the Government. But before doing this, the government should devise a comprehensive city plan to ensure that Hong Kong's infrastructure and ancillary facilities are adequate for developing its existing and new development areas.

Focus Group Interview with HKU on the Mechanism to Unleash Privately-owned Agricultural Land in the New Territories

The GPD's Land Supply Task Force Working Group was invited by The University of Hong Kong's Ronald Coase Centre for Property Rights Research to discuss the mechanism for unleashing privately-owned agricultural land in the New Territories. Sr KK Chiu and Sr Alnwick Chan attended the meeting.

During the meeting, the attendees exchanged opinions on the questions raised by the Working Group including how to best solve Hong Kong's housing problems, realise the potential of and develop agricultural land in the New Territories, overcome the hurdles of the public-private


partnership scheme, solicit opinions on the land readjustment proposal, determine the proportion of public housing out of total housing stock, etc.

CPD: Private Equity Real Estate – In Search of Values through Times of Market Turbulence (Code: 2018119)

Dr Charles Lam, an industrial veteran with over 25 years of experience in private equity real estate (PERE) fund investment practice at AIG Global Real Estate Investment, China Ping An Trust, Pramerica Real Estate Investors, and Baring Private Equity Asia's real estate investment arm was invited to give a CPD seminar from a practitioner's point of view on the impact of the growing PERE market in Asia. Dr Lam started by introducing the PERE industry and its expansion from established American/ European markets to emerging Asian markets. He then introduced the industrial practices in investment underwriting, transaction structuring, asset management, and specialisation of different professional consultants including GP surveyors' participation in every key area of the PERE investment process. Moreover, he shared with the younger members his investment philosophy and the career development paths in the PERE industry.

Throughout the seminar, members gained an understanding of this growing market

participant in the real estate investment market from both global and domestic perspectives. It is also a sector in which professional surveyors have increased their involvement. Dr Lam also encouraged surveying professionals to participate in this thriving industry.



CPD: Update of First-Hand Residential Sales Practices and Case-Sharings (Code: 2018141)

On 11 July, the SLC hosted a full house of members for a CPD, "Update of First-Hand Residential Sales Practices and Case-Sharings," delivered by Mr Raymond Wong, Senior GM of Sales at Henderson Land Development Company. Raymond gave a detailed interpretation of the Residential Properties (First-hand Sales) Ordinance and shared some practical ways to address the issues. Given that some surveyor members who might have been involved in preparing the sales brochures and sales/marketing sessions were in attendance, Raymond also highlighted some incidents encountered in "location plan" and "fitting, finishes & appliances" disclosures in the sales brochures, as well as the "consumption table" published during the sales period. He also discussed a few prosecution cases and the faults committed before proceeding to the relevance of the Trade Description Ordinance and new initiative of Housing.

Last, but not least, Raymond advised members to visit the FAQ section of the ordinance on the government website, which illustrates the various scenarios that may arise under this law.

Hong Kong Map Service 2.0

Practicing land surveyors in private practice. including myself, have seen continuous improvements in the quality of their services and products, which not only facilitate their work, but also enable the general public to gain easy access to geographical information. The Hong Kong Satellite Positioning Reference Station Network was launched in 2010. Following that came an automatic GPS computation service from the Geodetic Survey Section. GPS positioning is now a popular and efficient tool for every professional surveyor. Furthermore, the Lands Department's Survey and Mapping Office (SMO), supporting the government's open data policy, has, since 2011, posted geo-referenced public facility data, digital terrain models, 1:100,000 and 1:200,000 topographic maps of Hong Kong in geotiff format, etc, online for the general public's scrutiny. Having maintained a GIS database, the government's Geo-Spatial Information Hub, the SMO has publicised a wide spectrum of information in GeoInfo Map. MyMapHK, and VoiceMapHK, which contain powerful data that Hong Kongers can enjoy in addition to providing an excellent service.

Hong Kong has new 3D map products and free geodetic control data. It will soon have price-cutting maps and photogrammetric data. To give one example, the cost of a sheet of iB1000 data will fall from its current price of \$215 to \$54. Then there will be a level-jumping improvement to the mapping service, Hong Kong Map Service (HKMS) 2.0. This web-based service is available at https://www.hkmapservice.gov.hk. The SMO's service contact by phone is 2231-3187. Its e-mail contact is hkms_pub@landsd.gov.hk.

To land surveyors, the abovementioned developments represent a paradigm shift in their operations, as survey information searches have changed from paper to computer mode. The search function covers survey

data, aerial photos, cadastral survey records (including digital images of lot index plans and demarcation district sheets) using georeferenced or lot addresses and is conveniently available in the average surveyor's office or mobile device 24 hours a day. But such data are not limited to land surveyors. Anyone with a computer or mobile device can access them, too. The product preview function is also available in HKMS 2.0. It helps promote more applications that use digital products, as well as supports a paperless environment. The HKIS applauds this monumental achievement and thanks its counterparts at the SMO.

CPD Events

Sr Eric Tang delivered a talk, "The Authority of the Land Boundary Evidence," on 15 August. His land survey firm has handled over 10,000 boundary cases and he has personally handled over 100 cases as an expert witness in court. The audience was interested in hearing about his most prominent court cases and the evidence rules derived from them. Eric gave a detailed lecture on the historical background and legal settings of Hong Kong's cadastral system, particularly on the rules of adopting extrinsic evidence. He referred to his successful expert witness case, HCMP 982/2013, in which the judge preferred his extrinsic evidence findings on the intention behind a subdivision, as shown in a 1956 aerial photo, to that of the other side using a registered plan as evidence. There was not enough time for Eric to share all of his knowledge with the audience, so he promised to discuss more case studies at his next CPD event scheduled for December.



The LSD's Sr YC Chan and Dr Albert Wong of PricewaterhouseCoopers Consulting HK, Ltd shared their experiences with spatial data infrastructure and smart cities on 17 August. Dr Wong directed a consultancy project for the government that formulated a development

strategy for a smart city. He introduced short and long term development initiatives on six aspects: the environment, mobility, people, living, government, and the economy. Then he explained how common spatial data infrastructure underpins smart city services.



物業管理業監管局(下稱"監管局")於2018年6月15 日致函本會, 誠邀本會就物業管理公司及物業管理人牌 的發牌制度提供意見,本會經過詳細審視和商討,已經 把本會的回應意見交回監管局,以下是其中一些要點:

(1) 學會建議應加入主項服務類別 (core category of services) 及持牌管理公司的定義

建議「關乎物業的一般管理服務」是主項服務類別 (core category of services) 及持牌管理公司須符合:

- (a) 公司業務涉及 2 項或以上的服務類別:及
- (b) 其中 1 項必須為主項服務類別即「關乎物業的一 般管理服務」

訂定主項服務類別可給予提供物業管理及/或相連服 務的營運者有較清晰的定義和指引,兼且會較公平和 合理,例如只經營關乎工程顧問服務、物業管理的法 律服務及人力資源管理服務的公司便毋須持有物業 管理公司牌照。

雖然物業管理服務條例已訂定持牌管理公司的準則, 學會仍建議監管局在擬定「實務或行政指引」時能加 入上述的主項服務類別,以免因定義不清而引致混淆。

(2) 物業管理的 7 項服務類別

物業管理的 7 項服務類別中每項都包括 / 列舉細項服 務,但例子側重較前綫的督導工作(第2級持牌物業 管理人),而忽略較專業及策劃性的管理層面(第1 級持牌物業管理人)的參予,例如新發展項目的籌劃 及服務、企業財政管理、風險管理與政府部門緊密聯 絡及了解/推行新法例/政策/指引等。特別是「關 乎物業的設施管理」下所列細項並未全面反映現時設 施管理的發展路向。

為此,學會建議監管局於7項服務類別下增加多些 適合第1級持牌物業管理人的職能範疇。

(3) 物業管理公司及物業管理人發牌準則

a. 建議註冊的物業管理公司董事必須為第 1 級持牌 物業管理人,以確保管理公司的專業水平。

- b. 由於業界很多物業管理公司均持有附屬公司或獨 立公司用作專項物業管理之用,故建議不應限制 持有物業管理人牌照的董事以此身份出任物業管 理公司的數目。學會認為不應限制董事服務物業 管理公司的數目。
- c. 監管局建議每間物業管理公司須以全職形式僱用 至少3名持牌物業管理人,當中至少一名為第 1級持牌物業管理人。由於發展商普遍會於一個 屋苑成立一間獨立或附屬管理公司負責管理,故 此,學會建議每間管理公司只須1名持有第1級 物業管理人牌照的董事及根據其管理數目聘用相 關持牌管理人便可。
- d. 監管局建議持牌物業管理人與其所管理的單位 數目或面積比例,此設定的比例並不符合現時市 場的人手狀況。此舉將會令現時緊張的人手更為 嚴重,因各物業管理公司需要於市場上爭奪持牌 管理人員,從而直接推高平均薪酬,令管理費用 被迫要作調升。故此,學會認為規定物業管理公 司須擁有以下最低數量的第1級及第2級持牌 管理人:

(1) 住宅單位 - 大型屋

- 每4,000個單位計最少1名(第1級)及
- ii. 每 2,000 個單位計最少 1 名 (第 2 級)

倘管理單位由多個住宅物業組成而達至 2,000 個或以下,如公司董事已有最少一名 持牌第1級持牌物業管理人則只需要一名第 2級持牌物業管理人便可。

(2) 非住宅單位

- i. 每 100,000 平方米計最少 1 名 (第 1 級) (以總樓面面積計算)及
- ii. 每 30,000 平方米計最少 1 名 (第 2 級) (以總樓面面積計算)

倘管理單位由多個非住宅物業組成而達至 30,000 平方米或以下,如公司董事已有最 少一名持牌第1級持牌物業管理人則只需要 一名第2級持牌物業管理人便可。

(3) 混合式住宅

- i. 可依據上述住宅單位計算;或
- ii. 可依據上述非住宅單位計算

混合式住宅不可只用住宅單位計算,因不少是住宅連商場/商舖、車場等(非住宅單位)。

- e. 監管局建議物業管理公司牌照年費為HK\$6,000, 但學會認為過高,加重規模較小的物業管理公司 的營運費用,可能間接轉嫁到業主的管理費。學 會認為HK\$2,500 牌照年費較適合。
- f. 學會建議物業管理人牌照年費應為 HK\$400(第 1 級)及 HK\$200(第 2 級)是較為合理,用以減輕持牌人的負擔。
- g. 學會認為凡有物業管理相關經驗的香港測量師 學會會員皆乎合第1級持牌管理人的要求,並 在申請牌照之前具有最少一年的本地物業管理 工作經驗。

(4) 其他

根據物業管理服條例第6部33(1)及(2)條,民政事務局局長須委任一個由個人組成的上訴委員團,該委員團由1名主席及11名其他成員組成。監管局成員不得根據第33(1)條獲委任。另第6部35條(a)及(b)的「上訴審裁小組」須由「上訴委員團」的主席委任3名個人成員。學會建議「上訴審裁小組」及「上訴委員團」成員必須包括學會代表,以便提供專業和客觀的意見及對被投訴人作出公平的裁決。

學會希望監管局能詳細考慮本學會所提供的意見,並 修訂相關的條例,以致對整個物業管理行業能得到正 面的幫助,提升物業管理服務的水平,並且保障本學 會會員的權益。

YSG Long Distance Running Course, Series 2







1. Visit to Joyous Living at The Tanner Hill (28 July 2018)



Building Energy Saving Initiatives in Response to Climate Change

Introduction

The Paris Agreement, which was adopted by 195 nations in 2015, sets out an action plan to reduce the impacts of climate change. These countries basically agreed to keep the increase in the global average temperature below 2°C. Since China has signed the agreement, it also applies to Hong Kong.

The HKSAR Government has set a carbon intensity reduction target of 65-70% by 2030 (with 2005 as the base year). In absolute terms, it is equivalent to 26-36% reduction. At present, 70% of carbon emissions are arising from the electricity generation. Apparently, the strategy for large carbon emission reduction is to gradually replace the existing coalfired electricity generation by natural gas. It is estimated that by 2020, natural gas will be used to generate 50% of electricity. This helps achieve the target of 50-60% carbon intensity reduction. However, the relevant capital investment and natural gas costs would be recovered from consumers.

Although the use of natural gas would significantly reduce carbon emissions at the electricity generation 'supply' side, it does not reduce the electricity consumption or 'demand' side. Currently, 90% of the total electricity is consumed by buildings. The commercial and residential building sectors account for 65% and 27% of the electricity respectively. As such, the primary direction for achieving the 2030 target reduction should aim at saving energy used in buildings. This article briefly reviews the current energy saving initiatives for reducing the electricity consumption in buildings in response to the targeted carbon emission reduction.

Legislative Initiatives

Around 65% of the total electricity is consumed by commercial buildings. Enhancing the thermal transfer standard of commercial buildings is one of the most important measures for reduction of carbon emissions. The Building (Energy Efficiency) Regulation aims at reducing solar heat gain through building envelopes, thus saving electricity used in air-conditioning. Roofs and external walls of hotel and commercial buildings must attain the specified overall thermal transfer value (OTTV) according to the code of practice for OTTV. The OTTV standard was tightened in 2011 and was also extended to residents' club houses in 2015. However, for further cutting down the solar heat gain, the current OTTV standards must be tightened. In addition, the OTTV code is only applicable to new buildings and existing buildings are not required to upgrade to the latest OTTV standard.

Residential buildings account for around 27% of the total electricity. Enhancing the thermal transfer standard of residential buildings is also one of the important measures for reduction of carbon emissions. In this regard, Guidelines for Energy Efficiency of Residential Buildings was promulgated in 2015 to control the residential thermal transfer value (RTTV) of external walls and roof and also promotes natural ventilation design for reducing electricity used in air-conditioning. Same as the OTTV, this guideline is only applicable to new buildings and there is no requirement for existing buildings to upgrade to the latest RTTV standard.

Enhancing the energy efficiency of building service installations is one of the important measures for effective reduction of carbon emissions. The building energy code sets out energy efficiency standards of air conditioning, lighting, lift and escalator and electrical installations in both new buildings and existing buildings when carrying out major retrofitting works. In addition, the energy audit code requires all existing commercial buildings to conduct energy audits in respect of four specified types of building services installation every 10 years. While the energy audit normally provides recommendations to improve energy efficiency, the current code does not have a mandatory requirement for the building owners to carry out the improvement work according to the latest standards.

It is also important to help the public choose the most energy efficient electrical appliances. Under the energy efficiency labelling scheme, five types of prescribed appliances are mandatorily required to provide an energy label to show the energy efficiency of the appliance. This scheme currently covers refrigerators, dehumidifiers, room airconditioners, washing machines and fluorescent lamps which only account for 60% of electricity consumption in residential buildings. For further energy reduction, the current mandatory scheme must cover more different types of electrical appliances.

Environmental Initiatives

A number of green building assessment methods are available such as the LEED, BREEAM and Three Stars. The predominant method in Hong Kong is BEAM Plus, covering new buildings, existing buildings, interiors and neighbourhood. The green building rating provides an objective assessment of a building's overall performance, including the energy use. However, there is a lack of verification between the designed and actual performances.

Building energy benchmarking is an important tool for developers/building owners to reconcile the actual energy performance and the assumption made during the design stage. The Benchmarking and Energy Saving Tool developed by the Hong Kong Green Building Council (HKGBC) provides an online tool for owners of existing commercial, office and retail buildings to measure and compare their energy consumption to market peers and to identify potential energy improvement measures to enhance performance. Upon completion of benchmarking, energy performance certificate, label rating and specific energy efficiency improvement recommendations will be provided.

Using green building products is a way to improve the overall environmental performance of a building. The Green Product Accreditation and Standards is a local labelling scheme to certify greener building products, materials and components, currently covering 20 product categories. In addition, the Carbon Labelling Scheme provides carbon footprint information of construction products for users to make informed decision. At present, the scheme covers cement, reinforcing bar and structural steel only.

Economic/Financial Initiatives

To enhance the built environment, the HKSAR Government provides gross floor area (GFA) concession scheme for private developers to invest in innovative and green new buildings. Green features, which adopt a holistic life cycle approach, maximise renewable resources and green materials, reduce construction waste and minimise the energy consumption, are exempted from gross floor area calculations. The concession is currently capped at 10% of the total gross floor area of the development. This creates a good incentive for developers to pursue green buildings. At this moment, the amount of GFA concession is same for all projects even though they achieve different green building assessment ratings.

On the other hand, a large number of existing old buildings were designed and constructed before the introduction of various environmental related measures. Most of these buildings cannot achieve a comparable high energy performance as new buildings. In order to assist existing building owners in carrying retrofitting works, with effect from 1 January 2018, new or existing buildings that have achieved bronze rating or above under BEAM Plus are eligible to register under the Energy Efficiency Registration Scheme for Buildings. Capital expenditure incurred in respect of renewable energy and efficient building installations is allowed for tax deduction to be claimed in full in one year instead of the current time frame of five years. In addition, the two local power supply companies, CLP Power and HK Electric, have set up the "CLP Eco Building Fund" and "HK Electric Smart Power Fund" to subsidise existing residential buildings and ancillary facilities to carry out energy efficiency enhancement works.

In Hong Kong, tenants typically pay a flat management fee, irrespective of the electricity being actually used. The Green Tenancy Driver developed by the HKGBC promotes collaboration between the landlord and tenant to create a sustainable working environment. Under the green lease arrangement, energy usage data are shared between the landlord and tenant to increase the scope for enhancement and behavioural change. Cost savings through more environmental operation are fairly split between the landlord and tenant so that both parties would benefit from adopting green measures.

Social Initiatives

The Green Building Award organised by the HKGBC provides recognition to building projects with an outstanding performance in sustainability. These exemplary projects demonstrate the innovative green building designs and practices to building professionals.

The Ways Ahead

The Paris Agreement is an international agreement signed by most countries. Hong Kong has an obligation to achieve the targeted carbon intensity reduction by 2030. Besides using less coal in electricity generation, the ways ahead are to strengthen and implement various initiatives so as to significantly cut down the energy consumption in buildings. This would require the collective effort of the HKSAR Government, relevant building professionals and the public.
