Extension of Government Leases Ordinance : the Ordinance took effect on 5 July, ensuring that leases will be extended where there is no right of renewal. This covers a significant number of expiring leases in general residential, commercial, and industrial situations, on or after 5 July. Writing in her blog on 7 July, the Secretary for Development, Ms Bernadette Linn, JP, said the ordinance upholds the land policy made in July 1997 (pix 2a) and simplifies arrangements to extend land leases. I was videotaped welcoming the Ordinance on behalf of the HKIS (pix2b), for the certainty it gives and confidence it instils in the land and property markets.

It will help in redeveloping adjoining lots and establish a "Support Service Centre for Minority Owners under Compulsory Sale", which will better protect owners' rights. I reiterated these views later on a Radio Television Hong Kong phone-in radio programme.

# Land surveyors keep feet firmly on ground

No other field of surveying has been affected as much by technological advances over the past 40 years.



To trace the history and development of land surveying and the Land Surveying Division, is to track the rapid and fascinating growth in technology and how it has muscled its way into being indispensable to the work.

But these ever-increasing levels of accuracy, diminishing degrees of tolerance and advances in efficiency are not without the potential for the absurd or ridiculous. Both Sr Sung Hon-kwong and Sr Kevin Sung Man-hin are keenly aware of where these can, and do, occur, as they are of old-school values handed down from generation to generation, father to son, that keep land surveyors grounded.

Sr Sung, who retired in 2012 as Chief Land Surveyor at the Lands Department, left a Post Office job for the great outdoors. He completed his surveying assistant (Class III) post as a trainee in two years in the 1970s.

"I liked how the job allowed me to work outdoors, I liked the field work, determining the position, distance and elevation of various points on a piece of land," Sr Sung said. "That's how we drew accurate maps in the old days."

He also liked the routine: collecting equipment from the office, heading out for field work—not only on roadsides where people often saw them, but also up mountains and other inaccessible places—then "back with data and measurements before lunch and spending the afternoon in the office processing and calculating it all".

When the Government began its policy to localise the Civil Service, Sr Sung saw a chance to step up from technician to surveyor. He won a scholarship and went to the United Kingdom to study a surveying degree, before Hong Kong offered them. On returning, he completed his qualifications and in 1984 became a member of the Royal Institution of Chartered Surveyors (Hong Kong Branch) and the Hong Kong Institute of Land Surveyors (HKILS).

There is a strong argument that the pioneering spirit of the local and expatriate land surveyors who began the HKILS in 1976 continued in the Land Surveying Division of the HKIS. They got the ball rolling in 1977 on the first land surveying laws in Hong Kong, so vital in regulating the definition and demarcation of parcel boundaries. The Land Surveying Ordinance took effect on 15 January 1996.

When the HKIS was formed, Sr Sung was asked to join—and thus held memberships in all three bodies while Government endorsement no doubt persuaded the HKILS to amalgamate with the HKIS, which finalised on 1 April 1991.

Sr Sung Hon-kwong was at the time—in his own words—"a small potato, a newcomer"; still years away from his 2006–9 tenure as Chair of the Division, which at last count had 374 Corporate Members.

"I've only a sketchy memory of the exercise," he said.

# **Critical mindset**

In these critical foundational years, the Land Surveying Division established the mindset that has continued, to stay ahead of the curve in knowledge and skills, boosted by the then Hong Kong Polytechnic's starting a land surveying degree in 1991.

"There were only six areas when I entered the profession: topographic, cadastral, engineering, geodetic and hydrographic surveying as well as photogrammetry and remote sensing," he said.

There are now ten, the growth driven by technology, including building information modelling, geospatial information and technology, and utility surveying.

The manual-muscle-and-mind of the old days has all but yielded.

"We copied data down by hand because the devices either didn't display them or couldn't save. When I began, electromagnetic distance measuring equipment was the newest thing—imagine, needing only to click a button to measure the distance from the 'Star' Ferry in Tsim Sha Tsui to Central! Fantastic!" Sr Sung said.

"Later, new software made data processing even easier."

Making charts was a many-stepped, manual process:

"After calculating the data and figures, we had to add symbols and place names on separate transparent sheets before a positive film could be produced for plate printing. But less than 10 years after I entered the industry, software handled calculations and printed everything. Our role was reduced to editing. And nowadays, with the land information system, digital aerial cameras and unmanned aerial vehicles collect data and update maps with enhanced accuracy.

"The theodolite had the most impact on my field work, but before I retired, the global positioning system made things so much more accurate."

## **Better, faster**

But high technology has been at the core of Sr Kevin Sung's young career. Poised to take up construction studies in the UK, he baulked and had a father-son heart-to-heart.

"It was the first time we exchanged views about surveying—I'd known little about his job except that it had to do with maps," Sr Kevin Sung said. "He suggested it may be an option."

Sr Sung was surprised when Kevin decided to pursue land surveying: "I rarely discussed about my work with him and tried not to influence his thoughts about study or career aspirations. Well, he never expressed any interest before!"

Sr Kevin Sung returned to Hong Kong, read for a BSc (Hons) in Geomatics (Land Surveying) at the Hong Kong Polytechnic University, graduated in 2015 and joined the Government, where he received two years' post-qualification training in land boundary and geodetic surveying. He qualified as a land surveyor in 2019, and since has been working on rotation in the Lands and the Highways Departments and others, where engineering projects have familiarised him with many advanced surveying technologies like mobile mapping systems (MMS) and laser scanners and the Satellite Positioning Reference Station Network.

"Advancements in technology bring land surveyors

new ways to carry out our technical role and to do things that couldn't be done before," Sr Kevin Sung said.

"Street-level MMS, measuring more than one million points per second, speeds the process and saves time. Drones, new when I began, have advanced greatly and have shortened a one-to-two week field survey to one-to-two days.

"But speed, efficiency, volume of data bring complications: how best to analyse them all and present them? Too much data frustrate or confuse clients," Sr Kevin Sung said.

Clients are a broad range of private and public interests: digital maps produced and maintained by land surveyors are critical to construction firms' operations; it is only with land surveyors' confirmation of boundaries that any resumptions can proceed, old districts redeveloped, or historical buildings revitalised.

"Boundaries still require land surveyors getting their feet dirty," Sr Sung said, "and then attending conferences with relevant departments, like Highways, Water Services and Drainage Services, should they be affected." The fact is land surveyors are "there to support: wherever help is needed, they are there".

## **Ground underfoot**

"A million points of data per second, tolerances of 5mm versus 2mm ... it isn't worth the effort unless extreme accuracy is called for. Traditional principles like economy of accuracy still prevail—as does that allimportant rule of double-checking measurements: selfchecking is a cornerstone. Re-checking procedures thoroughly avoids mistakes," Sr Sung said. "Of course, some old ways have surrendered to new, such as position triangulation."

These words have a familiar ring for Sr Kevin Sung.

"My father taught me to be thoughtful when dealing with and analysing a lot of data. For the sake of accuracy, double-check calculations, learn to be patient and have a keen eye for detail," he said. "He was never a 'tiger dad' but once I decided on land surveying, he encouraged me, supported me, and while I admit feeling pressure over his career, his success and achievements, I used it to drive me gave me a lot of guidance on professional exams, submissions and interviews."

Education, passing on the formal and informal tricks of the trade, was a cornerstone of Sr Sung's work at the Land Surveying Division.

"Promoting land surveying was always top of the agenda, so as the Division Chairman I made it a point to be on our booth at the Hong Kong Polytechnic University career expo every year," Sr Sung said. "It's the only institution providing bachelor's degrees in land surveying, so we must be there to tell aspiring land surveyors what it is and what we do."

The chairmanship took Sr Sung in many directions and places, but always with the aim of promoting land surveying.

"Being Chairman was never in my plan but, frankly, the experience was eye-opening. I represented the HKIS at overseas conferences in Sweden and Bali. Some regional or cross-strait associations took turns to organise annual meetings, so I have been to Beijing, Taiwan, Macau, and Guangdong: it was useful seeing how professionals from the world perform and work."

# The vital generation

As land surveying continues to be a dynamic field, driven further by the possibilities of new technologies it was vital for the younger generation in particular to explore these.

"See how they can be applied to our work, to contribute to clients both public and private," Sr Kevin Sung said. "For instance, BIM has been around for a decade but only popular in our industry over the past few years. Keep learning, adding to your skills and knowledge; I enrolled in an MSc in Geomatics (Geographic Info Systems) in 2022 to better do my job."

Both men said the value of Division-run Continuous Professional Development courses and events for keeping up to date cannot be underestimated. Part of their importance is in "giving us a better understanding of our industry, even when experts' talks on new technology and their application may not touch our day-to-day work", Sr Kevin Sung said, "since there was little chance that any one land surveyor would specialise in more than three or four of the present 10 fields in their career".

Sr Sung's advice is simple: "Embrace a stable path and stay hungry for knowledge. Develop a serious and responsible manner at work, maintain good work relationships"—and to the HKIS and those in practice—"Always keep the young generation in mind. Offer them opportunities and help whenever needed."

# 土地測量師 踏實地幹實事

過去 40 年,沒有其他測量領域較土地測量般因科技進步有更深影響。

追溯土地測量及土地測量組的歷史和發展,等同 追蹤科技快速而令人著迷的發展足跡,以及它如 何變得對工作不可或缺。

但不斷提高的精確度、不斷降低的容許誤差程度, 以及日益提升的效率,仍然有可能出現不合理或 荒謬的情況。宋漢光測量師和宋文軒測量師兩父 子,將土地測量師腳踏實地的傳統價值薪火相傳, 二人已察覺到上述的情況可能會發生,而且確實 發生了。

宋漢光測量師於 2012 年從地政總署總土地測量師 一職退休。早年,他辭去了郵局工作,轉而投身 戶外的測量工作。在 1970 年代,他以實習生的身 份,花了兩年時間完成測量助理(三級)的培訓。

他表示:「我喜歡這份戶外工作,可以實地工作, 確定一塊土地各點的位置、距離和高度,這就是 昔日繪製精確地圖的方法。」

宋漢光測量師喜歡這種日常工作的工序:到辦公 室拿取工具,前往實地工作。除了到大家經常看 到的路邊工作外,他還會走到山上及其他人迹罕 至的地方工作。然後「在午飯前回到辦公室,並 利用下午處理和計算所有上午收集得來的數據和 測量結果」。

當政府開始推行公務員本地化政策時,他看到從 技術人員晉升至測量師的機會。他獲頒獎學金, 前往英國進修當時香港仍未開辦的測量學位課程。 回港後他考取專業資格,並於1984年成為英國皇 家特許測量師學會(香港分會)和香港土地測量 師學會的會員。

香港土地測量師學會於 1976 年由一批本地和外籍 土地測量師創立,並於 1977 年建議引入法定的土 地測量制度,其對規範地界的定義和劃分至關重 要。他們的開拓精神在香港測量師學會的土地測 量組中延續下去。《土地測量條例》於 1996 年 1月 15 日正式生效。

當香港測量師學會成立時,宋漢光測量師獲邀加入,自此成為三個專業組織的會員。而政府的正式 認可和支持無疑推動了香港土地測量師學會與香 港測量師學會合併,合併工作於1991年4月1日 完成。

宋漢光測量師謙稱當時是「一個小人物、一個新 人」,距離他於 2006 至 2009 年期間擔任土地測 量組主席還差一段時間。根據當時的資料顯示, 土地測量組共有 374 名正式會員。

他説:「對於兩個學會的合併情況我只有粗略 記憶。」

# 思辨能力

在這重要的奠基歲月中,土地測量組建立了持續 保持知識和技能領先的心態,香港理工學院於 1991年開設的土地測量學位課程更將這種精神發 揚光大。

他稱:「當我入行時,土地測量只涵蓋六個範疇: 地形、地籍、工程、大地測量和水文測量,以及 攝影和遙感測量。」

現在因科技推動而增至十個範疇,包括建築信息 模擬(BIM)、地理空間資訊和技術,以及地下管 線測量。

過去土地測量的體力勞動和腦力工作,到了今天 幾乎已被取科技取代了。

宋漢光測量師説:「以前我們用人手抄寫數據, 因為裝置不能顯示或者無法儲存數據。當我剛入 行時,電磁測距儀是最新的設備。想像一下,只 需按一下按鈕,就可以量度從尖沙咀天星小輪到 中環的距離,太棒了!」

其後,新型電腦軟件使數據處理變得更加簡便。」

過去,製作圖表是一個多步驟的人手處理程序:

「計算數據和數字後,我們必須在另一張透明膠 片上加上符號和名稱,然後才能製作用於製版印 刷的正片菲林。但我加入這行不到10年,軟件就 可以處理計算並列印所有內容。我們的工作簡化 了,變成主要負責編輯測量圖表。如今,有了土 地資訊系統、數碼航空相機和無人機拍攝,可以 收集更準確的數據並更新地圖。 「經緯儀對我的實地工作影響最大,但在我退休 之前,全球定位系統使測量更加準確。」

## 更好、更快

但是高科技一直是宋文軒測量師年輕職業生涯的 核心。在準備留在英國學習建築時,他猶豫不決, 於是和父親來了一次促膝談心。

宋文軒測量師説:「除了知道父親的工作與地圖 有關之外,我對他的工作所知甚少。這是我們第 一次就測量業交換意見,他稱測量業可以是其中 一個選項。」

當文軒決定修讀土地測量時,他父親感到驚喜: 「我甚少和他討論我的工作,亦盡量不想影響他 對學業或事業抱負的想法。他從來沒有表示自己 對土地測量感興趣!」

後來文軒回港,在香港理工大學攻讀地理資訊學 (土地測量),並於2015年獲頒(榮譽)理學 士學位之後加入政府工作,接受兩年地界及大地 測量的執業培訓。他於2019年獲取土地測量師 資格,此後先後在地政總署、路政署及其他部門 輪調工作。而各式各樣的工程測量項目使他有機 會熟習許多先進的測量技術,如移動測繪系統 (MMS)、激光掃描儀和衛星定位參考站網。

宋文軒測量師表示:「日新月異的科技為土地測 量師提供全新的方法來履行技術職責,並且能夠 完成昔日無法執行的任務。」

「車載移動測繪系統每秒可蒐集超過一百萬個點, 加快數據收集流程並節省時間。我剛入行時,無 人機還是一種嶄新科技,到現在已大為改進,並 將原先一至兩星期的實地測量工作,縮短為一至 兩天便完成。

宋文軒測量師稱:「但速度、效率、數據量亦伴 隨複雜問題:如何以最好的方法分析及描述數據? 太多的數據讓客戶感到懊惱或迷惘。」

客戶涉及廣泛的私人和公眾利益:土地測量師製 作和維護的數碼地圖,對建築公司的運作至關重 要。只有土地測量師確認邊界後,才能展開任何 土地收回、舊區重建或歷史建築活化的工作。

宋漢光測量師稱:「確定土地界線仍需土地測量 師親力親為,然後與路政署、水務署及渠務署等 相關部門開會,以防其受到影響。」事實上,土 地測量師「隨時提供支援:有需要協助,他們就 在左右」。

## 腳踏大地

宋漢光測量師説:「每秒一百萬個數據點,5毫米 與2毫米的公差……除非對精準的要求極高,否 則不值得付出過多的努力。適度的規模所產生的 最佳經濟效益等傳統原則仍然普遍運用,仔細複 查量度數據這重要規則亦然:自我檢查是基石。 重複徹底檢查程序有助避免錯誤。當然,一些舊 方法已經被新方法取替,例如三角定位測量。」

這些話對宋文軒測量師來說耳熟能詳。

他說:「爸爸教導我在處理和分析大量數據時要 深思熟慮。為了準確,應再次檢查計算結果,學 習保持耐性並注重細節。我必須承認爸爸的事業、 他的成功和成就使我感到壓力,但我借此激勵自 己。他從來不是一位『虎爸』,當我決定從事土 地測量時,他鼓勵我、支持我,還在專業考試、 提交論文和面試方面為我提供不少指導。」

教育、傳授正式和非正式的行業技巧,是宋漢光 測量師在土地測量組工作的基石。

他指出:「推廣土地測量一直是首要議題,因此 身為土地測量組主席時,我每年必定造訪我們於 香港理工大學職業博覽會設置的展位。理工大學 是唯一提供土地測量學士學位的院校,因此我們 必須告訴希望成為土地測量師的學生,什麼是土 地測量及土地測量師的工作。」 主席職位讓宋漢光測量師走遍各個方向和領域, 但始終以推廣土地測量為目標。

「擔任主席是因緣際遇,坦白説,這經歷卻令我 大開眼界。我曾代表香港測量師學會出席於瑞典 和峇里島舉行的海外會議。而一些地區或兩岸學 會輪流舉辦的年會,讓我有機會到訪北京、台灣、 澳門和廣東。看看世界各地的專業人士如何執行 工作,實在令我獲益良多。」

# 活力的一代

由於土地測量仍然是一個充滿變化的行業,在新 技術的推波助瀾下,探索這些技術對年輕一代來 說至關重要。

宋文軒測量師説:「了解如何將這些技術應用到 我們的工作中,為公營和私營客戶作出貢獻。例 如,建築信息模擬技術已推出了十年,但只是在 過去幾年才在我們這個行業流行起來。你需要不 斷學習,強化技能和知識。為了做好我的工作, 我於 2022 年攻讀地理資訊學(地理資訊系統)碩 士課程。」

二人表示,土地測量組舉行的持續專業發展項目 和活動,對緊貼最新行業發展的價值不容小覷。 這些課程和活動當中的重要之處,正如宋文軒測 量師説:「在目前 10 個土地測量範疇中,幾乎沒 有任何一位土地測量師在其事業生涯中能有機會 專注於三至四個以上範疇,專業講者談論的新技 術及其應用,大多不會觸及我們的日常工作,但 至少可以讓我們加深了解行業。」

宋漢光測量師的建議很簡單:「走一條穩妥的路, 保持對知識的渴求。在工作中培養認真負責的態 度,建立良好的工作關係。」而對香港測量師學 會和執業者來說,「應時刻關心年輕一代,給他 們機會,並在需要時伸出援手。」

# The HKIS Awards 2024 Results Announcement

The results of the HKIS Awards 2024 were announced at the HKIS Awards Presentation Ceremony on 12 July at the Hong Kong Ocean Park Marriott Hotel. With the theme of "Surveying for a Sustainable Future," the Awards aimed to recognise the efforts of Hong Kong surveyors to create a sustainable future, provide a platform for them to showcase their exceptional work, and promote the surveying profession.

Nine Past HKIS Presidents were invited to serve in the First Screening Committee, while the esteemed Jury Panel was formed by 11 government officials and industry leaders. 

# HKIS "Create Your District" Competition 2024

The HKIS launched its "Create Your District" Competition since 2017 to promote the surveying industry to Hong Kong's younger generations. While the 2024 competition commenced in May, the competition aimed to encourage students to explore the rich history, cultural traditions, and development of the To Kwa Wan area of the Kowloon City, as well as to demonstrate their creativity through story maps.

#### 1. Competition Workshop & Guided Tour

The Competition Workshop & Guided Tour was successfully held on 13 July. HKIS Senior Vice-President and Chairman of the Competition Organising Committee Sr Robin LEUNG Chi Tim, Director (Planning and Design) of the Urban Renewal Authority Ar. Lawrence MAK, Director (Building Rehabilitation) of the Urban Renewal Authority Sr Peter WONG, and General Manager (Building Rehabilitation) of the Urban Renewal Authority Sr Louis LEE attended the workshop to share their views on planning To Kwa Wan area of the Kowloon City with participating students and highlighted the important role that surveyors play in urban planning, redevelopment, rehabilitation, and revitalisation.

Later, Robin and members of the six divisions joined the guided tour to visit various places in To Kwa Wan and shared their surveying knowledge with over 200 secondary school students and teachers from 60 groups ranging from Forms 2 to 5. The tour provided a multidimensional introduction to the region's economic and social status, as well as its geographic, land, and ecological resource advantages. It also goes a long way towards exploring the possibility of combining the characteristics of the historic Kowloon and modern Kai Tak development areas.



#### 2. Story Map Training Workshop

The story map training workshop was successfully held from 22-24 July. Students learned to create story maps during those three days. Afterwards, contestants had to illustrate a designated area of Kowloon City, and depict the area in an ideal state from a surveyors' point of view via story maps.



# Interim Reports from HKIS Committee/ Forum/ Working Group/ Task Force/ Organising Committee

# Administration Committee Chairman: Sr Raymond Kam Ka Fai

The Administration Committee is responsible for monitoring and overseeing the effectiveness and efficiency of the HKIS Secretariat's operations including human resources management, operations management, office accommodations, and matters related to office administration. To ensure the smooth and efficient running of the Administrative Office, the Committee reviews the use of office facilities and equipment (including hardware and software) and makes recommendations to the General Council/Executive Committee on repair and replacement works.

The HKIS Beijing Office relocated to a new location in July at the landlord's request. Its new address is Room B10, 8/F, North Tower, CP Centre, CBD Core Area Z14, 10 Guanghua Road, Chaoyang District, Beijing, China (Postal Code: 100026). After considering recommendations from the Mainland Affairs Committee and Beijing Forum, the GC agreed to move to the new venue on a 13-month lease that will expire in August 2025.

# BIM Working Group Chairman: Sr YY Yip

The BIM Working Group held the HKIS Digitalisation Round Table Forum on 7 December 2023 at the JC Cube, Tai Kwun. It featured 15 speakers on three topics and was moderated. The issues explored were:

- 1. The Implications of Contractual BIM
- 2. The Problems Stemming from the Parallel BIM to Digital Twinning Process
- 3. Challenges and Opportunities for Surveyors in the New Technologies Era

The event attracted over 150 in-person participants. Mr David Lam Chi Man, JP, DevB Under Secretary, served as the Guest of Honour, while then-HKIS President Sr Paul Wong delivered the welcome speech. Speakers from various sectors shared insights into the abovementioned topics and provided a wealth of valuable experiences and inspirational ideas.

In 2024, the Group will organise a new forum on 5 December to discuss contractual BIM and GBP BIM submissions, which are currently hot topics for most surveying stakeholders.

On 2 February, the Group hosted an exchange session on DevB's BIM Roadmap for Building Plan Preparation and Submission. Ms Jenny Choi Mui Fun, JP, Deputy Secretary for Development (Planning & Lands) 2, and Ms Cheung Hoi Shan, Principal Assistant Secretary for Development (Planning & Lands) 3 of DevB introduced the draft roadmap and exchanged views with HKIS members. The Group subsequently provided a consolidated response.

Additionally, on behalf of the HKIS, it responded to the Construction Industry Council's (CIC) plan to set up a scheme for the HKIS to help certify members with BIM manager/coordinator qualifications. Lists of "Surveyor BIM Pro" and "Surveyor BIM Co" will be formed and Group members on them will be assessed/endorsed by the CIC as its CCBM or CCBC, respectively. A CPD has been arranged for 2 September 2024 to explain the details.

# Building Policy Panel Chairman: Sr Kenny Tse

- 1. The key tasks of BPP in 2024 include:
  - 1.1 Advising on subdivided unit (SDU)

- 1.2 Advising on setting up a building repair authority and mandatory sinking fund
- 1.3 Commenting on minor UBW policy
- 2. In response to the Government task force's directives on addressing the SDU issue, the BPP submitted a paper titled, "Resolving Sub-divided Unit (SDU) Problems," to the Government on 16 May. It also held a press conference on 17 May to publicise the perspectives and recommendations outlined in the paper, which broadly encompassed the BPP's suggestions on the minimum SDU habitable area, essential standards for fire safety, lighting and ventilation, headroom, waterproofing, drainage, imposed loads, etc. Furthermore, the paper offers additional considerations for registering SDUs, enforcing and eradicating SDUs in poor condition, transitional arrangements, and public education.
- 3. The final stage of the ESH building plan submission for GBP and A&A works was implemented on 30 June. A CPD on ESH for HKIS members, hosted by the Buildings Department (BD), was held on 18 March and attracted over 400 registrations.
- 4. DevB invited BPP and BSD representatives to a meeting on 22 April to discuss elderlyfriendly building designs in response to the Government's Policy Address 2023. They were informed that the BD would conduct a comprehensive review of the design manual for barrier-free access, while elderly-friendly designs will be incorporated into the revised manual. The BPP and BSD will monitor the manual's development and provide input and advice when appropriate.
- 5. In response to an invitation from the Urban Renewal Authority (URA), the HKIS reviewed the trial version of the Guidelines and Templates for Preparing Maintenance Manuals for Residential and Composite Buildings. The URA wrote the trial version to promote the preventive maintenance of existing buildings. The HKIS recognises the maintenance manual's role in preserving structural integrity and planning for major

repair and renovation works. To that end, the BPP, BSD, and PFMD jointly wrote a letter summarising the HKIS's comments on the trial version of the Guidelines and submitted it to the URA on 28 June.

- 6. On 15 April, the HKIS issued a press release offering its perspective on the unfortunate fire that occurred at New Lucky House in Jordan. The release outlined several recommendations aimed at preventing similar incidents in the future including expediting amendments to the Fire Safety (Buildings) Ordinance; conducting a comprehensive review of penalties for noncompliance with building orders, directions, and notices; enhancing public education on fire safety; etc.
- 7. In reference to the public consultation on the proposed roadmap for BIM building plan submissions in 2029, the BPP has contributed its comments through the HKIS BIM committee's letter. It highlighted the challenges associated with BIM submissions for A&A works and emphasised the need to align with other Government departments' BIM submission requirements.

Students had the opportunity to showcase their creativities, explore the work of surveyors, and prepare for their future studies and careers. As part of this year's competition, the Urban Renewal Authority served as the HKIS's competition strategic partner. Over 200 students comprising 63 groups from 40 schools – a new record – enrolled in the competition.

In July, contestants were invited to join the competition workshop, guided tour, and story map training workshop. These sessions provided them with a multidimensional introduction to the economic and social status, geographic features, land resources, and ecological advantages of the To Kwa Wan area. Participants also familiarised themselves with the work of surveyors in each division.

Shortlisted finalists will be invited to present their work to a jury panel in October 2024 and the awards presentation ceremony will occur on 16 November 2024.

# Land Boundary Working Group Chairman: Sr C K Lau

- 1. Technical Notes for Land Exchange: Draft notes have been prepared. The GPD, LSD, PDD, and PFMD have circulated them to each Division for its input.
- 2. The Survey & Mapping Office (SMO) has provided more information (such as Aerial Photos of 1924 from the UK).

To allow for the public inspection of historical Government rent rolls, the SMO is still negotiating with the District Lands Offices.

3. On 21 June, the Working Group arranged with the General Manager, Mr KF Pang, a CPD that featured a visit to the Land Registry Archive at the Shatin Government Offices. Members were very excited about examining the Archive and Land Registry Deputy Manager Mrs Cindy Lam and her team happily obliged the delegation. They explained to members the Archive's records, some of which were over a century old and very useful for cadastral surveys including those for establishing boundaries, titles, registrations, etc.

In turn, members shared their professional knowledge of the uses and origins of the land records with Registry staff. Both parties were enlightened.

4. During a visit to the SMO on 26 June, LSD representative Sr Winnie Wong Wing Yin, who works for the SMO, showed how her department's online system can search for land and survey information. The HKIS delegation had requested a demonstration of it.

## Mainland Affairs Chairman: Sr Dr Lai Yuk Fai, Stephen, JP

The Mainland Affairs Committee was formed to gather every Division's requests on CEPArelated issues before raising them with the relevant Hong Kong and Mainland Government bodies or officials and to encourage each Division to establish and maintain close dialogue with its Mainland counterpart. The Committee also explores collaborative opportunities with Mainland institutes and universities. This year, it held meetings on 6 March and 17 June.

#### **Mainland Forums**

Another duty of the Committee is to promote the surveying profession and enhance the HKIS's image in China. As a frontline organisation for implementing such a task, it selected the following members to preside over the Mainland Forums.

The Forums will arrange different CPDs and gatherings to enhance the HKIS's relationship with its members and the relevant Mainland government departments/professional institutes in the abovementioned cities. Members may hereafter refer to individual reports on the Mainland Forums.

#### Visit to Beijing

To maintain close dialogue and strong relationships with the relevant Mainland ministries and counterparts, a 22-member delegation led by President Sr Francis Lam and Beijing Forum Chairman Sr Wu Yuk Lam visited Beijing from 19-22 May. The delegation met with officials of the Department of Ministry of Housing and Urban-Rural Development, Ministry of Natural Resources, and Hong Kong and Macao Affairs Office of the State Council. It also discussed with its professional counterparts ways to promote the surveying profession on the Mainland. For a detailed report, please refer to the May issue of *Surveyors Times*.

#### Visit to Shanghai

The Committee will arrange its annual visit to Shanghai from 1-3 August 2024 to meet government officials, counterparts, and HKIS members there.

#### 2024 Mainland and Hong Kong Construction Forum in Guangzhou

The Mainland and Hong Kong Construction Forum 2024 was held from 26-27 March in Guangzhou. Its theme was "Deepening the Collaboration of the Construction Industries on the Mainland and in Hong Kong, Building a High-Quality Guangdong-Hong Kong-Macao Greater Bay Area, and Taking Forward the Belt-and-Road Initiative Together". The Forum attracted over 800 industry practitioners from Guangdong, Hong Kong, and Macao. To promote Hong Kong's surveyors and surveying industry, the HKIS sent a delegation to the Forum and arranged one of its parallel sessions.

#### PASS Project

Funded by the Professional Services Advancement Support Scheme (PASS), a project, "The Hong Kong Surveying Profession in the Greater Bay Area: Opportunities and Challenges for Advancing Net Zero Projects and Properties in the Technological Era," started in 2022. It involves organising seminars or conferences and publishing the Smart Practices on Net Zero for Sustainable Built Environment and Surveyor Guidebook. Its first two half-day seminars were held on 23 June and 22 July 2023 at the Mira Hotel.

In addition, it held two one-day conferences with international and Mainland speakers on 13 and 27 July 2024 at the Cordis Hotel. They attracted over 500 participants.

# Modular Integrated Construction (MiC) Working Group

# Co-Chairmen: Sr Lee Hoi Tat, Nathan & Sr Ngai Chi Hang, Tim

The modular integrated construction (MiC) approach has been a focus of the local building industry starting with the construction of quarantine camps during the pandemic before expanding to transitional and public housing projects.

MiC is known to offer benefits such as shortened construction times, higher quality, improved site safety, and reduced waste. In June 2024, the MiC Working Group arranged visits to green building industry parks in Mainland China and 50 PDD, BSD, and QSD members joined them.

On the morning of 15 June, members visited the China Green Industrial Park, which is a factory that manufactured steel-structured MiC and public housing wall modules. China Green Industrial Park, located in Shenzhen's Shanwei Special Cooperation Zone, is one of China's most advanced modular smart manufacturing bases. Its efficient smart equipment "industrial robot welding team" can replace traditional manual operations and perform automated welding, thereby greatly improving efficiency. The products it manufactures include structural metal products, modular building products, containers, metal packaging containers, wooden products, bamboo products, fibreglass and glass fibre-reinforced plastic products, and lightweight building materials.

That afternoon, the delegation visited the China Zhongtian Green Building and New Materials Industrial Park, a factory that manufactures MiC concrete structures.

Apart from these visits, the MiC Working Group plans to review the following areas:

- 1. IPA submissions
- 2. Future MiC maintenance issues
- 3. Contractual arrangements and payment terms of MiC projects
- 4. Pros and cons of having MiC suppliers as direct Government suppliers

## New Standard Form of Building Contract Task Force Chairman: Sr Thomas Ho

The most recent edition of the *Standard Form of Building Contract – with Quantities* and *without Quantities* was published in 2006. Since then, industry practices and statutory requirements, including the use of e-platforms, adoption of BIM, revisions to the Arbitration Ordinance from Cap 341 to Cap 609, the forthcoming enactment of the Security of Payment Legislation, etc, have changed. All warrant a review of and updates to the Standard Form of Building Contract.

A new Standard Form of Contract, Sub-Contract, Supply Contract, and Sub-Subcontract will be drafted to include provisions that cover new elements such as SOPL, BIM, and collaborative approaches similar to NEC.

A task force comprising a steering committee; drafting sub-committee; and a working group with members from the HKIA, HKIS, HKICM, and ACQS will collect members' comments on the *Standard Form of Building Contract* and explore the requirements of the new standard form that were set up last year.

Five law firms were invited to tender in April. The winning law firm was appointed in June to draft the new *Standard Form of Contract*, whose anticipated release date is mid-2025.

### Production of Archive Video to Showcase the Contributions of HKIS/ Surveyors in the Development of Mainland China Task Force Convenors: Sr Robin Leung Chi Tim & Sr Raymond Kam Ka Fai

The video project that will showcase the contributions of HKIS Surveyors to the development of Mainland China is now complete. The project captured the work of pioneering surveyors who dedicated their time and efforts to share their professional knowledge with Chinese Government officials and academics on land and property development, which led to the Mainland's first-ever land auction.

The video was professionally filmed and edited to boast a polished, high-quality look and feel. It effectively communicates the unique experience of the HKIS's surveyors almost 46 years ago in their engagements with their Mainland counterparts.

The video will be a valuable asset for marketing purposes and showcasing the HKIS's values to industry stakeholders in Hong Kong and on the Mainland.

### Promotion Committee Chairman: Sr Thomas Ho

The objectives of the Promotion Committee are to explore ways to boost the surveying profession and improve the Institute's image. To achieve these objectives, the Committee adopted a "One Surveyor" concept instead of highlighting and splitting the surveying profession into six disciplines, as in the past. In the last year, the Committee revamped its marketing materials and produced uniform data for use in career talks with a tagline, "Broaden your surveying horizons, unleash your true imagination" (「放眼測量、開拓想像」), added to HKIS leaflets and PowerPoints. It also introduced the surveying profession and different surveying works under a development cycle, as well as published guidelines for members to access career talk materials.

To ensure consistency in the HKIS's career talks, some Career Talk Ambassadors comprising two members from each Division and YSG came together in January, with Sr Colin Wong as the convenor and Sr Dick Li as the vice convenor, to conduct career talks to secondary school students. As of this writing, the Ambassadors have held career talks at six secondary schools. The Committee also hosted a large career talk in October 2023 and joined a secondary school career fair in July. Both it and the Ambassadors will host a major career talk in October 2024.

The Committee joined the work experience programme under the Education Bureau's Business-School Partnership Programme, which is a continuing programme held every three months.

From July 2023 to March 2024, the Committee conducted a creative digital campaign, which included a short video showcasing the daily life of a surveyor and highlighting the benefits of working in the surveying industry. It also administered an online and street personality test to engage with its target audience and provide it with personalised career recommendations. On Facebook and Instagram, it briefed the public on the work of surveyors. The campaign has a total reach of 728,000 on Facebook and 283,000 on Instagram.

Other promotional activities, such as the composition of a corporate song to promote the HKIS through social media, extension of the online promotion campaign, posts on other social media channels, production of new souvenirs, advertisements on trams and buses, etc, were proposed for the General Council's consideration. ### Research Committee Chairman: Sr Dr Mei-yung Leung

The Research Committee initiates and devises research projects for the General Council's consideration. It also vets research proposals from each Division and recommends the best ones to the Executive Committee or General Council for its formal approval. The Committee last met on 7 May.

#### **HKIS-Funded Research**

Currently, there are six ongoing projects, two of which have submitted their mid-term reports and are close to completion. Three projects have been completed so far in 2024:

- RC1819/039: BIM Model Information Requirements for Quantity Takeoff
- RC1920/042: Market Research for Hong Kong Planning and Development Surveyors in Belt-and-Road Countries: Case Studies of Vietnam, Thailand, and Malaysia
- RC1920/043: Systematic Review of the Change Detection of Land Use and Land Cover Over Urbanised Areas Using Very High-Resolution Remote-Sensing Images

The completion reports for the above projects were uploaded to the HKIS website for members' knowledge enhancement.

Should a member have an idea for a research topic that may benefit the surveying profession and industry, s/he should submit it or a proposal to the relevant Division for its consideration.

#### **HKIS Outstanding Dissertation Awards**

To promote research excellence amongst surveying students, the Committee also organises the HKIS Outstanding Dissertation Awards, which comprise two categories: Outstanding Final Year Dissertation Awards for undergraduates and Dissertation/Thesis Awards for Postgraduate Students. The final results of the HKIS Outstanding Dissertation Awards 2023 and executive summaries of some winning papers were published in the February 2024 issue of *Surveyors Times* (<u>https://www.hkis.org.hk/archive/materials/category/ST\_02\_MED.pdf#24</u>). The 2023 Awards' presentation ceremony is scheduled for 30 July 2024 along with the HKIS Scholarship 2024 Presentation Ceremony.

The HKIS Outstanding Dissertation Awards 2024 are currently accepting nominations. All nominated dissertations will be assessed by appointed assessors



and their results should be announced by December 2024 or January 2025.

### Security of Payment Task Force Convenor: Sr Raymond Kam Ka Fai

The following is a brief summary of the SOPL.

#### A. Basic Information

- 1. The SOPL is intended to improve the cash flows of contracting firms that undertake construction work in Hong Kong.
- 2. It will not deal with construction workers' wages.
- 3. It will cover most construction work EXCEPT:
  - A&A work in the private sector unless its scale falls within the designated meaning, as stated in the SOPL;
  - (ii) renovation and maintenance work in the private sector, especially that for residential estates and buildings;
  - (iii) home decoration work; and
  - (iv) construction work at sites outside of Hong Kong, even if the work is undertaken by Hong Kong-based contracting firms or consultants.

- 4. The value of the construction work (the amount of the main contractor's engagement contract) exceeds HK\$5 million. All subcontracts including supply and consultancy agreements (engaged by the main contractor or sub-contractors) under the main contract, irrespective of tier and value, will be covered by the SOPL.
- 5. Consultancy agreements with values exceeding HK\$500,000 will be covered by the SOPL.
- 6. The SOPL will not cover loan agreements related to construction work. There are specific terms governing what these agreements mean, but bonds, advanced payments, etc, are not covered.

### B. Operation

- 1. The SOP draft bill was submitted to LegCo on 29 May and is expected to be enacted at around the second quarter of 2025.
- 2. There will be two stages of the SOPL's implementation. The first stage is its implementation in all public contracts, including those procured by 31 statutory and public bodies, and in the private sector except for payment disputes related to time extensions (EOTs) and delays or extensions of project completion dates.
- 3. The exceptions, as listed in A3 above other than (iii) & (iv), do not apply to public contracts.
- 4. The second stage will be implemented for all construction work including that in the private sector. This covers payment disputes related to EOTs or disputes over time delays or extensions for project completions. The time for implementation will be announced by the Secretary for Development.
- 6. Adjudicator nominating bodies (ANBs) are required. The HKIS is listed on the ANB Register that DevB maintains to implement its SOPP (Technical Circular (Works) No 6/2021 (5 October 2021)). The HKIA, HKIE, and HKIAC are also listed on the ANB Register. ANBs under the SOPL will presumably be maintained on the same register, which means the HKIA, HKIE, HKIAC, and HKIS are SOPL ANBs. More ANBs can be listed on the Register as long

as they meet certain admissions criteria that DevB sets.

- 7. The adjudicator shall be in recognised trainings organised by the ANB and is subject to its terms and conditions.
- 8. DevB will prepare and issue adjudication rules, codes of practice, practice notes, and conflicts of interest notices in relation to the establishment and running of ANBs, which are expected to have their own adjudication rules and codes of practice.

#### C. Key Features

- 1. The SOPL will focus on payments from upper and lower-tiered contracting and consultancy firms.
- 2. Payment includes that for work done, variation works, and claims for direct losses and expenses. In other words, the direct losses and expenses in relation to EOTs are included.
- 3. All payment applications must be answered within 30 days of the request and paid within 60 days. No contract provision may override this arrangement. However, all parties may agree on the number of payment applications that could be made within a contract agreement.
- 4. The time for an adjudicator to resolve a dispute is 55 days after it receives a notice of appointment, subject to extension upon the mutual agreement of the claimant and respondent.
- 5. Failure to pay the interim payment or adjudicated amount within the time stated in C3 above will give the claimant the right to suspend work or reduce its progress until it receives the full payment or adjudicated amount.
- 6. Prior to exercising the right listed in C5 above, the claimant shall give five days' notice to the respondent and site owner (whose name must be made known to all parties working onsite).
- 7. The suspension and delay so caused will not be subject to the imposition of liquidated damages, if any, to the claimant.
- 8. In the above, the claimant is assumed to be the lower-tiered contracting party, while the respondent would be the upper-tiered contracting party.

- 9. An adjudicator's determination on EOT is contractually binding.
- 10. During the adjudication process, all submissions by the claimant and respondent to the adjudicator should be known to all parties. Ideally, one party's information should be made known to the other party at the time of the payment application and assessment, but should not be produced for the purpose of adjudication.

### Sustainability Working Group Co-Chairmen: Sr Chiu Kam Kuen & Sr Kenneth Yun

The General Council formed the Working Group on Sustainability in January 2022 to promote the role of surveyors in achieving sustainability. Its terms of reference are:

- 1. To identify and consolidate the existing services of the different surveying divisions (including environmental, social, and governance) for achieving sustainability at the corporate and asset levels and financial sector.
- To explore new opportunities for surveyors to work on sustainability and assemble each division's existing standards or guidelines to promote the comprehensive role of surveyors in achieving sustainability.
- 3. To promote the HKIS's sustainability services on behalf of the surveying industry to the public, market, and Government.
- 4. To recommend, on behalf of the Institute, changes to the Government's sustainability policies, procedures, and legislation;
- 5. To consult with other professional bodies/ authorities/organisations on the promotion and development.
- 6. To form a Task Force to handle green building matters including:
  - a. Providing a platform to update fellow surveyors with information on current

green building developments in Hong Kong including, but not limited to, the organisation of green building-related CPDs.

- b. Providing a channel for HKIS members to leave feedback regarding current green building designs, assessments, and practices.
- c. Enhancing surveyors' green reputation in the construction industry.
- d. Promoting and advocating green development, buildings, and living.
- e. Promoting green building materials, construction, and financing in Hong Kong.

To commit to shaping a sustainable real estate sector through its professional services and performance, the Working Group has proposed issuing ESG (environment, social, and governance) objectives, which have been endorsed by the General Council and posted on the HKIS website. A leaflet, Charting a Greener Future with Surveyors, has been prepared to promote surveyors' role in sustainability and will be distributed when its design is finalised.

#### **Green Building Task Force**

The Task Force on Green Building has organised three CPDs so far in 2024 to promote the latest technologies in and experiences with green buildings, sustainability, and advancing net zero.

The Task Force publishes a bi-monthly column, "Green Corner," on Surveyors Times to update members on the work of the Task Force and other green organisations affiliated with the Institute including the Professional Green Building Council, BEAM Society Limited, and Hong Kong Green Building Council.

## Promotion

1. The 18 Districts Building Maintenance talks continued in To Kwa Wan on 18 July and featured questions about building maintenance and water leakage from attendees. The talks provided a great platform to educate the general public on the correct approach for handling building maintenance and promoting the HKIS's pilot scheme of expert determination to resolve water leaks, UBWs, and fit-out disputes by employing experts to help owners settle disputes. Expert determination can help owners resolve problems more effectively and economically. Future talks will take place in Kwun Tong and Shatin on 27 and 29 August 2024, respectively.



2. I represented the BSD as a juror for the Best Landscape Award organised by the Leisure and Cultural Services Department on 5 July. Among the hundreds of entries for new projects and existing buildings, the jury had to select outstanding and merit awards using the criteria of design, maintenance, sustainability, social interaction, etc. The award ceremony will be held on 4 October 2024. The BSD supports activities that will improve living standards by providing a healthy, safe, and desirable environment.





### Publication

 The BSD and QSD jointly reviewed the Standard Form of Contract for Design, Decoration, Repair and Maintenance, whose first edition was published in 2008. The aims of this review included adjusting the maximum contract sum that the Standard Form of Contract could apply and additional conditions for the design and introduction of the Expert Determination clause, which were in line with the HKIS's pilot scheme for expert determination. The revised edition should be published in early September 2024.

### Connection

1. The BSD arranged a roundtable discussion forum for over 30 younger and senior members on 5 July to discuss the building surveying industry's present and future SWOTS. The topics of discussion included how to attract

more students to study building surveying, opportunities in the Greater Bay Area, influence on the professional practice through the BSD's publications, manpower shortages in the private



sector, etc. Many useful suggestions were received during the discussion and the BSD will think and plan ahead for the opportunities and concerns in the short and long terms to uphold the BS profession.



2. The BSD and Professional Building Surveying Consultants Association of Hong Kong (PBSCA) have met with ArchSD's Property Services Branch twice a year over the past decade to maintain close dialogue between both sides. On 3 July, the Director, Assistant Director (PS), and senior management attended the most recent meeting to discuss various topics of mutual interest including technological developments, improvement of maintainability through better designs, heritage conservation schemes, and the procurement of building surveying services. It was a very constructive and useful venue for working hand-in-hand with the Government to foster development and improve the industry.



# Education

 As members already know, the BSD has organised many PSQL and CPD events throughout the years to provide training opportunities to its probationers and members. They number about 3-4 a month and cover site visits, regulations, professional practices, advanced technologies, etc. Sr Gigi Mok, Sr Peter Dy, Sr Ken Wong, Sr Paul Lau, Sr Benny Chan, and Sr Johnny Lau of the CPD event committee have worked very hard to organise these events for members and deserve thanks for their efforts. The BSD looks forward to seeing you at future events.



2. The HKIS organised a two-part conference, "The Hong Kong Surveying Profession in the Greater Bay Area: Opportunities and Challenges for Advancing Net Zero Projects and Properties in the Technological Era," on 13 and 27 July with Guest of Honour Ms Bernadette Lin, the Secretary for Development, and Secretary for Housing Ms Winnie Ho. Other well-known speakers from academia, private practice, and industry came to enlighten the attendees on their role in helping to achieve sustainable development. BSD Vice Chairlady Sr Carmen Lai joined a discussion panel to share her project experiences in the UK.

Moreover, a visit to bustling Lee Tung Street in Wanchai led by PFMD Vice Chairman Sr Louis Lee on 4 July provided the delegation with firsthand exposure to this urban renewal project's cultural and architectural richness. Embracing opportunities to collaborate and exchange insights with such esteemed entities not only enriched members' collective knowledge, but also nurtured stronger bonds that should fuel innovation and progress within the industry.

Empowering Urban Renewal: Mobilising Volunteer Surveyors to Expedite Urban Renewal in Hong Kong

The number of private buildings aged 50 years or older in Hong Kong has surged from 4,500 to 9,600 within the last decade with a mere 1,600 undergoing redevelopment. To expedite the city's urban renewal, LegCo agreed to lower the threshold for the proportion of owners who must agree to sell old private buildings to 65 percent.

In light of this, DevB recently requested that the GPD compile and provide two crucial lists – the "List of Scheduled Information Service Sessions with Assigned Surveyors" and the "List of Surveying Firms for Compulsory Sale" – to support the operations of the Dedicated Office of Supporting Services for Minority Owners under Compulsory Sale to safeguard the interests of such owners. The GPD seeks volunteer surveyors for this important initiative and encourages their nomination as long as they meet the following criteria:

- Must be a GPD member or fellow with at least five years of post-qualification experience.
- Must have actual experience of serving as a valuation expert or assistant to the valuation expert in at least one Cap 545 case.

Engaging in this volunteer initiative not only showcases your commitment to professional excellence, but also provides a unique opportunity for you to shape the real estate and surveying landscape in Hong Kong. Your involvement will also support the GPD and DevB and serve as a platform for showcasing your expertise in and dedication to this crucial sector of the city's economy. By participating, you help advance Hong Kong's urban renewal efforts, which ultimately help create a more sustainable and vibrant urban environment. Don't miss this chance to make a meaningful impact and be part of a collaborative effort that influences the future of surveying in Hong Kong.

#### The Reclamation of Three Runway System Project at Hong Kong International Airport

For the Reclamation of Three Runway System Project at Hong Kong International Airport, land surveyors' helped the project team during its different stages.

During the Tender & Procurement Stage:

• Providing accurate quantity estimations of reclamation fillings through 3D modelling.

During the Construction Stage:

- DCM Barge positioning using GNSS.
- Bathymetric surveying of artificial and shellfish reefs (design and deployment).
- Quality checks using the automatic GNSS system for movements and settlement monitoring

- Providing accurate quantity estimations of fill materials.
- Ensuring the interlocking and placing density of the seawall Accropode Unit by aerial photogrammetry.
- Providing 3D models through aerial photogrammetry and LiDAR.

One of the major achievements was being granted advanced operational permission to use SUA within the restricted flying zone and near an active airport. This involved much effort to coordinate with different stakeholders and overcome many challenges such as short daylight times, communications with air traffic control, rapid responses to GFS operations, etc. Hence, comprehensive planning was required.

The record of aerial images has greatly helped claim management teams' construction claim assessments, verifications, and confirmations of actual site progress in relation to delay events. It aids in the impact assessment of a delay event by providing solid evidence to retrieve earlier records and resolve disputes.

By regularly updating the 3D model to reflect the actual construction status, the project team could, if necessary, review the construction sequence if unforeseen circumstances, design changes, or adverse site conditions emerged. Such up-to-date data and feedback allowed the team to continuously refine its construction sequence.









#### <u>Sustainability Strategy in Road and Tree</u> <u>Inspection by Advanced Geo-spatial</u> <u>Technology</u>

A mobile laser scanning and imagery (MLSI) survey is an advanced surveying technology adapted to manage and monitor tree growth. The MLSI survey instrument consists of several main components: an inertial measurement unit (IMU), 360-degree LiDAR, high-speed panoramic camera, GNSS antenna, and receiver. These components are integrated into one instrument and work with each other. The instrument not only produces three-dimensional models almost instantly, but also provides data with high accuracy down to the cm level and could maintain its data quality for precise analyses.

The surveying instrument is installed on a vehicle using a car-mounting gear before it collects data. After driving the vehicle to an open-sky area, its operator performs static initialisation of its GNSS antenna to receive signals for positioning. Then the vehicle is driven forward and turned around for dynamic initialisation of the IMU. With specific signals on, the instrument is well prepared for surveying. The vehicle is then driven along the planned route and captures the scene by camera and laser scanner.

Back at the office, post-processing occurs. The data is geo-referenced and governed by control points. Afterwards, the protruding trees in the data are classified as 6-metre and 8-metre clearance zones relative to the ground levels of the carriageways. Eventually, the results are delineated on mobile platforms and survey plans for tree-pruning works.

This technology has many advantages compared to traditional sight inspection. It reduces manpower and transport, so as to achieve energy savings. Furthermore, with accurate data and limits, trees within the limits are trimmed to ensure safer conditions for road users, while those that lie outside the limits remain to protect the environment. Moreover, by conducting a survey twice a year, one can monitor protruding trees and track their changes using geospatial data. This helps other professionals develop strategies for protecting resources, landscape planning, and maintaining carriageways.




# **CPD** Highlights

### Visit to the Land Registry Archive

On 21 June, LSD Chairman Sr CK Lau led a delegation to visit the Land Registry Archive at Shatin Government Offices. Over 20 members joined this event.



Mrs Cindy Lam, Deputy Manager of the Land Registry, and her team hosted the delegation. During the visit, Land Registry staff introduced various land records including original land grant documents (e.g. land leases, block government leases, and new grants) dating back to the 1840s, along with memorial plans.



HKIS members showed a keen interest in the land records. Many said that this was the first time they could see and touch original land grant documents. They were surprised that the Land Registry had kept these records in such good condition for over 100 years.

The land records are very useful for cadastral surveys including those for determining boundaries, titles, registrations, etc. Other records were also new to the visitors, who reciprocated by sharing their professional knowledge of the uses and origins of the land records with the hosts.

Apart from registered documents, the Land Registry also displayed the evolution of land registration services over the past 180 years. Both parties concluded the visit with much excitement.

### CPD: Challenges of Super Tall Buildings – Property Management Perspectives

#### Reported by Sr Jack Lee, PFMD Council Member

Mr Albert Lee, Head of Property and Asset Management at South China JLL, was invited to deliver the captioned CPD on 21 June. He covered the following key topics:

### 1. Definition of a Supertall Building

- The definition has varied globally over time.
- In China, buildings of over 100 meters in height are categorised as supertall, while those in the US are supertall if they exceed 152 meters.

#### 2. Special Features of Tall Buildings

- Supertall buildings require unique designs for their gondolas and lifts to accommodate their operations efficiently.

#### 3. Challenges of Managing Supertall Buildings

- Iconic supertall buildings that suffer incidents attract media attention, so they need careful management.
- Managing lift usage during peak hours is a critical challenge due to a supertall building's high occupancy.


### 4. Daily Operations

- Security and cleaning operations are divided into different zones to ensure effective management.
- Measures such as deploying explosive detection dogs enhance safety protocols.

During the Q&A session, Albert addressed members' concerns over energy efficiency and the ESG aspects of supertall buildings. The PFMD thanks him for providing its members with so much information and looks forward to further enlightening them on supertall building management.

### CPD: Introduction to IAQ, Scada System Applications, & AR Technologies in Facility Management

#### Reported by Sr Danny Leung, PFMD Council Member

The captioned webinar was delivered by four experienced speakers on 28 June in two sessions detailed below.

### Session 1: Introduction to IAQ and Scada System Applications

Mr Will Cheung, Director (BIM) of Moebius Innovation Limited, covered the application of the Supervisory Control and Data Acquisition (Scada) System to control, monitor, and analyse processes. It is designed to operate in real time, with data being collected and processed in near-real time, and control signals are sent to field devices within milliseconds for the safe and efficient operation of industrial processes in a wide range of facility management tasks (Figure 1).

Then Mr Harold Ng, Director (IAQ) of Moebius Innovation Limited, shared a project reference in which Scada was used at the Clarity Eye & Surgery Centre to control for humidity and temperature inside its operating room on the 9/F of Wai Fund Plaza.

Finally, Mr Allen Poon, Director (Architectural) of Moebius Innovation Limited, shared how the scan-to-BIM system could be applied to BIM developments in existing buildings.

# Session 2: AR Technologies in Facilities Management

Mr Frankie Pang, Director of Cordex Digital Architecture Limited, introduced his company's AEC reality solution, which integrated digital assets geometrically within physical spaces using augmented reality (AR) technology with the following features:

- 1) It operates by triggering and tracking without the need for external on-site sensors.
- 2) The tracking system is continuously calibrated to provide accurate image overlays within a 3D environment that is precise to the nearest centimetre.
- 3) It adapts to a variety of architectural environments whether they are indoor or outdoor.
- 4) It is compatible with most BIM software and 2D/3D data, which can be seamlessly transformed into AR content.
- 5) It ensures a seamless experience so that users can freely roam each site, inspect their details from different positions and angles, and enhance the coherence and systematic nature of their operations (Figure 2).

The PFMD is grateful to all speakers for delivering such interesting presentations.

CPD: Financial Disputes and Irregularities for Surveyors and Property Managers – Forensic Accountants' Perspective

### Reported by Sr Danny Leung, PFMD Council Member


This webinar occurred on 12 July and featured Mr Benny Kwok of BENNY KB KWOK FORENSIC EXPERT as the speaker. With respect to financial disputes and irregularities that surveyors and property managers face, forensic accountants address these issues by providing services such as bookkeeping, payroll accounting, auditing, tax compliance, corporate governance, due diligence, restructuring, sustainability reporting, and forensic accounting (Figure 1).

Benny elaborated on the following topics:

- Work of forensic accountants on two main project types: (a) Expert Witness – providing expert opinions and testimony in legal cases and (b) Investigation – uncovering financial fraud and misconduct through data analysis and forensic auditing.
- 2) Interpretation of financial statements of owners' corporations in Hong Kong.

- 3) Wrongful manipulation of staff costs, such as those for ghost employees, and that for property expenses such as price-fixing, bidrigging, and fraud in needs determination/ works specifications/pre-solicitations/bid evaluations/product substitutions/payment certification and approval.
- Wrongful financial manipulation through various methods including fictitious sales, provisional revenue, understatements, overcharging, capitalising expenses, disguising transactions, mixing funds, receiving kickbacks, inflating profits, and making misrepresentations.
- 5) Claims against property and facility managers including professional negligence and breach of contract (Figure 2).

During the follow-up Q&A session, Sr Kays Wong shared his experiences in justifying administrative fees for recruiting property management company staff. The PFMD thanks Benny for his engaging presentation on the significant roles of forensic accountants in the PFM industry.





### QSD PQSL Specialisation Series 2024 (4): Exploring Artificial Intelligence from the Quantity Surveyor's Perspective (16 July 2024)

Sr Sasa Zhang, an Associate at MJ Consultants, Ltd, delivered a PQSL seminar on artificial intelligence on 16 July. Given the growing importance and competitive advantages of AI across various industries, its adoption in the construction industry has become increasingly pertinent.

This webinar aimed to enhance attendees' understanding of AI, inspire them to consider potential AI applications for the construction industry, and demonstrate how these technologies can apply to their professional practices.

During the webinar, Sasa briefly explained the basics of AI and highlighted three primary areas: machine learning, natural language processing, and robotics, along with their benefits and limitations. Sasa also discussed AI's possible application to manage time, costs, and contracts in construction projects from a QS perspective.

The YSG Study Tour 2024 will go to Melbourne, Australia, for the first time to provide an exciting opportunity for its members to experience a city outside of Asia.



### CPD: Biodiversity Tour at Taikoo Place

### Exclusive Tour for HKIS Members Promoting Urban Biodiversity and Sustainability

Around 30 HKIS members, including President Sr Francis Lam, joined a biodiversity tour of Taikoo Place in Quarry Bay on 26 June. The event was hosted by Swire Properties to showcase its commitment to placemaking and sustainability. Ms Eliza Wong, Deputy Director of Projects, and Ms May Lam-Kobayashi, Deputy Director of Public Affairs at Swire Properties, hosted the group.

May provided a project introduction, which included a background of the Taikoo Place redevelopment project. This started in 2016 and involved converting three older industrial buildings into two triple-A-rated office towers – One Taikoo Place and Two Taikoo Place. An expansive green space, Taikoo Square and Taikoo Garden, was planned for the site and located in front of the two buildings. Their combined area of over 70,000 square feet of greenery comprises 30 percent of the site area. Taikoo Place's office buildings are interconnected by elevated walkways to enhance their interconnectivity.

To integrate urban biodiversity into the design of Taikoo Place's green spaces, Swire collaborated with Dr Billy Hau, an ecology specialist from HKU, to evaluate urban biodiversity in the Eastern District of Hong Kong Island. Dr Hau's study inspired the selection of over 260 native and exotic plant species to enhance ecological value for wildlife in Taikoo Square and Taikoo Garden. A biophilic design was also adopted to better connect people to nature.

HKIS members observed the naturalistic planting style that allows wildlife in a layered

ecosystem. The tour also explained the importance of ecological corridors with the new gardens linking to nearby natural areas, such as Mount Parker and Quarry Bay Park, to facilitate wildlife movements.

The designs of the long pools at Taikoo Square and the suspended lanterns in the lobby of Two Taikoo Place pay tribute to Swire's former dockyard and sugar refinery businesses in Quarry Bay.

The tour continued with insights from Outdoor Wildlife Learning Hong Kong (OWLHK) representatives. Members learned about the ecological values of selected native species planted in the garden, which drew inspiration from Hong Kong's native "feng shui woodlands" to enhance habitats and food sources.

The event concluded with refreshments and networking, which allowed the HKIS, Swire, and OWLHK to share perspectives and experiences. It is hoped that such CPDs between surveyors, environmental organisations, and developers will drive sustainability in Hong Kong's built environment.
