# HKIS Surveyors view current use, potential of Building Information Modelling

Surveyors describe the growing use and benefits of Building Information Modelling, its penetration of their respective divisions and how they expect the greater use of and advances in BIM technology to affect their professional lives.

Today in particular project developers/owners are more aware of BIM's benefits in a competitive business environment. They use it to raise productivity by facilitating reduction of wastage and abortive work.

The Government's 2017-18 Policy Address affirmed the adoption of Building Information Modelling (BIM) technology in the design and construction of major public works projects estimated to cost over HK\$30 million. Then, last December, the Government fostered adoption of BIM by enhancing implementation requirements and revising the scope of mandatory BIM use, e.g. "2D drawings shall be generated from the 3D BIM model."

BIM has been used in the construction industry for a decade. Apart from traditional 3D design modelling, BIM dimensions have evolved into 4D, 5D and 6D, facilitating collaborative working among various project parties.

Its beauty is that it encapsulates an immense amount of information, extractable later from digital models. Building first in a virtual world helps avoid unnecessary changes in the construction process, thus reducing wastage and time-cost. This explains why in recent years the surveying industry has adopted such information-rich models more widely.

Land Surveyor Sr Lai Man-kit Thomson, Executive Director, AECOM Asia, attributes the wider usage of BIM to proactive promotion by the Government. He said, "Mandatory use of BIM in public works has certainly spurred its adoption. Formerly, our role in construction involved engineering surveys or defining land boundaries. Now, with BIM technology, we play a dual role — project manager of overall BIM data management flow and quality assurance to ensure virtual design is accurate and matches future delivery. We treat BIM as a tool rather than just software because, through digitisation, it drives immense changes to traditional construction and design processes."

"Land Surveying manages large amounts of data, including spatial information and database attributes. Moving in the direction of smart cities or digital twins, BIM helps virtualise what is going to be built and simulate e.g. the effects of sunlight and wind on buildings after completion. When more

smart city initiatives emerge, e.g. shifting from 2D to 3D BIM and beyond, it will reflect the prolific data generated for collection, processing and analysis. How to use or apply this data is a big topic for us. That's the value of land surveyors, who can play a spatial information advisory role."

Different BIM dimensions indicate different impacts and functions, but Land Surveying is not limited to any particular dimension; various project stages determine what is best to use. For instance, 3D for design and construction coordination with virtual world created, 4D featuring time function, with what to build when, and 5D focusing more on cost factors, suiting quantity surveying. Sr Lai explained, "Currently there are huge number of requests on BIM data sharing, it proves that a common spatial data sharing platform is necessary to effectively integrate and collaborate various data."

Building Surveying had similar views on greater BIM adoption. Building Surveyor Sr Y Y Yip, HKIS's BIM Committee Chairman since 2017, has witnessed the changes to BIM over the last decade. He said, "It has received little industry attention until recent years. Today in particular developers/owners are more aware of BIM's benefits in a competitive business environment. They use it to enhance cost control by facilitating reduction of wastage and abortive work. For instance, the company I work for is exploring extending BIM to asset/ facility management. So far, we have integrated BIM with air conditioning system for energy control and sensors for security systems, then connected both to mobile apps for managing daily operation, energy consumption, maintenance orders and job completion. A data summary allows management to see the operation in a day."

However, Sr Yip acknowledged, many surveying professionals know the benefits of different BIM models — 2D, 3D, 4D, 5D etc. — but have little grip on how exactly can BIM help them. He added, "Don't adopt the technology for the sake of using it, people should ask how to use BIM to achieve

a better outcome. In fact, BIM can handle most of the design and construction process, provided you know how to leverage it specifically. Hence, the Construction Industry Council rolled out the Certified BIM Manager programme to promote the adoption of BIM techniques, as well as the BIM management."

Lands and Property Development involves a lot of data and the key is using it effectively to speed up the decision-making process. To some extent, Sr Yip reiterated, the marriage of BIM with big data will result in accurate statistics and analysis, e.g. development options, financial assessment etc. He added, "We must submit building plans to the Government for approval and the Government is now discussing electronic submission, i.e. BIM E-submission. Moreover, we are still discussing the possibility of automated checking because of numerous rules in building regulation, e.g. plot ratio checking, usable area checking, building height, means of escape, so professions don't have to spend time on routine checking, freeing them to provide other value-added services. Furthermore, the trend for BIM will see it marry with the Internet of Things (IoT), Al programming or users' tailormade programs in order to exemplify its uses."

Someone said BIM is a tool for the next decade and onwards, apart from experienced practitioners, what is the view of a young surveyor? Sr Sammy Yip, a quantity surveyor, works in Gammon Construction's innovation team. When she graduated from the University of Hong Kong in 2015, there weren't any BIM-related modules/ course in the syllabus. She observed, Quantity Surveying consultancy firms are taking advance initiatives in adopting BIM technology but contractors are mostly a bit lagging behind. She explained, "If it weren't for Government projects or required by clients, contractors would not take the initiative to build their own BIM models due to the high initial cost and the handful of capable BIM professionals in Hong Kong. Obviously, we see the BIM trend, but lacking standard BIM modelling rules results in difficulty for efficient data collaboration. Having said that, training sustains BIM talent development and I understand some big main contractors push BIM learning. My company sponsored QS staff to attend external training. However, if you don't apply it or learn by doing, it's easy to forget."

5D BIM has been tried and even adopted in some building projects, but 4D BIM and beyond heavily rely on the standard of model quality and information included in models. Ms Yip opined, "The ideal way of applying BIM to our profession's day-to-day operations is real-time data sharing, e.g. when an architect changes the size of a wall, obtaining old and new areas, with cost implications. After calculating the cost difference, the client can decide whether to accept the change or not. It allows informed decisions, speeding up construction. But the existing data transfer speed is too slow to support this function."

Looking ahead, the industry expects to embrace the soon-to-come 5G network era. Sammy Yip explains, "5G is data transmission in real time, solving the speed issue and enabling various possibilities like real-time control of robots. Our lives will be a lot easier, e.g. we can deploy a drone and capture data such as number of workers and quantities of materials at project site. Contractors and consultants will be freed from mundane on-site duties, e.g. taking pictures recording damage by sub-contractors and issuing claim letters."

Sr Lai agreed, saying, "Communication speed has to be fast in view of BIM generating more data, or we would be unable to transfer or share real-time data. I estimate cloud computing will dominate when a lot more 3D data is generated than ordinary office servers can contain. The cloud is supported by unlimited storage and a powerful platform. From there, we can ride on powerful hardware to process, analyse and share data at high speed."

## 香港測量師學會評估 BIM 技術的現況和潛力

測量師講述建築信息模擬技術 (BIM) 的普及化與其效益,相關技術如何應用在各組別的工作;他們期望能更廣泛地使用技術,提升專業。

政府在 2017 至 18 年度的施政報告表示,將採用建築信息模擬 (BIM)技術去設計和興建估計耗資 3,000 萬港元以上的工務工程項目。 去年 12 月,政府再推廣有關技術,增強實施 BIM 的要求和修訂必須使用 BIM 技術的範圍,例如使用三維 BIM 模型繪製二維圖。

BIM 技術應用在建造業已有十年。 除了傳統的三維模型設計外,BIM 技術已進化至四維、五維和六維,促進了各方之間的通力合作。

BIM 技術精妙之處在於技術本身儲存了大量信息,日後可從數碼模型中提取出來。先建造虛擬實景,可減少在施工過程中的無謂改動,減少浪費資源和降低時間成本。因此,近年測量業逐漸更廣泛地採用BIM技術。

土地測量師、AECOM 大中華區數字化轉型領導、執行董事黎文傑測量師認為政府帶頭推廣,使 BIM 技術普及化。他説:「強制工務工程中使用 BIM 技術肯定會推動業界使用技術。以往我們在建築工程中負責工程測量或土地鑑界。如今利用 BIM 技術,我們扮演雙重角色,包括管理整體 BIM 技術數據和質量保證,確保精確的虛擬設計符合之後興建的實景。 BIM 不僅僅只是軟件,我們將它視為一種工具,通過數碼化,BIM 可以為傳統建築和設計流程帶來巨大變化。」

「土地測量管理大量數據,包括空間信息和數據庫屬性。若朝著智慧城市或數位學生的方向發展,BIM將計劃中建築的內容虛擬化,例如模擬完工後陽光和自然風對建築物的影響。當出現更多與智能城市有關的建議,例如從二維設計流程轉到三維或以上的BIM流程,就需要收集、處理和分析更大量的數據。如何使用或應用這些數據將是一個重大的課題,也是土地測量師的價值所在,他們可以發揮空間信息諮詢的作用。」

不同的 BIM 應用帶不同的影響和功能,但土地測量不限於任何特定的應用,要視乎各項目階段而決定採用怎樣的 BIM。例如,三維圖用於設計和配合虛擬實景進行施工協調,四維圖具時間功能,顯示適合的建築時間表,五維圖更注重成本因素,適合工料測量。黎文傑測量師解釋說:「目前有大量關於 BIM 數據共享的要求,顯示我們需要一個共同的空間數據共享平台去有效地整合和協調各種數據。」

建築測量同意更廣泛地採用 BIM。自 2017 年起擔任香港測量師學會建築信息模擬委員會主席的葉燕勇測量師,見證過去十年 BIM 的變化。他說:「BIM 過去一直沒有受到業界的關注,直至近年情況有變。現在項目開發商或項目實施機構更加了解 BIM 在競爭激烈的商業環境中可帶來的優勢,包括利用 BIM 技術減少浪費和工程作廢的情況,從而提高成本控制。

又例如,我工作的房地產公司正研究將 BIM 擴展到資產/設施管理。目前為止, 我們已將 BIM 連接到冷氣系統去控制能 源,又連接到保安系統感應器,然後再連 接到應用程式,方便管理日常能源效益、 日常操作、管理維修申請和完成工作。數 據摘要讓管理層查看每一天的運作。」



然而,葉燕勇測量師承認,許多測量專家都知道使用二維、三維、四維、五維等不同 BIM 模型的好處,但他們未必完全掌握 BIM 技術。 他補充說:「不單只是為用而用,應該要充分發揮 BIM 技術,取得更大成效。事實上,BIM 可以處理大部分設計和建造過程,但前提是你具體掌握這門技術。 因此,建造業議會推出了認可建築信息模擬經理計劃,推廣採用 BIM 技術以及 BIM 管理。」

土地和地產開發涉及大量數據,關鍵是如何有效地利用這些數據,加快決策過程。在某程度上,葉燕勇測量師重申,結合 BIM 與大數據有助得出準確的統計數據及分析,例如:發展的不同方案,財務分析等。 他亦補充説:「我們必須向政府提交建築圖則,並取得批文。政府正在討論提交電子版本圖則的可行性,亦即 BIM 電子提交申請。 此外,由於建築物規例眾多,我們仍在討論自動篩查電子申請的可能性,例如檢查地積比率、可用面積、建築物高度、逃生方式,以致專業人員不必再花時間進行例行檢查,讓他們能夠提供其他有需要的服務。此外,BIM 的發展趨勢將結合物聯網、人工智能編程或為用戶訂製的程式,這樣就能更具體説明其用途。」

有人認為 BIM 是適合未來十年以後使用的工具,除了以上兩位資深的測量師,另一位年輕的測量師又有什麼看法?工料測量師葉詠心在金門建築的創新團隊工作。她 2015 年畢業於香港大學,當時課程大綱中沒有任何與 BIM 相關的課程。她觀察到工料測量諮詢公司正搶先採用 BIM 技術,但大多承辦商在這方面有點滯後。她解釋說:「如果不是政府項目或客戶要求,承辦商不會主動建立自己的 BIM 模型,一來因為初期成本高,二來香港優秀的 BIM 專家為數不多。顯然,我們洞悉 BIM 趨勢,但缺乏標準的 BIM 建築規則,阻礙有效地使用各種數據。然而,我們可以培訓 BIM 人才,我知道一些大型主要承辦商積極推動 BIM 培訓。像我就職的公司就贊助工料測量的員工參加外部培訓。但是,如果你沒有學以致用,就會很容易忘記技術。」

BIM 五維圖已應用在一些建築項目中,但 BIM 四維圖及其後的多維圖著重模型質量標準和模型中包含的信息。 葉測量師認為:「將 BIM 應用於我們日常工作中的理想方式是即時數據共享,例如: 當建築師改變牆壁大小,涉及的新舊區域,會影響成本。在計算成本差異後,客戶可以決定是否接受更改建議。這樣有助作出明智的決策,同時加快施工速度。但現行的數據傳輸速度太慢,無法支援此功能。」

展望未來,業界即將踏入 5G 網絡時代。 葉測量師解釋說:「5G 有助即時數據傳輸,解決速度問題,實現各種可能性,如即時控制機械人。5G 能令我們生活更便利,例如我們可以利用航拍機收集數據,包括工人人數和現場材料數量。承辦商和顧問無需在現場處理沉悶的工作,例如省卻承辦商拍照記錄損毀情況和發出索賠信。」黎文傑測量師同意,他說:

「BIM 產生更多數據,所以需要加快傳訊速度,否則我們將無法傳送或共享即時數據。我估計,當產生的三維數據超出普通辦公室電腦伺服器的負荷時,雲端計算將成為主導技術。雲端具無限儲存空間和強大的支援平台,這樣我們可以使用功能強大的硬件來高速處理、分析和共享數據。」

## **Land Resources: Unlocking its Potential**

I have mentioned earlier on that land is the source of economic wealth and success. We surveyors are putting every effort to make the most of this precious and finite commodity. Surveyors are involved in various stages during the land development cycle; a perpetual cycle. Our profession and sector we practice in, demands that we continually sharpen our skills and advance our knowledge, with a view to attaining breakthroughs in our respective surveying specialities. In the recent HKIS Building Surveyor Awards 2019, many outstanding building projects were entered for the Distinguished Award, covering a swathe of categories, which included building development, maintenance, rehabilitation, alteration, addition, and conversion. These building works display the talent and ingenuity of surveyors as well as their fruitful exploitation of state-of-the-art information technology in their work.

Alongside our drive towards efficient and effective use of land resources, surveyors have made great strides and advances towards the goals of constructing buildings that are more sustainable and greener, creating a more liveable environment, injecting greater value and improving affordability through savings in construction cost and materials, and finally shortening development time through more efficient work processes. Ultimately, a greater quantity and quality living space is materialised. How much further can we push past the established

boundaries and move further forwards under current mode of construction practices, with the current tools, methods and resources at our disposal?

## **Technology is the Key**

Modern information technology, both in software and hardware, has made quantum leaps. Business operators are continually being exposed to opportunities where they can reap considerable benefits through IT systems. In this highly competitive environment, whether profit-making or non-profit-making, the use of information technology is inevitable in order to survive, we are of no exception.

With the fast development of the Geographic Information System (GIS) and Building Information Modelling (BIM) technology, gargantuan computing power, highly sophisticated and user friendly applications, growing types of 3D geospatial data, and versatile imagery capture methods, it is evident that taking advantage of and applying this technology in various surveying works is becoming imminent.

Indeed, this technology is applicable to all surveying divisions. For example, 3-dimensional photorealistic model and geospatial data of the building development and the surrounding topography allow users to have a panoramic view of distant landscape and skyline, a close up perspective of the neighbouring area, and even a view of the outside scene from different angle inside the tenement unit not to mention the ability to enjoy a fly-through and walk through as well. BIM is also an effective tool to control cost and avoid cost overrun. One of the merits of BIM is to make use of its 'objects' to enrich 3D geospatial data. But a prerequisite is that data from different sources must comply with an agreed standard in terms of content and format, which will bring long term benefits.

Surveyors of different divisions working on the same development can have access to the same piece of information instantaneously. Changes to the design can be added and concerned parties can be made aware of such without delay. Work process can be planned and put on trial before-hand to avoid any unforeseeable incidents, which may be costly and time consuming. These minor improvements when added up can be quite substantial and be advantageous to all parties. Through a more rigorous design and multiple selection of materials and methods, more useable space can be made available and saleable.

## ACTING PRESIDENT'S MESSAGE 署理會長的話

## **Common Spatial Data Infrastructure (CSDI)**

The Government has just announced that the Development Bureau aims to roll out the CSDI for public use by the end of 2022, and the 3D digital map will be made available in phases from late 2019 to 2023, subject to funding approval from the Legislative Council Finance Committee.

This is an encouraging sign that the Government is taking a positive step forward for the full implementation of GIS and BIM in the Government. It is opportune for surveyors to seriously consider going for GIS and BIM in order to reap the substantial benefits from it. 'Rome was not built in a day' and likewise users and operators will not be versed in the operation of this technology in a day either, time must be invested to sow the fruits of success. I therefore encourage all surveyors to make use of the new technologies, to keep abreast of the development of the technology and reverently take advantage of it in their work for developing Hong Kong into a spatially enabled world city.

Lastly, this is the last message from me in the capacity of Acting President. I would like to take this opportunity to thank the unfailing support from the General Council and the efforts of the Office Bearers for sharing the workload together.

## 土地資源:釋放潛力

我之前提及過,土地是經濟財富和成功的來源。我們作為 測量師不遺餘力地、充分利用這珍貴且有限的資源。在土 地開發的過程中,這同時也是一個循環的運作,測量師都 有參與各個階段。我們的專業推動我們在技能和知識上精 益求精,使我們在各自的測量專業範疇中不斷取得突破。 本會最近舉辦「建築測量師大獎 2019」,許多優秀的樓宇 工程入圍卓越大獎,這些工程涵蓋不同類別,包括新建樓 宇、保養、復修、加建、改動和改造。這些樓宇工程展示 了測量師的才能和創意,以及他們如何善用資訊科技。

隨著我們爭取更有效和便捷地使用土地資源,測量師在建築項目取得更大的進步,興建更多可持續和更環保的樓字,

創造一個更宜居的環境,提升樓宇的用途,節省建築成本和物料,從而使樓宇更符合經濟原則,改善工作效益繼而縮短工程開發時間,最終為市民帶來更大和更美好的生活空間。在目前的建築模式下,如果我們繼續採用現有的工具、方法和資源,是否可以超越現時的限制,更上一層樓呢?

## 科技是關鍵

不論是軟件或硬件,現今資訊科技取得了飛躍的進步。企業得到越來越多的機會透過以善用科技系統發展業務。在這個競爭激烈的環境中,無論是商業機構還是非牟利組織,都要發展資訊科技,我們也不例外。

地理信息系統 (GIS) 和建築信息模型技術 (BIM) 發展迅速, 龐大的電腦計算能力,實用和簡便的應用程式,各種三維 地理空間數據以及圖像攝取方法,都能應用在各種測量工 作中,達到事半功倍。

事實上,這些技術適用於所有測量組別。例如,樓宇開發和周圍地形圖的三維實景模型和地理空間數據,可讓用戶看到遠處景觀和天際線的全景圖,近距離地觀察鄰近區域,甚至以不同角度、從單位內部欣賞外面景觀。BIM 同時有助控制成本和避免項目超支,其另一個優點是利用「物體」化,來豐富三維地理空間數據,但先決條件是不同來源的數據在內容和格式上都要符合指定統一標準,同時這會帶來長遠利益。

不同組別的測量師可即時閱覽同一份資料,若對設計作出 任何更改,其他相關人士亦能即時被通知。我們可以預先 計劃工作流程,進行試驗,避免任何不可預見的事件,省 卻不必要的成本和時間。這些微小的改進,如果集合起來, 積少成多,可為各方帶來實際利益,因採用更精密的設計 和有更多種材料供選擇,便能提供更多可使用的空間。

### 空間數據共享平台

政府剛剛宣布發展局計劃在 2022 年年底前推出空間數據共享平台給公眾使用,而三維數碼地圖亦將於 2019 年年底至 2023 年期間分階段推出,視乎立法會財務委員會的撥款。

以上種種推出的計劃,顯示政府內部正積極地全面實施 GIS 和 BIM,消息令人振奮。測量師可考慮使用 GIS 和 BIM,把握這個難得的機會。「羅馬不是一天建成的」,同樣地,這些技術不是可以在短時間內精通地運用,大家都需要經過努力才能達到有效的成果。因此,我鼓勵所有測量師善用新技術,跟上科技的發展步伐,將科技應用在日常工作,使香港成為一個信息空間化的世界城市。

這是我最後一次以署理會長的身份在這裡跟大家講話,我 想藉此機會感謝理事會對我的支持。

## HKIS 35<sup>th</sup> Anniversary Celebration Memoirs of the HKIS Past Presidents – Celebrating 35 Years of Excellence 香港測量師學會35周年誌慶 – 歷屆會長回憶錄

The year 2019 marks the 35th anniversary of the service and commitment by The Hong Kong Institute of Surveyors towards the surveying profession and the community. To celebrate this joyous occasion, a new column in the HKIS monthly newsletter - *Surveyors Times*, will be dedicated to the Past Presidents for sharing their precious memories, invaluable insights and significant achievements during their tenure. The articles will be published in the *Surveyors Times*, starting from December 2018 to November 2019.

"The HKIS is certainly never dull". So started my incoming President's Address in April 1989, although I doubt if I quite realised what a turbulent year it would be. The Institute was in its infancy, barely five years old with a membership of just one thousand. There was a need for the HKIS to be recognised

both in Hong Kong and internationally. This could only be achieved through a credible system of education, training and professional standards.

It was a time of uncertainty. The Joint Declaration had been signed in December 1984 and although the drafting of the Basic Law was in progress, there was pressure for additional guarantees in the form of a right of abode in the UK. In April 1989 I had attended the Foreign Affairs Committee hearing of the British Parliament to help make the case. The case was not accepted by the British Government. In June that year the events of Tiananmen Square shook Hong Kong. This resulted in one third of members paying their respects to the dead, and letters being sent to both the Chinese Government and the British Prime Minister.

It was a time to move on and rebuild confidence in the future. The 'Joint Council of Nine Professions' was an informal network of Presidents. The Council was galvanized into action. The objectives were to build confidence in Hong Kong, promote our professions overseas, and to preserve the independence of the professions under the Basic Law. In May 1989 the HKIS held a seminar on the second draft of the Basic Law and then provided input into the draft.

It is perhaps not appreciated now, but that at the time the HKIS was not fully recognised by Government. Despite introducing a TPC in 1987, HKIS qualifications were not accepted for Government employment unless members had entered through the RICS route. To gain recognition it was necessary to benchmark the HKIS educational and TPC requirements against international organisations. To its credit the HKIS aimed to become the benchmark.


One problem was that the only way to become a member of the HKIS was to obtain a degree overseas. The Institute succeeded in putting pressure on the then University and Polytechnic Grants Committee to fund surveying degrees in Hong Kong. It argued that surveying was the only

profession where an overseas degree was required. I took part in the first external validation of surveying degrees at the University of Hong Kong and the Hong Kong Polytechnic University as part of the RICS validation team in 1987/8. Importantly there was an independent HKIS observer on the team. In 1989 Land Surveying was added to the list of degrees.

With the proposal to create Functional Constituencies, recognition of surveyors and the HKIS under the Laws of Hong Kong was essential. Following an EGM in July, a private members HKIS bill was tabled in November and came into law in January 1990. Local surveying firms had raised the \$130,000 needed to sponsor the bill. In parallel the government sponsored the Registration of Surveyors bill which proposed that the HKIS administers the registration process. The third piece of legislation in gestation was the Land Survey Ordinance.

Communication, Corporate Image and Administration were other objectives during the year. The first HKIS Newsletter was introduced. Confusion in the mind of the public about the various surveying disciplines led to the use of the phrase "Surveyor the Property Professional". The priority was to increase the profile of the HKIS within Government and businesses. At the time few surveyors worked outside government or surveying firms. We reached out to the public by providing the content on home purchase, management and maintenance for a five-minute slot in a weekly TV series called 'Women Today'.

I once referred to management and administration as the "mundane side of the HKIS". In truth the Institute can only work with the support of its Members operating at that time through six Divisional Councils and six Standing Committees supported by eight working groups. We were represented on 16 Hong Kong and International Standing Committees. All decisions were taken by General Council, so in 1989 a Management Committee was formed. This enabled General

council to focus on strategy, policy and overall control leaving day to day administration, cost control and management to the Management Committee.

The 'engine room' of the HKIS is its administration. This had just moved into new offices and for the first time had computerised its accounts. An important step was taken with the

production of the 'Rules of Conduct' needed underpin our Bye-Laws. It was agreed in principle to introduce CPD. As with today there was a need to provide input into government consultations such as 'Metroplan'. Working with the RICS and Institute of Housing support was given to the formation of an Association of Property Companies.

In 1988 I had joined President Sr Francis Lau on a visit to Beijing. There we met with government officials and made presentations. During my year as President I visited Singapore to meet the Singapore Institute of Surveyors and Valuers. I also met the President of the RICS in London where we reached agreement in principle on reciprocal recognition.

It was a time when the HKIS took the first tentative steps to achieve recognition both in Hong Kong and internationally. It put into place some of the foundations for the education and ethical standards that are so important to our profession. I am proud to have been part of an Institute that has grown in stature and contributed so much to Hong Kong. In my own words so long ago "The HKIS is certainly never dull."

## 国家发展改革委办公厅关于对房地产企业发 行外债申请备案登记有关要求的通知

发改办外资〔2019〕778号

各省、自治区、直辖市及计划单列市、新疆生产建设兵团 发展改革委,各有关企业和金融机构:

为进一步落实《国家发展改革委关于推进企业发行外债备案登记制管理改革的通知》(发改外资〔2015〕2044号)、《国家发展改革委 财政部关于完善市场约束机制严格防范外债风险和地方政府债务风险的通知》(发改外资〔2018〕706号)等规定要求,完善房地产企业发行外债备案登记管理,强化市场约束机制,防范房地产企业发行外债可能存在的风险,促进房地产市场平稳健康发展,现对房地产企业发行外债申请备案登记提出如下要求。

- 一、房地产企业发行外债只能用于置换未来一年内到期的中长期境外债务。
- 二、房地产企业在外债备案登记申请材料中要列明拟置 换境外债务的详细信息,包括债务规模、期限情况、 经我委备案登记情况等,并提交《企业发行外债真实 性承诺函》。
- 三、房地产企业发行外债要加强信息披露,在募集说明书等文件中需明确资金用途等情况。
- 四、房地产企业应制定发行外债总体计划,统筹考虑汇率、利率、币种及企业资产负债结构等因素,稳妥选择融资工具,灵活运用货币互换、利率互换、远期外汇买卖、期权、掉期等金融产品,合理持有外汇头寸,保持境内母公司外债与境外分支机构外债、人民币外债与外币外债、短期外债与中长期外债、内债与外债合理比例,有效防控外债风险。



**BIM Committee** 

Chairman: Sr YY Yip

The BIM Committee successfully hosted the first HKIS BIM Conference on 30 November 2018. Over 200 participants, including senior government officials and members of all disciplines, attended this gathering. The conference demonstrated how surveyors could adopt BIM techniques in the development and construction lift cycle process during its various stages. This year, the Committee will host the second HKIS BIM Conference in late November with a theme of "The Next Frontier for Surveyors - Digitised Development Workflow". Its aim is for surveyors to showcase BIM application cases. The Committee has also invited overseas surveyors as its featured speakers to share their experiences employing BIM applications.

Members may already know that the Construction Industry Council (CIC) named 2019 as the "BIM Year" when it launched a BIM Manager Certification Scheme and Construction Innovation and Technology Fund (CITF). In this connection, the Committee invited the CIC's representatives to introduce the details of the Scheme and CITF to members on 25 June. Also, to cope with this move, it is now organising a training course in collaboration with a university institute. The course content will specifically focus on BIM + surveyors aspects.

A CPD, "What are the impacts of BIM, Big

Data and AI on City Planning?" was held on 10 June. The Committee will continue to organise informative CPDs to promote and update members on BIM applications and related technologies. It will also try to organise social gatherings to allow members to exchange the latest knowledge of BIM + applications and developments.

One year ago, it was reported that the LSD were proposing to re-establish reciprocal recognition with RICS and the PFMD were exploring the possibility of reciprocally recognizing the RICS's Facilities Management pathway.

Great progress have been made by the LSD and PFMD. A new Memorandum of Mutual Recognition of Membership was signed by the geomatics professionals of both Institutes on 29 November 2018. LSD Members and professional members of RICS (Chartered Land Surveyor) would be recognised by both Institutes.

On 11 April 2019, the HKIS and RICS entered into a new Memorandum of Mutual Recognition of Membership for facilities management professionals of the two organisations.

The PDD are also exploring the possibility of mutual recognition with its respective counterpart in RICS.

The HKIS will continue its dialogue with RICS, including the organisation of joint activities for the benefit of its members.


- To advise on matters relating to the HKIS's IT requirements including the plans for improvement works and capital expenditures.

## Mainland Affairs Committee

Chairman: Sr Dr Stephen Lai

The Mainland Affairs Committee was formed to consolidate every division's request on CEPA-related issues before raising them with the relevant Hong Kong and Mainland government bodies or officials and to encourage each division to establish and maintain close dialogue with its Mainland counterpart. The Committee also explores collaborative opportunities with Mainland institutes and universities. It held meetings on 4 March and 6 May.

### **Mainland Forums**

One of the Committee's main duties is to promote the surveying profession and enhance the HKIS's image in China. This year, the HKIS appointed the following members as Chairmen and Vice Chairmen of the Mainland Forums.

### Building for The Future「未來建設 建設未來」

The Hong Kong Trade and Development Council invited the HKIS to join two promotional campaigns tailored to the infrastructure development and real estate-related services sector during the first and second quarters of 2019.

## Guangzhou (25-27 March 2019)

The development plan of the Greater Bay Area was first presented in China's 13th Five-Year Plan, which aims to elevate the region to a world-class city cluster that is globally competitive. The Central Government attaches great importance to this plan, which is significant to the country's development.

With an area of 56,000 square kilometres and a population of some 66 million, the Greater Bay Area's efficient integration would require enhancements to its infrastructure; real estate; and smart city, green city, and related developments, which together create immense opportunities for Hong Kong professionals.





## **Chongqing (14-17 May 2019)**

Chongqing has a total area of 82,400 square kilometres and a population of over 30 million. According to its Population Development Plan (重慶市人口發展規劃), the city's population is forecasted to reach 32 million by 2020 and 36 million by 2030. This requires it to build more infrastructure and real estate developments and it will invest up to Rmb1.2 trillion in infrastructure construction by 2020.



## Visit to Beijing

The Committee has arranged annual visits to Beijing since 2011 to maintain close dialogue with the relevant Mainland ministries and counterparts. The 2019 visit is scheduled for early November.

## Project Management Committee

Chairman: Sr Prof Wong Bay

The purpose of establishing the Project Management Committee is to enhance the project management (PM) skills of members; promote a greater public awareness of the work of surveyors in providing PM services; consider making assessments and keeping a register of 'certified project managers' (CPMs) for HKIS members; liaise with other professional bodies, authorities, organisations, and project managers to promote and develop PM; and conduct research on PM.

The PMC held two committee meetings in April and July to debate and re-affirm its objectives and vision. It believes that PM is an interdisciplinary activity and all divisions are involved in various PM activities. Committee members brainstormed activities that would be suitable for enhancing the PM skills of members. Then they agreed to arrange a series of joint CPD events with other divisions on PM-related topics in 2019.

The PMC unanimously agrees that promoting CPMs would be complicated and require long term planning. It considered that promoting public awareness of employing surveyors to provide PM services and organising a "**Distinguished PM Award**" could be explored when resources become available. Members noted that they conducted a questionnaire survey in 2016 to collect information on HKIS members who practiced in the project management field. The report will be retrieved and updated for further study.



## Public and Social Affairs Committee

Chairlady: Sr Winnie Shiu

The Public and Social Affairs Committee was formed to identify those public matters that may enhance the HKIS's public image and/or improve its public relations. It held its first and second meetings on 12 March and 11 June, respectively.

The brand new corporate and explainer videos for the six divisions and YSG have been launched and uploaded to the HKIS's Facebook and YouTube accounts. Members are welcome to share the videos with their friends and colleagues to let them know more about the role of surveyors and the HKIS.

The Committee, in collaboration with the Education Bureau's Business School Partnership Programme (BSPP), will organise a cross-division career talk at the Surveyors Learning Centre on 8 November 2019 for secondary school students. Thematic talks will also be offered to secondary schools when requested.

In view of enhancing the publicity of the HKIS, a series of activities has been planned including luncheons with different media outlets, press conferences on policy addresses or topics relating to the surveying profession, and ongoing pitches for media interviews.



## Research Committee

Chairman: Sr Prof Eddie Hui, MH

The Research Committee wants to initiate and devise research projects for the General Council's consideration. The Committee also vets research proposals from each division and recommends the best ones to the Executive Committee for its formal approval. The Committee last met on 20 June.

The 2018 HKIS Outstanding Final Year Dissertation Awards Presentation Ceremony was held on 5 June (in conjunction with the HKIS Diploma Presentation to newly-qualified members). Executive Summaries of the winning papers had been published in previous issues of *Surveyors Times*. Currently, the 2019 Awards are being organised. The nominated dissertations/ theses will be judged by qualified assessors and all results will be announced by December 2019.

The Committee recommended, with the Executive Committee's endorsement, that the PFMD conduct a six-month (May-October 2019) research project named, 'A Study on the Use of Building Information Modelling in the Property/Facility Management Industry in Hong Kong'.



## Senior Members Committee

Chairman: Sr Prof WONG Bay

The purpose of establishing the Senior Members Committee (SMC) is to allow older members (working, semi-retired, or retired and aged 60 or above) to maintain strong links and close communications with the Institute.

Senior members have long provided invaluable services to the surveying profession and made significant contributions to the Institute. It wants to ensure that they will not be forgotten as they wind down their careers. The SMC will assume the role of arranging and facilitating social events for the purpose of allowing senior members and the HKIS to continue communicating with each other. It wants its senior members to pass on their experiences, along with their embodiment of the history and culture of the Institute, to their younger fellow members in all divisions including YSG.

The SMC held two committee meetings in April and July to debate and re-affirm its objectives and vision. Members brainstormed activities that would be suitable for integrating both older and younger members. They agreed that the SMC should continue to invite past presidents to share

their experiences during CPD talks or site visits and plan to host two such sharing sessions each year. A visit to Joyous Living at the Tanner Hill followed by a talk by Sr Marco Wu Moon-hoi, GBS, SBS, Past Chairman of the Hong Kong Housing Society, on his career in Hong Kong's housing industry, the mismatch in housing supply with respect to the city's demographic changes over the years, and the challenges that lie ahead were arranged for 20 July 2019.





## Strategic Planning Committee

Chairlady: Sr Winnie Shiu

The Strategic Planning Committee, comprising representatives of the six Divisions and YSG, was formed to review the direction and goals of the HKIS, develop a strategic direction for the Institute, and recommend to its General Council the ones to implement.

The Committee held its first meeting on 19 March. The key issues discussed included:-

The tenancy of the HKIS Office Premise - The tenancy agreement for the HKIS Office at Wing On Centre has been renewed for a further 3 years from 1 January 2019 to 31 December 2021. The Committee proposed that a Task Force is formed in early to mid-2020 to review the office accommodation and study the options for lease renewal or re-location.

The Committee proposed a review and to plan in advance the goals of the Institute for the next council year, for discussion at the next HKIS Retreat to be conducted in 2020.

## Task Force on Lantau Tomorrow

Chairman: Sr Winnie Shiu

The Lantau Tomorrow Professionals Concern Group ("Concern Group") chaired by the Hon Sr Tony Tse and consisting of representatives from the HKIA, HKILA, HKIP and HKIS, was formed in 2018, to follow up with the Government's Lantau Tomorrow Vision as launched by Chief Executive, Mrs Carrie Lam in her 2018 Policy Address. The President and Senior Vice-President represented the HKIS in the Concern Group.

In the General Council meeting on 31 January 2019, it was proposed to form a Task Force on Lantau Tomorrow to be led by Senior Vice-President, Sr Winnie Shiu, and comprising representatives from the six Divisions and the Young Surveyors Group. The Task Force would replace the Task Force on Lantau Development with the imminent task of studying the information on the Lantau Tomorrow Vision together with the views provided by the Lantau Tomorrow Professionals Concern Group in 2018 for preparing questions for the Secretary for Development at the Joint Institutes Forum on 1 March 2019.

Subsequent to the Joint Institutes' Forum, the Task Force also provided its input on the following issues:-

- Compiled a list of views on Lantau Tomorrow Vision for submission to the Lantau Tomorrow Professionals Concern Group on 8 March.
- Reviewed the Concern Group's joint draft letter to the Secretary for Development relating to the Proposed Study on Lantau Tomorrow. The joint letter, enclosing the views of the 4 Institutes, was issued on 1 April.
- Reviewed the paper on "Studies related to Artificial Islands in the Central Waters" for providing comments to the Panel on Development Special Meeting on 13 April 2019. The HKIS supported in principle for the Government to conduct a consultation study.

Reviewed the Government's paper to the Public Works Subcommittee of Finance Committee (PWSC) on Studies related to artificial islands in Central Waters, provided by the Lantau Tomorrow Professionals Concern Group. The HKIS submitted its comments to the Concern Group and made a formal submission to the Hon Sr Tony Tse for the PWSC meeting discussion on 17 May.



Working Group - The Best Development and Conservation Award

Chairlady: Sr Winnie Shiu

To echo the United Nations General Assembly's Sustainable Development Goals from a local perspective, to promote the surveying profession and recognise surveyors' contributions to development and conservation, and to display their best development and conservation projects, the General Council endorsed launching an award titled the 'Best Development and Conservation Award'.

This Award is the first of its kind and shows the Institute's commitment to building a better community for Hong Kong and the world from now into the future. It aims to honour those outstanding projects in development and conservation to which HKIS member(s) have contributed, enhance the HKIS's professional and public image, and arouse the public's awareness of conservation in development projects.

Preparations for the award were kickstarted on 23 May with the endorsement of the terms of reference by the organising committee. The launch ceremony/briefing session is scheduled for the fourth quarter of 2019, while the award ceremony will occur during the third quarter of 2020.





## IVSC Advisory Forum Working Group Meeting

An IVSC Advisory Forum Working Group meeting was held from 17-18 June in London. The notes of the meeting are summarised as follows:

- 1. Sir David Tweedie, the Chairman of the Board of Trustees, will retire at the end of the year. He reported that three-quarters of IVSC members use IVS. The technical writers of IVS/USPAP and CUSPAP are working to harmonise the document so that the standards of the above three organisations could be aligned. Technical writers will make quarterly updates to keep each other informed of any proposed change to their standards.
- 2. Increasing funding for the IVSC is still the main role of the Board of Trustees, which hopes that this will allow for the hiring of more full-time staff and leasing of more office space. The publication of the Financial Instruments papers should help secure more funding from the bank.
- 3. There has been a continuous increase in membership numbers to the current 135.
- 4. The Business Valuation Standards Board reported that it has finished the new standards on non-financial liability and development stage companies. It will now focus on standards for inventory, cryptocurrency, and trophy assets. The Tangible Assets Standards Board is studying the topic of "social value" and seeks more position papers to post on the IVSC website.
- 5. The Financial Instruments Standards Board is working on a consultation paper that will be published in the near future.
- 6. The Membership and Standards Recognition Board reported that it will list the best practices for organisations that want to participate. It also wants to connect new valuation professional organisations (VPOs) with their mature counterparts. The Board is working on the current adoption mark.

- 7. Some VPOs expressed concern over the diminishing number of new members in the valuation profession.
- 8. The IVSC's AGM will be held from 7-9 October in Singapore.



## Hong Kong Business Valuation Quality Initiative Consultation

The IVSC, along with other organisations, invites feedback on the consultation paper, "Proposed Standards and Professionalism Framework for Business Valuation in the Hong Kong Market". The HKIS is a member of this Hong Kong Business Valuation Quality Initiative Task Force (other members include, but are not limited to, the RICS, HKICPA, CFA Institute, HKINEDA, CHKLC, along with the SFC and FRC as observers), which was set up in early 2019 to develop a framework for the Hong Kong market to help elevate its members' standards and professionalism. The "task force" is interested in the responses of HKIS members to the 14 questions set out in this Paper and welcomes any other comment with regard to it. Please submit your comments to comments@ivsc. org by Friday, 15 November 2019. ## CPD: Roles and Duties of **Expert Witnesses Giving** Evidence in the Lands Tribunal on Property Valuations (Code: 2019122)

Sr Alnwick Chan, Sr Louisa Yip, and Sr Jonas Wong conducted the above-titled CPD on 26 June, which was attended by over 100 members and probationers. The speakers stressed, inter alia, the importance of training and having a thorough understanding of the Ordinance as it relates to the valuation issues in dispute before one assumes the position of valuation expert in any litigation proceeding. The presenters highlighted a number of cases during the event to demonstrate the importance of adhering to the "Ikarian Reefer Rules" and observing the following Ten Commandments for Experts:

- 1. Do not say what you would have done under the circumstances, but explain the standards of conduct for your profession.
- 2. Do not be a soldier for your side.
- 3. Do not show off.
- 4. Do not be dragged into areas outside your area of expertise (don't be a know-it-all).
- 5. Do not be tempted to diversify outside your own area of expertise.
- 6. Do not rely on your fame if you are famous. Instead, do the necessary work.
- 7. Do not be over-optimistic in your initial report.
- 8. Do nothing that will cause your counsel to look away.
- 9. Do leave the advocacy to your counsel.
- 10. Do push for an early meeting with your solicitor and counsel.


#### HKIS GBA Visit

## Property Management Service Ordinance

The Legislative Council's Panel of Home Affairs (hereafter the Panel) discussed two LC Papers [Nos.CB(2)1662/18-19(01) and CB(2)1662/18-19(02)] on 24 June. The papers concerned the licencing regime proposed by the Property Management Services Authority (PMSA). Members of the Panel noted that under the Property Management Services Ordinance (PMSO, Cap.626), a property management company (PMC) had to fulfill all of the licencing criteria, including the minimum number of employees holding property management practitioner (PMP) licences, the company's suitability to hold a PMC licence, etc., which the PMSA would set out in the subsidiary legislation to enact the licencing regime.

Panel members generally considered it necessary for the PMSA to strike the right balance between the regulatory requirements and facilitating the development of the trade to formulate its proposals. However, members also noted a lack of licencing criteria in terms of academic and professional qualifications, along with work experience, in the draft, Property Management Services (Licencing and Related Matters) Regulation (Cap.626 sub. Leg. B), which the PMSA submitted to the Panel. Thus, members urged the PMSA to consult the trade as soon as practicable in respect of the licencing criteria and allow ample time for the trade and authorities to reach a consensus before submitting the relevant subsidiary legislation to LegCo for scrutiny. The PMSA followed up on this and took into account the views of all stakeholders concerning the draft's subsidiary legislation's finalisation.

To gauge the views of different stakeholders, the PMSA will hold separate briefing sessions on the proposed licencing regime for the property management industry on 8 and 12 August 2019. Members are welcome to join these sessions to reflect their views and let the PMSA understand the industry's mode of operation so that it could formulate a practical licencing regime that will benefit both HKIS members and the property management industry.

## Research Project

The PFMD has commissioned the Hong Kong Polytechnic University to conduct a research project - A Study on the Use of Building Information Modelling in the Property/Facility Management in Hong Kong. In order to collect the opinions of PFMD members on the barriers to and enablers of the use of BIM, a questionnaire survey will be sent to them. I seek members' kind assistance in completing the questionnaire when they receive it. After that, the survey data will be analysed to identify BIM's major barriers and enablers.

## Mutual Recognition of Membership with the RICS

After the Memorandum of Mutual Recognition with the RICS was signed on 11 April, the HKIS has received many enquiries and applications from RICS members who have qualified as chartered facilities management surveyors for admission as professional members of the PFMD. Professional interview panels have been arranged to verify the applicants' professional competence and suitability for admission into the Division, which wants to recruit more highcalibre and experienced RICS members to expand the HKIS's catchment in the PFM surveying practice.

## Visit to a CIMC MiC Manufacturing Plant in Xinhui (6 July 2019)

The HKSAR Government's Development Bureau is promoting the use of modular integrated construction (MiC) as an alternate form of building construction in Hong Kong. As propagated, MiC is one of the most efficient and complete principles for improving construction productivity because it facilitates the complete offsite manufacture of modules made of multiple units, including internal finishes, fixtures, and fittings, before these units are transported for installation onsite in a Lego-like manner.

In collaboration with the HKIS MiC Committee and BSD, the QSD was invited to view a CIMC MiC manufacturing plant in Xinhui on 6 July. The QSD will organise visits to the same plant after further meetings with CIMC.

As a business division of the CIMC Group, CIMC Modular Building Systems (CIMC MBS) specialises in technology and the manufacture of steel MiC. Since its establishment in 2004, CIMC MBS has become one of the largest providers in this field anywhere. With its innovative designs, patented building technology, and over 30 years of manufacturing experience and technologies, CIMC regaled the HKIS delegation on its services, which included product design and consultation, material suggestion, extensive global procurement and supply chain management, cross-operational management between onsite and offsite activities, a global shipping and logistics network, etc.

At present, CIMC MBS has delivered about 40 projects in the UK, Australia, USA, China, Japan, the Netherlands, etc. The building types it has worked on include hotels, residences, student accommodations, mine workers' accommodations, and commercial buildings. In 2018, it completed its first project in Hong Kong,

the CIC MiC Demonstration Centre in Zero Carbon Building, which was also Hong Kong's first MiC project. It jointly developed this project with the Construction Industry Council (CIC).

The delegation found the visit very fruitful and informative. The knowledge its members acquired together with the information collected from their earlier visit to Singapore at the beginning of this year will be published as a report for circulation to members.





## HKIS Feature Article No. 2 Integrity Requirements – Conflict of Interest (CoI) and Confidentiality

In view of the work nature and trade practices, a surveyor may from time to time encounter CoI situations and possesses confidentiality information in the course of discharging his/her professional duties. As revealed in past ICAC cases, CoI and confidential information, if improperly handled, could lead to abuse and even bribery offences. This article aims to highlight the associated risks and recommend practical ways to manage CoI and protect confidential information, and should be read in conjunction with the appropriate provisions of the Institute's Rules of Conduct.

#### **Dos and Don'ts**

- 2. When handling Col and confidential information, a surveyor should
  - avoid Col as far as practicable;
  - declare the Col, if unavoidable, to the employer and/or client;
  - seek the employer's and/or client's instruction on how the declared Col could be mitigated; and
  - comply with internal rules and/or contractual requirements for the safekeeping of confidential information.

- To ensure professionalism and to avoid misconduct or abuse, a surveyor should NOT –
  - misuse his/her position in the company or abuse the power entrusted with him/ her to make personal gains or to benefit his/her relatives, personal friends or other associated parties; and
  - disclose any confidential information to other parties without the permission of the employer and/or client.

#### **Surveying Companies' Codes of Conduct**

- To adopt good practices, surveying companies should incorporate in their codes of conduct the following requirements for the compliance of staff, including -
  - providing work-related examples on Col for reference by staff;
  - prescribing procedures and schedule of authorities for handling the Col so declared;
  - classifying information according to the level of confidentiality, with access right of individual staff assigned on a "need to know" basis;
  - setting out measures for safekeeping confidential information such as electronic encryption; and
  - requiring staff to sign an undertaking on keeping confidential information in strict confidence.

#### What is Conflict of Interest (Col)?

A Col arises when a surveyor's private interests compete or conflict with the interests of his/her employer or client, or his/her official duties. It could lead to divided loyalty, or even cause corruption or fraud. Below are some examples of Col situations faced by surveyors –

- a. A surveyor, who is responsible for inviting tenders and recommending contractors for works projects, has financial interest in one of the tenderers.
- b. A surveyor of a main contractor, who is responsible for assessing payment applications from subcontractors, undertakes part-time work (e.g. preparing interim payments) for a subcontractor under his management.
- c. A surveyor concurrently provides services on the same project to two parties with conflicting interests.
