# PRESIDENT'S MESSAGE

t our AGM on 9 December, I will be passing the torch and wish my successor well. The honour of serving as your President has far outweighed all the challenges I encountered during my tenure. May I take this opportunity to extend my sincere thanks to all Office Bearers, members of the General Council, Executive Committee, the Divisional Councils, the Boards, Policy Panels, the many Committees, Task Forces and Working Groups, and the Secretariat Office for providing unfailing support to me, and to the Institute, in fulfilling our vision.

Whilst completing my journey as your President, I am happy to feel the city's pulse pounding again, evidenced by the more than 35 events I was invited to or attended in the month.

#### China national affairs programme

A course on China National Affairs designed for the Architectural, Surveying, Planning and Landscape functional constituency and the Hong Kong Institute of Engineers kicked off on 22 October. It covered the macro views and the fundamentals of national development, with insight and guidance in professional career development from Mainland experts, government officials and industry leaders. I had the pleasure to meet the first intake of 30 young professionals, eight of whom were HKIS members.

#### **Expert centre to solve problems**

The Building Surveying Division launched its pilot scheme for resolving issues and disputes, namely the Building Affairs Expert Determination Centre (Pilot Scheme), at a press conference on 3 November. It draws on surveyors' professional knowledge of buildings and promotes the engagement of their expertise to resolve building-related technical issues or disputes in private properties. To start, the centre will focus on four main issues relating to: water seepage; decoration or fitting-out works; repair and maintenance works for existing buildings (except disputes on the handover status of new flats or commercial units); and liability of unauthorised building works. A BSD subcommittee will manage the centre.

One of its chief aims is to bring a fair and highly efficient platform to the public by giving them access to specialist resources such as professional assessment and single-expert determination in dispute cases — and at less cost and time than litigation.

# HKIS Annual Dinner makes a glorious return

Our first annual dinner in two years was held on 8 November and the turnout was exceptional. It speaks for itself but I, for one, was grateful it was so wonderfully supported. Our distinguished guests, sponsors, members, and professionals from different sectors gathered at the Grand Hyatt under proper social distancing. I spoke briefly, highlighting accomplishments in public policy participation, professional image promotion, external collaborations and talent development, among other things. Also, we had the pleasure of officiating the installation of

#### Finger on the pulse

Our Surveyors' Luncheon Talks also resumed, on 11 November at the World Trade Centre Club. Our new Honorary Fellow, Mr Lam Saihung, drew 100 people to hear him speak on Hong Kong's edge in aviation and shipping as well as how infrastructure pushes development.

Twenty Institute members took up a Water Supplies Department invitation to visit the Ex-Sham Shui Po Service Reservoir on 16 November. Rated Grade 1 historical building status in June 2021, the ex-reservoir was an amazing structure for a CPD activity. The guided tour allowed us to better understand the 100-year history, conservation and heritage of this historic waterworks building.

#### **Lending support to government**

The Institute spares no effort to support government endeavours to improve our city, and so we did here. On 20 October, we took the 90-minute guided tour through "Envisioning Beyond Legacy" at the invitation of the Development Bureau (DevB) and Planning Department (PlanD). Their exhibition displayed the Government's planning and infrastructure achievements and outlined its development directions as well as major planning and infrastructure projects like Lantau Tomorrow.

Two days later, I attended the opening of "Building Safety Week 2022", organised by the Buildings Department at Tsuen Wan's City Walk 1 mall, where innovation and technology in building safety were exhibited.

The HKIS is also involved in the "Strive and Rise Programme" for junior secondary students who need societal support to set themselves up for a stronger, brighter future. The Institute is a participating professional institute and nominated mentor in this collaboration among the Government, business sector and community. Our mentors will share their experience, give insight into their fields and run group activities for participating students. I was at the Central Government Offices on 29 October to witness Chief Secretary for Administration Mr Chan Kwok-ki launching phase one and the students taking their pledge.

# Regular industry collaboration and dialogue

"Bringing Applied R&D to New Heights", a DevB forum with the University-Government-Industry Consortium, shed light on the Government's research and development in construction. I sat in on the sharing session on 4 November, during which MiC, its practice and wider adoption, was discussed.

On 10 November, the Civil Engineering and Development Department and PlanD briefed institute presidents on the design competition under the Study on Artificial Islands in the Central Waters. The competition is being extended to early next year.

I attended the Construction Industry Council's (CIC) third President's Forum on 28 October. Secretary for Housing Ms Winnie Ho Wing-yin spoke about housing policy and the audience shared its views. On 31 October, the CIC hosted a webinar on the Policy Address, with the ASPL presidents all present at Zero Carbon Park to hear government officials speak on policies on

MiC and MiMEP, and other invited guests on Modular Integrated technology in different fields of construction.

#### 國情研修班

專為建築、測量、都市規劃及園境界功能界別以及香港工程師學會設計的國情研修班於 10 月 22 日正式開始。課程涵蓋國家發展的宏觀觀點和基礎知識,並邀請到內地專家、政府官員和行業領袖提供關於事業生涯發展的見解和指導。我非常高興與首批共 30 名年輕專才學員會面,其中 8 名是香港測量師學會會員。

#### 成立專家中心解決樓宇問題

建築測量組於 11 月 3 日舉行新聞發佈會,宣佈成立樓宇事務專家裁定中心(先導計劃),助公眾解決問題及糾紛。中心借助測量師的專業樓宇知識,協助解決與樓宇有關的技術問題或私人物業的糾紛。

中心將重點關注以下四個主要問題:滲水、裝修工程、現有樓宇維修及保養工程(但不包括有關新公寓或商業單位移交狀況的爭議),以及違例建築工程責任。樓宇事務專家裁定中心將由建築測量組委員會負責管理。

中心希望為公眾建立一個公正及高效率的平台, 向其提供比起訴訟更有效及更具成本效益的專業 資源,例如針對樓宇糾紛提供專業評估及單一專 家裁定流程。

#### 香港測量師學會週年晚宴隆重回歸

另外,20名學會會員於11月16日應水務署邀請, 參觀前深水埗配水庫。這座前配水庫於2021年6 月獲評為一級歷史建築,實在令本會的持續專業 發展項目活動更精彩。導賞團讓我們得以深入了 解這座歷史悠久的水務廠房之百年歷史、保育工 作及文物價值。

#### 鼎力支持政府工作

在學會事務以外,我們亦不遺餘力支持政府為改 善城市環境而作出的努力。10月20日,我們應 發展局和規劃署邀請,參加為時90分鐘的「繼往 創未來」展覽導賞團。是次展覽展示了政府在規 劃及基建方面的成果,並概述政府未來的發展方 向,以及明日大嶼等主要規劃及基建項目。

兩天後,我亦出席了屋宇署於荃灣荃新天地一期 舉辦的「樓宇安全周 2022」開幕典禮,當中展出 樓宇安全的創新科技。

香港測量師學會亦有參與「共創明『Teen』計 劃丨,務求扶助需要各界力量以助向上流動的初 中學生。學會是其中一個參與計劃的專業機構, 並為是次政、商、民三方的協作計劃提名友師。 我們的友師將會分享經驗,深入他們的專業領域, 並為參與學員舉辦小組活動。10月29日,我出 席了假座政府總部的啟動禮,當中政務司司長陳 國基先生宣佈計劃第一期正式啟動,而學員亦一 同承諾積極參與計劃。

#### 定期的行業合作及交流

「應用研發闖高峰」是發展局與大學/政府/業界 三方聯盟合辦的建造研發論壇,旨在探討政府在 建築領域的研發工作。我參加了11月4日的分享 會,當中討論到組裝合成建築法 (MiC)、相關實 踐及更廣泛的採用。

土木工程拓展署及規劃署於 11 月 10 日向各學會 會長就中部水域人工島設計比賽進行簡介。比賽 將延至明年初開始。

10月28日,我出席了建造業議會第三場會長論 壇。當中房屋局局長何永賢女士談論到房屋政策, 觀眾亦有踴躍分享意見。10月31日,建造業議 會就施政報告舉辦一場網絡研討會。一眾建測規 園界的會長聚首建造業零碳天地, 聽取政府官 員關於組裝合成建築法 (MiC) 和機電裝備合成法 (MiMEP) 的政策演講,而其他受激嘉賓亦探討了 不同建築領域的組裝合成技術。

值得一提的活動多不勝數,但由於篇幅有限,最 後僅以兩個活動作結 — 規劃師學會、廣東省國土 空間規劃協會及澳門城市規劃學會於 11 月 7 日在 中環街市合辦的「大灣區規劃大獎 2022 | 展覽進 行開幕儀式,而發展局文物保育專員辦事處聯同 古物古蹟辦事處亦於 11 月 9 日舉辦了「大灣區文 物建築高峯論壇一。

最後,我冀望大家繼續敞開心扉,迎接持續變化 的環境和不斷進步的社會:這種積極態度將使我 們有能力應對挑戰並共創繁榮。團結就是力量。 我在此祝願學會及測量界透過團結及可持續發展 獲得成功。

Today, surveyors are finding themselves relying a lot more on innovative technology, with cloud computing, big data and virtual reality enabling them to do their jobs more effectively. In this cover story, Sr Patrick Leung, Council Member of the Property & Facility Management Division of the HKIS, and Sr Junior Ho, Honorary Secretary to the Planning and Development Division of the HKIS, tell us about how technology plays a big part in driving their initiatives.

#### Achieve sustainability goals with digital transformation

According to Sr Leung, who is also Head of Facilities Management for Hong Kong and Macau at DFI Retail Group, the integration of cloud computing, big data and the Internet of Things (IoT) has transformed the way assets, properties and facilities are managed, maintained and serviced. DFI Retail Group is member of the Jardine Matheson Group and a leading listed Pan-Asian multi-brand retailer. To better keep track of assets and monitor maintenance history while reducing carbon footprint, the group has deployed smart asset and energy management solutions across its operations.

"For a large retail group like DFI managing over 1,800 stores, including convenience stores, health and beauty stores, and supermarkets, we need to keep track of over 50,000 items of fixed and moveable assets. IoT devices that are seamlessly integrated with our enterprise asset management platform help us achieve the accuracy and efficiency needed to manage their lifecycle and improve operational efficiencies," he says.




Figure 2 – "MyFM" is one of the tools that facilitates communication between each store and all DFI stakeholders to review and monitor all planned and reactive maintenance requests.

"Barcode-driven asset tagging is nothing new and, these days, QR codes (Figure 1) are more common as they can store more information. When combined with a cloud inventory tracking platform, we can realise multiple benefits. For example, the platform (Figure 2) can provide store or facilities managers with automatic maintenance and procurement alerts and assign repair tasks to contractors. It also lets our teammates quickly compile reports on asset usage and status."

Procurement managers can quickly and easily check what status all assets are in, no matter which store they are installed in, by accessing various databases. They can see maintenance records and decide whether replacements are required. This allows them to order in bulk and negotiate better prices with vendors, he explains.

Decarbonisation is another driver for digital transformation. Across the retail group, multiple tech-driven initiatives have been undertaken to reduce energy consumption and carbon emissions from operations. Adding cooler curtains to keep cold air inside display refrigerators is a simple yet effective measure implemented.




Figure 3 – As many as nine energy saving measures are deployed in a typical DFI store in Hong Kong.

Retrofitting equipment (**Figure 3**) to reduce energy consumption is among other measures that the group is taking towards decarbonisation goals. HCFC-22 (R22) is a high-capacity refrigerant employed in many medium- and low- temperature refrigeration systems. The group's R22 refrigeration systems are currently being retrofitted to R448A, which boasts higher energy efficiency and reduced compressor discharge temperature at medium and low temperature conditions.

IoT-enabled systems are also able to help improve the energy performance of refrigerators, air-conditioners, and lighting. According to Sr Leung, IoT sensors are implanted in various types of equipment to collect their operational and energy consumption data for analysis, so as to optimise the balance between performance and energy consumption.

As another decarbonisation initiative, a smart chiller energy system has been piloted in some stores to analyse the temperature of air-cooled chillers. Whenever there is room, the system reduces the loading on the compressor while keeping the cooling range within the required temperature parameters.

"We've verified the effectiveness of the smart chiller energy system with a proof-of-concept before, which shows that it's an economically viable investment. We're planning to extend it to other stores and back-of-house facilities, including offices and warehouses," says Sr Leung. He adds that leakage detection solutions have been deployed to monitor at-risk locations or existing stores. In new stores, however, there is no need

to install a gas leakage system as a low global warming potential (GWP) system (with a GWP lower than 1,500) was already selected during design stage based on the input of the facilities management team.

Defrosting in supermarket refrigeration systems is normally controlled by a pre-set time cycle with most display cabinets timed to defrost every interval. But according to Sr Leung, the group has switched to a demand defrost control system which defrosts the evaporator coils when sufficient frost has formed to adversely affect their performance would lead to both better temperature control and considerable energy savings.

And last but not least, energy submetering devices are put in place to accurately and timely measure and report energy performance of different types of equipment. "We have an advanced and centralised energy monitoring system that is accessible to all levels of operations and enables in-depth analytics on the performance of individual stores, district-wide, and the group as a whole."

"In the quest for energy efficiency, we think about the largest energy wasters first and then tackle the smallest ones. Using this strategy can help achieve cost savings, reduce our emissions, and contribute to creating a low carbon economy," he says.

The Government's goal of a net zero carbon economy, along with policy and funding support for private companies that research green technology, is driving their efforts to decarbonise. He says Jardine Matheson is willing to work with start-ups and support them as they test out various solutions. This has been seen in their Hack. Asia, an annual entrepreneurship programme hosted by the conglomerate. If proven to be successful and cost efficient, then they will try scaling it up and see if they can extend the partnership to other affiliate companies.

# Elevating public engagement experience

As Hong Kong enters a new phase of development, from ongoing redevelopment in the existing urban area to the Northern Metropolis

blueprint, the Government is keen to engage the public in more engaging ways on how the future of our built environment is envisioned. The use of virtual reality (VR) and augmented reality (AR) is on the rise in town and project planning, especially when it comes to community engagement, says Sr Ho.

A recent example he cites is The City Gallery managed by the Planning Department. The exhibition showcases the vision for Hong Kong's city planning projects and acts as a platform on which to engage and inform the public about the sustainable urban future. Visitors can experience interactive and VR-based exhibits inside.

Another example is the public engagement activities organised by the Civil Engineering and Development Department to collect public views on the implementation direction of the cycle track between Tsuen Wan Bayview Garden and So Kwun Wat. As well as a workshop regarding the proposed Sham Tseng promenade to understand the needs of local residents and amass community views, the CEDD has also staged roving exhibition at different locations and offer VR cycling experiences to give the public a taste of the future cycle track and enjoy the scenery along the route.

"VR and AR technologies can help surveyors and planners visually represent the way a project design would look in various settings, so that even the public could easily how it would look in their neighbourhoods. In other words, community members and stakeholders can visualise spatial data in an intuitive and interactive way using VR, which is valuable because it helps the user to conceptualise the details in the space around them."

There are plenty of uses for AR in the building and construction sector. During construction, AR can assist workers in identifying and planning around existing utilities such as electricity, gas and sewage. Contractors working on public works can also use AR to call up data on-site to detect possible hazards. AR is not only useful for envisioning observable changes, but also for foreseeing and planning around potential issues in infrastructure.

"In the future, when we have access to more geospatial data integrated with climatic and topographic data, we can do a better job in planning and designing by assessing environmental factors better that could impact the plan. This can help us make better decisions on building physics and geometry during the early design stages to maximise thermal comfort and natural ventilation and reduce cooling load requirements, ultimately improving building energy performance.



# 創新科技助力實現可持續 發展目標、提升持份者參與度

隨著科技日新月異,測量師也越來越依賴創新科技如雲計算、大數據和虛擬實境等以更有效地執行日常任務。在今期封面故事中,學會物業設施管理組理事會成員梁展柏測量師及規劃及發展組名譽秘書何誠謙測量師,講述了創新科技如何在推動節能減排和提升項目規劃社區參與度方面發揮重要作用。

#### 數碼轉型實現可持續發展日標

本身為 DFI 零售集團香港及澳門區設施管理主管的梁展柏測量師表示,雲計算、大數據和物聯網的結合,改變了資產、物業和設施的管理、維護和運作方式。DFI 零售集團隸屬於怡和集團,是泛亞地區的大型多品牌零售集團。他表示,集團透過智能環保物聯網解決方案,改進了資產和設施管理的成本效率,並減少了碳足跡。

「集團旗下零售業務眾多,包括便利店、健與美產品連鎖店、超市在內便有 1800 多家分店,需要管理超過 5 萬項固定和移動資產。有見及此,我們在資產管理的不同環節裡安裝了物聯網傳感器,收集即時數據並上載到雲端管理平台中,管理人員可隨時監控資產生命週期,提升運營效率和準確性。」他解釋說。

「從前我們會以條碼標識資產,現時已採用了二維碼(**圖1**),可存儲比傳統條碼更多的資訊,與雲端資產管理平台互動。例如,管理平台能為分店或設施經理提供自動維護和採購提示,直接指派供應商執行維修工作。團隊同事還能隨時檢

閱資產使用情況和狀態報告(**圖2**),無論資產位於任何分店甚至國家,採購部門都可以快速查看狀態和維修記錄,決定是否有需要更換。這樣,採購部可統一向供應商批量採購,取得更好的價格,減低採購成本。|

減少碳排放是實現數碼化轉型的另一大推動力。 據悉,該集團實施多項舉措以減低業務營運的能 源消耗(圖3)。較簡單直接的方案,包括在開 放式凍櫃加裝透明膠簾,將冷空氣保存於凍櫃裡, 而較複雜的工程則包括升級現有設備以降低能 耗。HCFC-22(R22)是一種用於許多中低溫製 冷系統的高容量製冷劑(雪種)。集團目前正將 R22製冷系統改裝為R448A,而後者在中低溫條 件下,具有更高的能源效益和更低的壓縮機排氣 溫度。

此外,物聯網系統還能幫助提高雪櫃、冷氣和照明系統的能源效益。梁展柏測量師表示,集團已將物聯網傳感器安裝於不同設備中,以收集其運行和能耗數據並加以分析,最佳化設備控制模式,降低用電量。舉例說,集團某些分店已試行智能冷水機組能源系統,分析並智能化操控風冷式冷水機組的溫度。只要室內環境條件合適,系統自動減少壓縮機的負載,將冷氣範圍保持在舒適的範圍內。

「我們已透過 POC 驗證了這套智能冷水機組能源系統的技術和經濟可行性,正計劃將其引進到其他分店和後勤設施,包括辦公室和倉庫等。」他補充説,集團亦已在冷凍系統高風險位置或現有

分店裝配了洩漏檢測解決方案,以監測製冷和其他關鍵組件的洩漏風險。然而,新店的系統設計已按照設施管理團隊的意見,選用了低全球變暖潛能值(GWP)系統(GWP值低於1,500),故新店並沒有需要安裝氣體洩漏檢測系統。

超市製冷系統中的舊式除霜功能,通常由預設的時間週期控制,即是說,凍櫃定時每隔一段時間會進行除霜一次。梁展柏測量師表示,集團已改用按需除霜控制系統,當蒸發器盤管形成足夠的霜凍對其性能產生不利影響時,系統將對自動進行除霜,從而更好地控制溫度以及節省用電。

「我們為不同設備安裝了能源分錶,測量和上報各電氣裝置的耗電量。各級管理人員可登入中央能源監控系統,了解各分店、分區以至整個集團的用電情況。可以說,我們在追求節能的過程裡,會先從耗電量最大的電器設備著手,深入研究細小的節能空間,此舉除可減低電費開支外,更重要的是集團作為一家負責任的企業,能為減排作出貢獻。|他説。

他表示,政府制定了實現淨零碳經濟的目標,並為研究綠色創新技術的公司提供政策和財政支持,對企業實現低碳轉型有莫大鼓勵。怡和集團對初創企業非常開放,願意與他們合作,讓他們於集團旗下公司營運測試創新解決方案,而集團每年舉辦的 Hack.Asia,正是創初實地試驗其創新方案的理想場合。如果方案被證明在技術上和經濟效益上可行,將被擴大到其他分公司,深化合作。

#### 提升公眾參與體驗

從正進行得如火如荼的市區重建項目,到未來北部都會區的發展藍圖,香港市區發展正進入新階段。何誠謙測量師認為,政府非常樂意採用嶄新技術,例如虛擬實境(VR)和增強實境(AR)等互動媒體,加強公眾參與度,讓市民更深入了解香港未來的城市發展藍圖。

他舉例說,由政府規劃署設立的「展城館」,展示了政府對香港未來城市發展的願景,讓公眾深入淺出地認識香港城市規劃,其中包括不同主題的互動和虛擬實境體驗。再如近月由土木工程拓展署舉辦公眾參與活動,收集市民對新界單車徑荃灣灣景花園至掃管笏段的意見。該署除了就擬建的深井海濱長廊舉辦工作坊外,還在不同地點舉辦巡迴展覽,並提供虛擬單車體驗,讓公眾體驗未來的單車徑,欣賞沿途風景。

「現時,測量師和規劃師可借助 VR 和 AR 技術, 更直觀與全面地將設計方案呈現給客戶和公眾, 市民能了解項目落成後對社區的正面影響。透過 讓公眾參與規劃過程,城市可以創造更宜居、可 持續和公平的地方,意義重大。」

AR 在建築領域亦能發揮很大作用。舉例說,在施工期間,AR 可以協助施工人員定位基礎設施,例如電纜、供氣和排水管道。工務工程承包商亦可以利用 AR 來檢測施工現場可能存在的危機。換句話說,AR 不僅有助於可視化可觀察到的變化,還可用於預測正規劃中基建設施的潛在問題。

「未來,當我們能夠獲取更全面結合氣候和地形數據的地理空間數據時,規劃人員將能夠更準確地了解地理和氣候等環境因素,如何影響規劃中的發展項目,從而設計出更切合地形和氣候變化的建築方案,使樓宇環境溫度更加舒適,降低冷氣用電需求,進而提高建築物的能源效益。|

# 发展绿色建筑 推进节能改造——各地多举措助力建筑领域节能减排

发展绿色建筑,关系著低碳节能,关系著可持续发展。党的二十大报告提出,积极稳妥推进碳达峰碳中和,立足我国能源资源禀赋,坚持先立后破,有计划分步骤实施碳达峰行动。近期,北京、重庆、贵州、海南等地发布相关政策,以创建建筑节能与绿色建筑为抓手,多措并举,深入开展绿色建筑节能减排,为实现碳达峰、碳中和目标奠定坚实基础。

#### 推动重点领域低碳发展

建筑业作为国民经济重要支柱产业之一,是实现 碳达峰、碳中和目标的重要一环。绿色建筑能为 人们提供舒适的生活居住环境,建筑领域要想整体实现碳中和也离不开绿色建筑。

为了推动重点领域低碳发展,提升生态系统碳汇能力。北京市在日前印发的《北京市碳达峰实施方案》提到,新建政府投资和大型公共建筑执行绿色建筑二星级及以上标准,到 2025 年,新建居住建筑执行绿色建筑二星级及以上标准,新建公共建筑力争全面执行绿色建筑二星级及以上标准。推广绿色低碳建材和绿色建造方式,进一步发展装配式建筑,到 2025 年,实现装配式建筑占新建建筑面积的比例达到 55%。积极推广超低能耗建筑,到 2025 年,力争累计推广超低能耗建筑规模达到 500 万平方米。

按照碳达峰目标和阶段性要求,完善低碳建筑标准体系,加快修订公共建筑节能设计标准和农宅抗震节能标准等节能减碳标准。建筑领域因地制宜推广太阳能光伏、光热和热泵技术应用,具备条件的新建建筑应安装太阳能系统,新建政府投资工程至少使用一种可再生能源,其中,新建公共机构建筑、新建园区、新建厂房屋顶光伏覆盖率不低于50%。提高炊事等电气化普及率,开展产能建筑试点。

建立既有建筑绿色改造长效机制,结合生命周期

管理,在城市更新中持续推进建筑节能改造,到2025年,力争完成3000万平方米公共建筑节能绿色化改造。健全建筑拆除管理。加快推进农房节能改造,提升农房设计建造水平,推广使用绿色建材。

#### 加强既有农房节能改造

推动农房绿色低碳发展有利于延长农房使用寿 命,强化节能减排,有利于改善农房舒适性和安 全性。日前,贵州省发布的《贵州省城乡建设领 域碳达峰实施方案》,提出推进绿色低碳农房建 设。提升农房绿色低碳设计建造水平,建设满足 乡村生产生活实际需要的新型农房,完善水、电、 气、厕配套附属设施,加强建筑节能材料向乡村 推广,提高农房能效水平,到2030年建成一批 绿色农房,鼓励建设星级绿色农房和零碳农房。 按照结构安全、功能完善、节能降碳等要求,制 定和完善农房建设相关标准。引导新建农房执行 《农村居住建筑节能设计标准》等相关标准,完 善农房节能措施,因地制宜推广太阳能暖房等可 再生能源利用方式。加强既有农房节能改造,推 广使用高能效照明、灶具等设施设备。开展乡村 建设适用技术研究,创新乡村住宅技术体系和现 代乡土建筑体系,提升乡村住宅设计建造与宜居 性能。鼓励就地取材和利用乡土材料,推广使用 绿色建材,鼓励选用装配式钢结构、木结构等建 造方式。

同时,要加强节能改造鉴定评估,编制改造专项规划,对具备改造价值和条件的居住建筑要应改尽改,改造部分节能水平应达到现行标准规定。持续推进公共建筑能效提升重点城市建设,到2030年地级以上重点城市全部完成改造任务,改造后实现整体能效提升20%以上。推进公共建筑能耗监测和统计分析,逐步实施能耗限额管理。

#### 开展超低能耗建筑示范

发展超低能耗建筑,是建筑业低碳转型的重要途径。重庆市近日印发的"十四五"节能减排综合工作实施方案要求,积极开展超低能耗建筑工程示范,探索近零能耗、低碳(零碳)建筑试点。推动商场、医院、学校、酒店和机关办公建筑等既有公共建筑由单一型的节能改造向综合型的绿色化改造转变。到 2025 年,城镇新建建筑 100%执行绿色建筑标准。推进示范创建行动,推进公

共机构新建建筑开展超低能耗建筑、近零能耗建 筑建设。

同时,实施城镇绿色建造。大力推广装配式建筑,推进建筑工业化。开展成渝地区双城经济圈"无废城市"共建。推进城镇新建公共机构建筑、新建厂房屋顶应用太阳能光伏,推动可再生能源建筑规模化应用。到 2025 年,新增可再生能源建筑应用面积 500 万平方米。提升建筑能效水平。分阶段、分类型提高城镇新建民用建筑节能强制性标准。

此外,海南省绿色建筑发展条例也提出,在新建建筑和既有建筑节能改造中,推广使用太阳能、风能、氢能、生物质能、地热能等可再生能源放射、短照要建筑安装太阳能光伏、太阳能光热系统,按照要求与建筑主体工程同步设计、危机、有建筑主体工程同步设计、危力,安装太阳能系统。鼓励绿色建筑执行,更高的建筑节能和碳排放标准,降低建筑能耗建筑、近零能耗建筑、低碳建筑,推进超低能耗建筑、近零能耗建筑、低碳建筑,,模化发展,鼓励开展零碳建筑示范应用,推动建设零碳示范区,促进产业生态化。

- 3rd Promote best practices of site safety and proactive use of technology, including adoption of Smart Site for Safety System, for continuous improvement in safety
- 4th Work together to enhance communication, provide a safe working environment and targeted safety training for all stakeholders

The HKIS Outstanding Dissertation/Thesis Awards 2021 Executive Summary of Winning Papers

A STUDY OF NEW ENGINEERING CONTRACTS FOR PARTNER RELATIONSHIPS AND PROJECT IMPROVEMENTS

Undergraduate Category: QSD Second Award

Awardee: CHENG Pui Ying, City University of Hong Kong

The construction industry is recognised as adversarial and dispute-orientated. These limitations have consequences. Therefore, a new procurement approach is necessary for changing the adversarial relationships that exist in the industry to achieve better performances.

In recent years, the Hong Kong Government has encouraged the implementation of new engineering contracts (NECs) to promote collaboration between clients and contractors, so as to minimise contractual disputes. Despite success with this practice around the world, Hong Kong remains in its comfort zone of familiarity with traditional contracts. With regards to NEC's unpopularity in Hong Kong, it is important to study if it has improved partnerships and project performances.

In this study, the author investigates the relationships between NEC characteristics and project outcomes based on extensive literature reviews and quantitative analyses. She identifies nine NEC characteristics and seven project outcomes from the literature and groups the characteristics into four categories: specificity, award recognition, flexibility, and team conflict resolution. She further divides specificity into time, cost, quality, clarity, early warning, detailed procedure, and compensation events. She achieves award recognition through the pain/ gain sharing mechanism in the target cost options, which determine a target in advance. Partnering concept, risk management, and value management serve as team conflict resolution mechanisms for resolving disputes.

For NEC outcomes, disputes, time, cost, and quality form the basis of a project's performance. Team performance is achieved by good interpersonal relationships, while organisation performance is achieved by cultural changes and inter-firm relationships.

The above characteristics and project outcomes provide the basis of a questionnaire that the author sent to contractual parties with NEC experience. The results revealed that NEC characteristics had a significant impact on the outcomes, as each NEC characteristic demonstrated a positive relationship with a particular project outcome.

The multiple regression results showed that early warning and compensation events were the most effective NEC characteristics for predicting most project outcomes. This meant that NEC has improved partner relationships and project performances. Although not all partner relationships and project performances are related to every NEC characteristic, NECs can help improve both.

# Undergraduate Category: QSD Second Award

Awardee: WONG Lok Sum, Department of Real Estate & Construction, University of Hong Kong

New Engineering Contract 3 (NEC3) has recently been adopted in Hong Kong's construction projects. It promotes flexibility so that main and secondary option clauses are available to cater to different projects and parties' needs. The Hong Kong Government's Development Bureau (DEVB) is one of the city's largest NEC users. For engineering and construction contracts (ECCs), a type of NEC between an employer and contractor, a library of standard amendments and additional clauses was published in 2017. This has aroused discussions on and possibly controversy over the contractual mechanisms and rationale behind the amendments.

This dissertation aims to review standard amendments and additional clauses that DEVB has proposed, so as to identify key performance indicators (KPIs), evaluate the impacts of amendments and additional clauses on project performance, as reflected by KPIs, and the relationships between them. It also recommends refining the framework for the adoption of NEC3 ECC.

The author identified and categorised key amendments such as compensation events,

which are situations in which a contractor is entitled to time and/or cost compensation. He inserted new reimbursable events, such as unforeseen and unreasonable labour shortages for experienced contractors and prevention measures that arise from employers or others. The proposed amendments were intended to impose restrictions on various entitlements. Events such as inclement weather and labour shortages were entitled to time compensation only.

After identifying the key amendments, the author was able to formulate a framework for measuring project performance in the form of KPIs. Conventional KPIs are cost, time, and quality, while coordination-related KPIs involve risk and supply chain management and operations-related KPIs stress the importance of resource management and legal compliance. The most important indicator category is relationship management, which reflects the significance of NEC3 in building mutual trust and partnering among project parties.

The author believes that ECC may be unable to adapt to environmental changes, while contract drafting and amendments are not the only factors that affect project performance. During a project's operation, the involved parties may be unfamiliar with ECC and differing viewpoints on contract clauses usually arouse conflicts over financial and project management.

The author recommends that the potential implications and impacts on project operations should be thoroughly considered during the formulation and implementation of amendments. Further consultations should be conducted with the public legal sector and all project stakeholders, as they are crucial for balancing stakeholders' interests.





#### A Momentous 2022

This year has been a momentous one for all of Hong Kong with the installation of a new Government cabinet led by Mr John Lee and the celebration of the 25th anniversary of the establishment of the Hong Kong SAR, which ushered in a new era for the city.

As 2022 draws to a close, I am delighted to present a summary of the GPD's main accomplishments since the start of the year.

# Official Launch of the Overview (3rd Edition)

On 25 May, the HKIS launched its third edition of the Overview of the Land (Compulsory Sale for Redevelopment) Ordinance (「強拍條例」概覽).

Overview debuted in April 2009 as a guide to help the general public gain a deeper understanding of the compulsory sale regime. It outlines the basic framework and procedures of compulsory land sales in Hong Kong.

In 2010, the Government ordered the lowering of the compulsory sale application threshold to 80 percent for three lot classes. As a result, the HKIS updated Overview and released its second edition in June 2011.

Given the changes to the regime derived from Land Tribunal cases over the last 11 years, a working group was formed to publish a new edition. The Working Group on the Cap 545 Review (hereafter the WG) streamlined and enhanced the contents to make Overview more easily understandable to the general public.

Other major updates to the third edition of Overview include the following:

- Mediation Obligation between Majority and Minority Owners
- 2. Reimbursement of Litigation Costs by Majority Owners
- 3. Exemption of Stamp Duty for Minority Owners

Moreover, the working group introduced a concise version of Overview in booklet format. It provides simple answers to many common questions asked by affected owners during a compulsory sale case. A press conference was held on 25 May to launch the third edition of Overview and was well-attended by various media outlets. During the conference, the GPD reported on the progress of the then-ongoing policy review, which was being undertaken by the same working group.

# Policy Review of the Land (Compulsory Sale for Redevelopment) Ordinance

During the 2021 Policy Address, the HKSAR Chief Executive proposed lowering the compulsory sale application threshold under the Land (Compulsory Sale for Redevelopment) Ordinance (hereafter the Ordinance).

After six months of hard work, the WG issued its recommendation to the Development Bureau (DevB) on 21 June and held a press conference to discuss its findings on 22 June.

During the course of the policy review, the WG solicited the views of various stakeholders concerning the current compulsory land sale regime. They included the Real Estate Developers Association of Hong Kong (REDA), professional members of the GPD and BSD, and a community outreach organisation.

To examine if the current regime provided adequate protection to minority owners, the WG carried out a study, among others, which featured:

- 1) A Replacement Flat Test
- A Review of Final Offers vs Apportioned Reserve Prices
- 3) A Review of the Objections to Compulsory Land Sales

Based on the findings of the stakeholder engagement and various studies, the WG identified areas for improvement in the current regime and put forward six suggestions to the Government:

- 1. Lower the compulsory sale threshold.
- 2. Review the restrictions on lot applications.
- Establish an appeal mechanism and allocate additional resources to the Lands Tribunal (LT).
- 4. Establish reasonable vacant possession delivery requirements and minimise the impact of missing owners.
- 5. Provide financial assistance to minority owners to protect their interests.
- 6. Enhance the role of surveyors.

The WG supports the Government's proposal to lower the threshold for a compulsory sale application for "three-nil buildings," or buildings that are at least 60 years old, to address pressing problems that arise from the lack of building management and maintenance, especially for buildings with obsolete sewerage systems and outdated means of escape, which pose fire hazards.

By increasing the public's understanding of the compulsory land sale regime, the Government can better safeguard the interests of majority and minority owners. As such, I gave interviews to TVB and Metro Radio to discuss the regime

and promote the significance of surveyors in compulsory sale cases. The TVB interview was aired during its News Magazine programme (《新聞透視》) on 18 June.

For the same purpose, I wrote an article on urban renewal, which was published by the Hong Kong Economic Times on 27 June.

On 19 October, I was pleased to hear the new Chief Executive, in accordance with the WG's advice, propose lowering the compulsory sale thresholds in his 2022 Policy Address. Thus, the application thresholds for private buildings aged 50-69 years would drop from 80 to 70 percent of ownership and further to 60 percent for those aged 70 years or above. For industrial buildings in non-industrial zones, the threshold would drop to 70 percent of ownership for buildings aged 30 years or above.

The Government will also relax the requirements on compulsory sale applications covering abutting lots, streamline the legal procedures for compulsory sales, and set up a dedicated office to provide additional support to affected minority owners.

I recognise the tremendous contributions made by WG members. Apart from myself, members of the working group include Sr Leo Cheung, Sr Dorothy Chow, Sr Ken Chung, Sr Anne Lam, Sr Alvin Leung, Sr Paul MH Li, and Sr Joel Teh.

# Proposed Amendments to the Compulsory Sale Regime

For the purpose of discussion on 22 November by the LegCo Panel on Development, DevB published a paper outlining its proposed amendments to streamline the compulsory sale regime.

The Government is currently undertaking a stakeholder engagement exercise to gauge the public's views on its proposal. It aims to

propose an amendment to LegCo in the latter half of 2023.

# Land Policy Panel

The HKIS Land Policy Panel issued three policy review papers to the Government on the following subjects:

# 1. Unreasonable Car Park Requirements for New Developments

This paper sets out the HKIS's views and concerns over the unreasonable car park requirements endorsed by the Transport Department for new developments, particularly small sites with deep basements.

The document also makes recommendations, including those that modify the Hong Kong Planning Standards and Guidelines, to account for various site areas and building uses, as well as reviews the GFA concession for aboveground car parks with the goal of encouraging developers to build more parking spaces on sites with suitable attributes.

#### 2) Lengthy Planning Approval Process

This study aims to identify areas of delay and problems of "comments" in the planning

approval process before suggesting ways for the Planning Department (PlanD) and Town Planning Board (TPB) to resolve such issues.

### 3) Excessive Requirements of New Tender Sites

This paper reviews the land sale conditions for the: (1) provision of public car park and GIC facilities and (2) different impact assessments over the past three financial years (2019-2022).

A total of 36 tender documents were reviewed including three unsuccessful tenders. The Panel recommends several areas for improvement including building covenant periods and lease covenants pertaining to multi-use facilities such as Government accommodations and public car parks.

I thank all members of the Land Policy Panel who worked diligently to prepare these policy reviews under the direction of Sr CK Lau.

# Remuneration of Professional Fees by Stage Payment

Occasionally, LandsD tenders contracts for the valuation of compensation arising from land acquisitions and resumptions to general practice surveyors in private practice.

According to past consultancy contracts, the Government would only make a full payment when a case concludes. For example, for an LT case, the Government will pay its consultant when the case concludes without an appeal, which could take years. Such an arrangement has caused concern and cash flow issues among many surveyors in the industry.

Along with fellow GPD delegates, I met with LandsD representatives to discuss this matter in 2021. The GPD recommended that the

Government consider stage payments as a possible solution.

In June 2022, the LandsD decided to revamp the payment arrangement and began to implement stage payments for new contracts based on the progress of the consultancy services. This new arrangement is seen as fair and vastly improved over the prior procedure.

On behalf of the GPD, I thank the responsible LandsD assistant director for his wise decision and heeding the views of industry representatives.

# Pop Quiz

Social distancing measures have prevented the GPD from hosting large-scale gatherings since the beginning of the pandemic.

On 20 July, the GPD held an online pop quiz and offered prizes such as cash coupons and/ or whiskey to the winners.

I applaud the organisers, hosts, and HKIS administrative staff for putting together such a fantastic event via Zoom. Particular appreciation goes to Sr Chris Chan, Sr Kason Cheung, Sr Jason CS Chan, Sr Tracy Wong, Sr Cara Ng, Sr Camman Chan, and Ms Sharon Cheung.

# Discussion between DevB and the HKIS

I am pleased to see that DevB has been closely collaborating with industry professionals to advance Hong Kong's future development.

On 2 August, it invited me and other HKIS delegates to exchange views on issues pertaining to the property industry. The meeting was convened by the Secretary for Development, Ms Bernadette Linn.

#### 1) Streamlining Statutory Procedures

I was pleased to hear that DevB would prioritise the streamlining of the statutory procedures. The Secretary also informed attendees that DevB had heeded feedback from various stakeholders during earlier consultation sessions. It intended to submit legislative amendment proposals to LegCo before the end of 2022.

#### 2) Streamlining Administrative Procedures

The Secretary advised that DevB hoped to also streamline administrative procedures next year. She invited the HKIS to submit recommendations to DevB for its consideration. DevB shall consolidate all views from the HKIS, Hong Kong Institute of Architects, Hong Kong Institute of Planners, and the Real Estate Developers Association of Hong Kong before deciding on the necessary changes.

#### 3) Expediting Urban Redevelopment

DevB endeavors to expedite Hong Kong's urban renewal with the help of the URA and private sector. It commended the HKIS for submitting its recommendations following a policy review of the Land (Compulsory Sale for Redevelopment) Ordinance (Cap 545).

During the meeting, I brought up the implication of the Court of Final Appeal's decision in the case of Fully Profit (Asia) Limited vs The Secretary for Justice for and on behalf of the Director of Lands (FACV 17/2012). The "House" restriction in Government leases has led to more uncertainties over redevelopment projects throughout the years and slowed down Hong Kong's urban renewal process. DevB took note of the issue and will address the industry's concerns.

#### 4) Creating Opportunities for Youth

The Secretary also discussed the opportunities for younger Hong Kongers in the city and GBA. The HKIS urged the Government to provide younger surveyors with more opportunities to work in Government projects.

At the DevB's invitation, the GPD submitted the CVs of several young surveying professionals for possible appointment to the Government's various advisory panels, committees, and work groups. The HKIS wishes to collaborate with the Government to mentor the next generation of competent surveyors in Hong Kong.

I express my gratitude to Sr Leo Cheung and Sr Alex Fong of the Education Committee, Sr Jason CW Chan of the HKIS/RICS Working Group, and all voluntary assessors for their contributions over the past year.

The GPD took this opportunity to request more transparent discussions with the Valuation Section on valuation parameters, especially during the appeal process. It also encouraged

# Virtual Site Visit to Trunk Road T2 and Cha Kwo Ling Tunnel (Engineering Survey)

On 12 November, a joint virtual site visit cum CPD occurred. Co-organised by YSG and the LSD, land surveyors from the CEDD and Survey Team of Trunk Road T2 and Cha Kwo Ling Tunnel presented applications of various technologies in relation to both TBMs and drill-and-blast tunneling including LiDAR scanning for enhanced productivity in survey work, global navigation satellite system (GNSS) positioning for real-time 3D monitoring of sensitive structures with high accuracy and reliability, and interferometric synthetic aperture radar (InSAR) for comprehensive ground settlement surveys, especially in areas that are difficult to access.

LSD Chairman Sr Paul TSUI appreciated the young surveyors' efforts to arrange this virtual CPD and encouraged them to explore different disciplines and embrace new opportunities and challenges with geospatial technologies.



# PDD CPD Event: Current Development of Hydroponics in Hong Kong

On 9 November, the PDD invited Dr Lee Yiu Yiu, Agricultural Management Officer (Farm Modernisation) of the Agriculture, Fisheries and Conservation Department, to share with members the latest hydroponics developments in Hong Kong. Dr Lee introduced the recently-launched Controlled Environment Hydroponic Research and Development Centre Phase 2 and new technologies adopted including vertical mobile cultivation racks, a modular automatic seeding robotic arm, and an aeroponic cultivation rack. It also discussed the possible technical challenges when commencing

## PDD CPD Event: Structural-Grade Lightweight Steel-Concrete MiC System and Innovative Construction Material

On 23 November, the PDD invited Dr Ivan Sham, Chief Commercial Officer of Nano and

Advanced Materials Institute Limited (NAMI), to discuss the topic, "Structural-Grade Lightweight Steel-Concrete MiC System and Innovative Construction Material". NAMI is a research and development centre for nanotechnology and advanced materials that was incorporated in 2006 as an HKUST subsidiary that offers frontierapplied research on advanced materials and technology transfers for commercial purposes.

Dr Sham shared the material properties of the new structural-grade lightweight concrete, which is 40 percent lighter than ordinary concrete of the same strength, and has excellent insulation and fire-resistant properties. It can be used on external walls and last for up to 50 years.

Dr Sham also introduced the hybrid steel-concrete MiC system. With the use of new structural lightweight concrete on slabs and walls, modular weight can be greatly reduced. This is the first hybrid MiC system in Hong Kong to use structural lightweight concrete with a steel frame and the Buildings Department has granted the system In-Principle Acceptance (IPA) status.

During the Q&A session, PDD Vice Chairman Sr Annie Chong briefly discussed with Dr Sham the future prospects for this new material in other MiC and prefabricated elements. Dr Sham said that NAMI was exploring its feasibility for MiC shear walls on high-rise buildings to enhance their design.

## PDD CPD Event: Site Visit to the HKUST Shaw Auditorium

On 12 November, the PDD had the privilege to visit a new landmark at HKUST: the Shaw Auditorium, which is not normally open to the public. Mr Sam Tsen, HKUST Project Manager; Mr Ivan Chan, Technical Director of MEP Consultants; and Mr KK Kwok, an acoustic consultant, guided members on a tour of this amazing facility.

The auditorium is inside a new four-storey building that serves as a learning and gathering hub where various activities can be held. Members had no doubt that many visitors would be captivated by the iconic three-ring elliptical appearance of its exterior, which was designed by Henning Larsen Architects. However, the building is much more than an architectural beauty.

Most impressive of all is the brilliant design that allows the Auditorium to adapt to diversified operations including concerts, conferences, theatrical performances, banquets, exhibitions, congregations, etc. Its retractable seats and adjustable platform allow for a switch between "flat floor" and "raked seating" modes. Great efforts were made to manage noise to achieve excellent acoustics (NR20), while special consideration went into designing its mechanical and electrical systems to enable its flexible uses.

Besides achieving a BEAM Plus Platinum Grade, the auditorium, with ample natural lighting, sustainable materials, and integration between its interior and exterior spaces, offers a leisurely, but energetic, environment that fosters creativity.

The seminar was well-received with over 150 participants, who shared their experiences with the speakers during the Q&A sessions.





# Innovative Decarbonisation Technology to Improve **Energy Savings in Buildings**

#### Reported by PFMD Co-opted Council Member, Sr Nick Pang

A CPD on the above topic was held on 15 July. Climate change is one of the world's biggest challenges. The Paris Climate Conference agreed to try to limit global warming increases to 1.5°-2° Centigrade. Mechanical ventilation and air-conditioning units usually consume the most energy in commercial buildings. Mr Kenny Chan, Technical Consultant for Solar Farm Hong Kong Limited, shared the latest technology, graphene nanomaterial, which recovers the heat exchange capacity of coils from aircooled chillers with anti-corrosion functions to improve their performances. The coating can enhance thermal conductivity and produce a protective layer against corrosion. Some commercial buildings in Hong Kong have used this technology to enhance their performances with remarkable outcomes.





Photovoltaic systems are a hot technology in Hong Kong with income generation potential. They are also a renewable technology. Mr Benny Lo, Solar Farm's Head of Finance, shared some completed projects with their estimated annual incomes and a self-cleaning coating for solar panels to improve their efficiency.





The PFMD is grateful to Solar Farm for coming to deliver such an interesting topic for enhancing facility management, as well as saving energy, which should benefit the community as a whole.

The Faculty of Construction and Environment's (FCE) Alumni Reunion Dav at PolvU was held on 13 August to celebrate its 85th anniversary. 


# CPD: The CIC on Promoting Sustainable Construction (1 November 2022)

Sustainable construction has been a rapidly-evolving trend in Hong Kong's construction industry in recent years after the Government pledged to make the city carbon-neutral by 2050. As an industry that accounts for 39% of global carbon emissions, the construction industry should make relentless efforts to explore and adopt low-carbon solutions using a holistic approach from materials procurement to the design, planning, and construction processes. The different disciplines and expertise of building professionals should come together and practice sustainability in their everyday decisions.

The Construction Industry Council (CIC) endeavours to help local industry become more sustainable and has launched different tools and initiatives for the industry to go green.

During the webinar, the speakers (Ms Margaret HO, Manager, Industry Development – Environment and Sustainability, CIC, and Ms Ivy LEE, Senior Manager, Industry Standards and Practices, Hong Kong Green Building Council) covered the recent carbon neutrality trends and goals for the industry in both global and local contexts and elaborated on how various CIC tools, including the CIC Carbon Assessment Tool (CAT), CIC Sustainable Finance Certification Scheme (SFCS), and CIC Green Product Certification (GPC), etc, could help the industry become sustainable.






