Compatibility Needed for Government, Institution or Community Land Use

In order to meet the community's present and future needs for facilities, Government, Institution or Community (G/IC) zones are designated on Hong Kong's statutory plans to reflect existing G/IC uses and to reserve sites for future provision of G/IC facilities in accordance with the Hong Kong Planning Standards and Guidelines (HKPSG). Planning standards refer to the provision of various land uses, community facilities and infrastructure according to the size of the population. G/IC covers a wide range of uses ranging from police stations, fire stations, ambulance depots, parks, public car parks, public transport terminals, hospitals, schools, day care facilities to elderly homes etc. In this issue, surveyors will share their insights on G/IC from different perspectives.

To assist non-government organisations (NGOs) to optimise their under-utilised sites, in the 2019 Policy Address the government proposed to facilitate the redevelopment of low-rise buildings on these sites by providing support and introducing mixed residential, education and welfare uses. This will provide modernised facilities and increase the supply of various types of housing, including elderly housing, youth hostels or transitional housing. Besides, with the purpose of identifying land to increase housing supply, the Policy Address has also proposed to review G/IC sites, including developing multi-purpose public facility buildings under the 'single site, multiple use' model, developing residential projects and public facilities under a mixed development mode.

Under the circumstances of land sale, land grant and private development/ redevelopment, there might be provision of public facilities within private developments for public use, including G/IC facilities such as community halls and elderly centres etc. As governed by the specific conditions in the land leases or land grants where appropriate, some of these facilities are handed over to the relevant government departments upon completion while others are required to be managed and maintained by the private developers or owners on an ongoing basis.

Importance of compatibility

Sr Jason Kwong Wai Yin, Council Member of HKIS General Practice Division and Member of the Land Policy Panel, believes that while certain G/IC uses (such as public car parks, public transport terminals and residential care homes) can be supplied via 'single site, multiple use' model, it would be more appropriate for certain G/IC uses (such as hospitals and fire stations) to be provided on independent sites.

Regarding the practice of having private developers as providers of G/IC facilities or using residential / commercial land for G/IC facilities, he advises that compatibility and effect on land value should be emphasised. Whereas the initiatives seem to save time and cost, its social cost should not be ignored. Certain social welfare facilities may be more prone to having negative impact on land value and property prices. If these facilities and private residential/commercial land were open for auction in a bundle, it may lessen developers' enthusiasm to enter the bid. During the process, building of G/IC facilities involve complicated approval and hand-over procedures across various government departments, as well as prolonged timeframe for overall development. When the ground floor of a small construction site is used for social welfare facilities for instance, the facilities would occupy most of the ground floor space that could have been used for commercial purposes.

Apart from having developers provide G/IC facilities, he suggests that the government could use government properties (e.g. government offices) for G/IC facilities such as multi-storey government complexes which have been common. He hopes that the government will review usage of government properties and hopefully free up spaces for G/IC.

Since general practice surveyors focus on creating value, he believes the practice of having private developers provide G/IC facilities has not been particularly successful. As the government provides exemption of land premium as an incentive to encourage developers to provide premises for residential care homes for the elderly in their new private developments, he

suggests that the government also adopt similar incentives for developers to provide facilities with high compatibility such as arts and cultural facilities. As most people ultimately need elderly services, he thinks that developers could provide land to build larger residential care homes for the elderly.

As for idle or under-utilised G/IC land, he expressed the opinion that the government does not need to use them immediately. Vacant lands serve as reserves of land in the case that societal changes lead to demand for land, or when demolition or redevelopment of properties lead to decanting and thus temporary needs for land. In the long run, the government should review overall plans and development via census and planning in order to use vacant land efficiently. Progress in science and technology may bring about changing needs for G/IC lands. For instance, would Hong Kong need large-scale public charging hubs for commercial electric vehicles in future?

In conclusion, he supports the notion to consider macro, overall land administration and planning which should not be limited to G/IC. He agrees that early G/IC planning is appropriate for projects such as Northern Metropolis and Kau Yi Chau Artificial Islands. Planning should strike a balance between land values and social needs.

Fulfilling societal needs

Sr Victor Ng Pak Kin, Chairman of HKIS Planning & Development Division, cum Head of Property, The Salvation Army - Hong Kong and Macau Territory, opines that the proportion of G/IC land use is based on the respective community development, population and social needs of each district and they vary. Although some facilities might lead to resistance from residents, planning and development surveyors nevertheless try to achieve through planning an inclusive community for all, and promote equality and fairness to all age groups.

Planning and development surveyors focus on planning and design with considerations for building disposition, walkability and connectivity, in the attempt to increase compatibility among different facilities. In overall planning for new development areas, the vertical separation method can be used: for instance, parks or covered carparks can be used as buffer zone to be placed next to land use that might be considered by some as a nuisance. Residential units and certain G/IC facilities will be separated. If the G/IC itself has formed a cluster, such as those at public hospitals, residents and the G/IC can be separated by careful planning of pedestrian flow and access control. In a dense urban area or properties for urban development, the horizontal separation method can be used. For example, the ground floor can be occupied by retail shops, while first floor can be occupied by elderly home, and the podium and above can be used for residential purposes. If the site area is small, G/IC can be situated at the corner of the podium to make good use of the areas with less economic value, while maintaining consistent appearance at the exterior of the property. If the site is relatively large, such as an island site surrounded by streets on all sides, the main street with higher commercial value can be used as shopping mall or residential access, and secondary street as entrance to welfare facilities.

With changing economic development, demographics and aging population, as well as some industrial buildings being revitalised into offices and residential use, he believes there will be changing needs and allocations of G/IC facilities. Hence the government should review overall zoning and G/IC land use based on census and other data.

He hopes the government would continue using incentives such as exemptions of land premium and concessions of gross floor area to encourage developers to use private land for G/IC. He thinks that it is feasible to request developers to develop G/IC through land grant, since a lot of urban land is owned by developers. It is both efficient and effective for developers to provide land /designated areas for G/IC, while requirements for ESG (Environment, Social and Governance) provide further incentives. There are both pros and cons for the government or developers to develop G/IC, and the situation varies from district to district. He thus supports the mixed mode with efforts from both parties. In the meantime, the government could enhance publicity for G/ IC, learn from cases overseas, and achieve an inclusive society.

He pinpoints that some NGOs own G/IC land but there is a lack of financial resources to redevelop them. In order to make better use of the land owned by NGOs, in 2013 the government launched the Scheme on Privately Owned Sites for Welfare Uses to encourage NGOs to better utilise their own sites through

expansion, redevelopment or new development, to provide or increase elderly and rehabilitation service places in response to the public need of those welfare facilities.

As the Head of Property at Hong Kong and Macau Territory of The Salvation Army, Sr Victor Ng says the NGO has made applications to the above-mentioned Scheme to redevelop two existing blocks, with three and five storeys respectively, into a 21-storey youth hostel with community facilities in Wanchai. Also, there is another project converting a three-storey rehabilitation centre into an 11-storey elderly home cum day care centre in Shau Kei Wan. Since the plot ratio for non-residential land can now be maximised up to 15 times, it is expected that NGOs will expand their usable area for social welfare purposes through this Scheme.

He also mentions that normally the Housing Authority and the Housing Society are generally willing to offer rent concessions to NGOs. Developers on the other hand, work with NGOs which help to operate their G/IC facilities, so as to comply with the requirements under land lease. Due to ageing population, he hopes the government would resolve NGO's G/IC land shortage via planning, increase flexibility for fund allocation, shorten approval time, so that there would be adequate welfare facilities in every district.

The 2023 Policy Address proposed the Pilot Programme on Community Living Room (CLR), with the aim of providing households in subdivided units (SDU) with additional living space in their respective communities. Under the Programme, the business sector is encouraged to provide venues and the Community Care Fund will offer the funding to commission NGOs to operate the CLRs. Sr Ng thinks that this concept is similar to NGOs' provision of study rooms and recreational venues in the past. With the policy to support low-income people living in SDUs, he is glad to see the government promoting the Scheme in the effort to improve social connections and living standards of over 400,000 residents in SDUs.

既可提供現代化設施,也可增加各類住房供應,包括長者房屋、青年宿舍或過渡性房屋等。 另外為了覓地建屋,該施政報告提出檢視 G/IC 用地,包括以「一地多用」模式發展多用途公共設施大樓、以混合模式發展住宅和公共設施。

在牽涉賣地、批地和私人發展/重新發展的情況下,私人發展項目內亦有可能提供公眾設施,包括政府、機構或社區設施,如社區會堂、老人中心等。按有關的地契或批地文件的條款規定,一些公眾設施在落成後會交回相關政府部門,另一些則由私人發展商或業主繼續管理及保養。

需注重相容性

香港測量師學會產業測量組理事兼土地政策小組成員屬偉賢測量師認為,部分 G/IC 用途(如公共停車場/公共交通總站/院舍)較合適以「一地多

用」模式提供,亦有部分 G/IC 用途 (如醫院、消防局)則較合適以獨立用地提供。

由私人發展商擔當 G/IC 設施的提供者以及在住宅 / 商業用地闢設 G/IC 設施,必須注意用途相容性 以及對地價的影響;否則表面上省時省錢,實則 社會成本不輕。部分社福設施對地價與樓價較容 易造成負面影響,將這類設施與私人住宅/商業 用地綑綁拍賣,變相減低發展商的投地意慾。於 發展過程中,G/IC 設施的興建往往牽涉多個政府 部門的審批與交付程序,甚為繁複,同時將增加 發展整體時間。如在面積不大的地盤內將地面用 作社福設施,將可能佔據本可用作地面商業用途 的大部分空間。

政府除了要求私人發展商擔當 G/IC 設施提供者,他建議政府亦可在政府物業(如政府合署)設置 G/IC 設施,就如常見的政府多層綜合大樓。他期望當局多檢討政府物業的使用,或可騰出空間予 G/IC 使用。

作為創造價值的產業測量師,他認為私人發展商擔當作 G/IC 設施提供者的做法至今未見太大成效。因應政府透過豁免地價鼓勵發展商在新建私人發展項目中提供安老院舍院址,他建議當局亦以類似方法鼓勵發展商提供其他較相容的 G/IC 設施,例如文化藝術設施。由於大部分人最終需要長者服務,他認為亦可以由發展商提供用地興建較大型安老院舍。

至於現時仍然閒置或未被充分利用的 G/IC 用地,他表示當局不用急於徵用。社會正正需要空置土地作為儲備,以應付將來社會改變帶來的用地需求或為遷拆/重建的物業提供臨時用地。長遠來說,政府應透過人口普查與規劃詳細審視整體計劃及發展方向,以更好利用空置土地。G/IC 用地需求與科技發展亦可有密切關係,比如說,香港將來是否需要公眾的大型電動商用車充電中心?

總括而言,他支持宏觀考慮整體土地行政與規劃,而不是純為 G/IC 作規劃。他並贊成北部都會區與交椅洲人工島等地適合及早作 G/IC 規劃,而規劃應以平衡土地價值與社會需求為依歸。

符合社會需要

身兼香港測量師學會規劃及發展組主席及救世軍港澳地域物業部部門首長的吳柏堅測量師則認為每個社區的發展、人口結構比例和和社會需要都略有不同,繼而估算「政府、機構或社區」所需要的比例。雖然部分設施可能遇上居民反對,但是規劃及發展測量師的責任是透過規劃盡量達致社區共融包括傷健及長幼共融。

隨著經濟發展、人口結構改變和人口老化,部分工廠大廈亦活化成為辦公室與住宅等,他認為社會對 G/IC 的需求與地區分布亦有所改變。政府需要根據人口普查及其他數據,對整體規劃以及 G/IC 用地作出檢討。

他期望政府繼續透過提供地價或建築面積寬免的誘因,鼓勵發展商運用私人土地發展 G/IC。他認為透過賣地條款要求發展商發展 G/IC 的做法可行,因為由發展商在負責項目內興建 G/IC 會比政府自行興建更簡單便捷,同時發展商亦可因此而符合環境、社會與管治 (ESG) 的要求。然而無論



他特別指出現時部分 G/IC 的土地是由非政府機構持有卻沒有足夠資金發展以地盡其用。為了更有效利用非政府機構擁有的土地,政府於 2013 年推出「私人土地作福利用途特別計劃」,期望透過擴建、重建或新發展鼓勵非政府機構重新規劃善用其持有的土地並提供或增加安老及康復服務名額以回應社會大眾對福利設施的需求。

作為救世軍港澳地域物業部部門首長,吳柏堅測量師表示救世軍已透過上述「特別計劃」申請將灣仔兩座分別樓高三層和五層的舊有物業重建為一座樓高 21 層附設社區設施的青年宿舍。另一項目則將筲箕灣一座樓高三層用作復康的中心轉變成 11 層的長者院舍及日間服務中心。由於現時市區非住宅用地的地積比可增加至 15 倍,預料非政府機構透過計劃擴大社福用地的例子將陸續增加。

此外他表示現時房屋委員會與房屋協會在正常情況下會為非政府機構給予租金優惠,而發展商亦會邀請非政府機構營運旗下 G/IC 設施而履行地契要求。然而面對人口老化,他期望當局可以透過規劃、增加撥款的彈性和縮短審批時間,解決非政府機構 G/IC 用地不足的問題,達致每區都有足夠的社福設施。

政府在 2023 年施政報告提出「社區客廳試行計劃」,鼓勵商界、關愛基金與非政府機構合作於商界提供的場地上,讓劏房戶共享額外生活空間。吳柏堅測量師認為這概念與昔日非政府機構提供的自修室和康樂場地相似,喜見政府將之重新包裝及予以鼓勵,嘗試改善四十多萬劏房人口的社交聯繫與生活質素。

从雄安读懂「数字孪生」

哪一条道路车流量比较大?地下管廊里有没有异常?社区的垃圾箱有没有满?在河北省雄安新区,比住在城市里的人更了解这座城市的,是城市的「大脑」。

拱形的建筑立面,与湖景水面中的倒影融合,构成灵动明亮的「大眼睛」。雄安商务服务中心西侧,被称为「雄安之眼」的城市计算中心,是来雄安必看的网红打卡地。

一块巨大的电子萤幕上,清楚显示地下管网资料、 道路交通资讯甚至整个雄安新区的城市运作资料 ——这里是城市管理的智慧中枢。

「雄安之眼」为整个「数位孪生」城市的大数据、区块链、物联网等提供运算、储存和网路服务,把城市各领域的数据进行汇总集成,实现「规划一张图、建设监管一张网、城市治理一盘棋",是雄安新区的城市"大脑"。

什么叫「数字孪生」?

「雄安新区每建一栋大楼,都会在网路平台形成 与之孪生的数位化建模。」雄安新区数位城市建 设领导小组办公室相关负责人王子轩解释。

在数位孪生的技术基础上,城市「大脑」对城市 各个角落发生的事情了如指掌。

走在雄安新区容东片区一条主干道上,当你遇到的第一个交通信号灯变为绿灯后,以每小时 40 公里的车速匀速开行,遇到的一路信号灯都是绿灯,这个「绿波带」被人津津乐道。

「绿波带」的实现,是根据路口间距、交通流量等信息,对交通号志的配时等做相应调整,使得车辆行驶时实现一路绿灯或少遇红灯。在城市运算中心的「数位道路智慧营运中心」平台上,目前的车流量、壅塞指数、路段平均速度等数据都即时显示。

街道两旁的「智慧灯杆」对此也功不可没。一根根竖立在路口的多功能资讯灯杆,配置了摄影机、光达、毫米波雷达等多功能智慧型设备,能采集、汇聚、传输影像资料、雷达资料并传送到统一云平台。

雄安新区的「综合管廊智慧管理平台」与现实中的管廊就像一对孪生兄弟。该平台坚持数位城市与现实城市同步规划、同步建设,集合了电力、通讯、燃气、供热、给排水等各种工程管线,同步建有 BIM(建筑资讯模型)。

「一般工程的 BIM 以展示为主,综合管廊的 BIM 真正应用到实际管理工作当中,实现了城市管理的数位化、智慧化。」中国雄安集团基础建设有限公司营运管理部业务经理刘文举说,雄安新区的地下管廊长、管线多,其中布设了大量的传感器,可以及时将管廊内的环境参数资讯即时回传至管理平台,实现线上巡检查验。

人工智慧、5G 传输、BIM 技术、GIS(地理资讯系统)技术…许多先进的智慧化技术被应用于地下综合管廊专案管理。「管廊里有大量的城市生命线工程,一旦出现问题影响很大。而在智慧化管理平台上,漏水、瓦斯外泄等情况发生,系统能自动预警。」刘文举说。

一个是一砖一瓦砌成的现实城市,一个是资讯科技搭建的数位城市。坚持数位城市与现实城市同步规划、同步建设,雄安新区适度超前布局智慧基础设施,打造全球领先的数位城市。

独居老人在家,出现意外如何及时发现?雄安城 市计算中心的「多表集抄」系统透过数位化应用 解决了这个难题。

在「多表集抄」系统的「住户用能指标分析」功能里,居民的用水、用电、用气数据能即时收集,据此分析其入住状态。

「我们在徵得亲属的同意后,把独居老人的『多表』资讯列为重点关注对象。」雄安集团数位城市科技有限公司开发与营运中心工作人员陈海旺介绍说,如果长时间没有用水数据,系统会自动产生预警事件派单到社区,由工作人员查看老人是否需要协助。

雄安城市计算中心与综合数据平台、物联网平台、视频一张网平台以及 CIM(城市信息模型)平台,共同构成了雄安新区智慧城市中枢的「一中心四平台」,将城市的所有数据汇集起来,从源头形成高品质资料。

建城上「云」,智慧工地、智慧接驳、智慧社区、数位资产交易…在这座未来之城,数位科技领域的创新应用场景层出不穷,全面赋能城市建设、交通、运作、政务、生活、产业等方方面面。城市「大脑」记住过去、了解现在、预测未来,正让雄安越来越「智慧」。

HKIS Media Luncheon

The Institute hosted a media luncheon on 23 January which was well-covered by the media. More than 35 reporters from 19 media outlets attended and met the 2024 HKIS spokespersons.

The HKIS has introduced the spokespersons of the 6 divisions and the Young Surveyors Group. The HKIS President, Sr Francis Lam, Past President and Chairman of the Housing Policy Panel Sr CHIU Kam Kuen, Chairman of the Building Policy Panel Sr Kenny Tse, and Past President and Chairman of the Land Policy Panel Sr LAU Chun Kong, JP shared the focused issues of the HKIS this year. These issues include:

- 1. Promoting Building Affairs Expert Determination Centre (Pilot Scheme) to handle building matters disputes
- 2. Promoting digitisation in the construction industry to enhance project efficiency and safety
- 3. Establishing robust payment arrangements to improve payment problems in the construction supply chain
- 4. Further promotion of geospatial data to build smart cities
- 5. Implementing green and smart buildings for a sustainable environment
- 6. Constructing light public housing and transitional housing to alleviate grassroots housing problems
- 7. Lowering the threshold for compulsory sale to accelerate the pace of redevelopment
- 8. Establishing a building maintenance authority to enhance building safety
- Define "substandard sub-divided units" and expedite the improvement of living environment
- 10. Shorten the development time to "speed up the pace and increase the quantity"
- 11. Provide professional support to assist landowners affected by land resumption

The Institute has put forward the following five recommendations to help minimise potential disputes on home renovation, with a view to providing further information to consumers so that they can have a clear understanding of their rights and responsibilities and resolve disputes over renovation works expeditiously.

- 1. Adopt a standardised model contract
- 2. To make reference to the list of recommended terms and conditions proposed by the Institute when drafting contracts and quotations
- 3. Seek professional advice before signing the renovation contract
- 4. Make use of Building Affairs Expert Determination Centre (Pilot Scheme) to resolve renovation disputes
- 5. HKIS agrees with the Consumer Council's advocacy of establishing a "white list" accreditation system for home renovation companies and would be pleased to provide professional advice

IMPORTANT ANNOUNCEMENT

Construction Industry Safety Training Certificate ("Green Card") under the Factories and Industrial Undertakings Ordinance, Cap. 59 and updating of occupational safety and health knowledge

In the past few months, there has been a spate of industrial accidents on construction sites. Site safety is the responsibility of everyone, and all members are urged to adopt and implement safety measures and precautions for a safe working environment.

Members whose daily work requires entry into construction sites are reminded of the requirement to update their knowledge of the occupational health and safety legislation by undertaking relevant safety training courses. Members entering a construction site must hold a valid Construction Industry Training Certificate (ie Green Card).

In 2001, the HKIS was authorised by the Labour Department to issue the relevant certificate under section 6BA(4), Factories and Industrial Undertakings Ordinance, Cap. 59 (the Ordinance) to Corporate Members, and currently has arrangements in place to issue and renew the certificate to members upon their renewal of membership.

The HKIS Annual Subscription 2024-2025 and Membership Renewal Form will be issued to all members shortly. Corporate Members who are renewing their membership and would like to continue receiving the combined Membership Card cum Green Card will be required to declare that either (1) they have already acquired in the past year, or (2) will acquire in the coming year, the relevant training on occupational health and safety, before the Membership Card cum Green Card will be issued.

Members should note that the HKIS may be required upon request by the Labour Department to provide any relevant information concerning the recognition of the Corporate Members' training for the purpose of section 6BA of the Ordinance.

To facilitate members to enhance their knowledge on occupational health and safety, the HKIS is organising some CPD seminars, and members are strongly encouraged to attend the events. Coming CPD events on safety include:-





To provide timely responses to building-related affairs, the BSD produces videos to address them from a building surveyor's perspective and provide professional knowledge to educate the general public. Its first video discusses mandatory window inspections in response to a court case in which an authorised signatory of a qualified person was convicted and fined for not personally conducting a window inspection under the Mandatory Window Inspection Scheme (MWIS).

Publication

The Consumer Council recently held a press conference to summarise recent problems in the fitting-out industry. Prior to the conference, the HKIS was asked to review 40 quotations and point out their deficiencies. Then it held its own press conference on 27 February, which was widely reported in the media. BSD and QSD representatives promulgated the following solutions to improve the industry:

- I) Use a Standard Form of Contract for Decoration, Repair, and Maintenance Works, which the HKIS first published in 2008.
- II) The HKIS shall prepare a checklist of essential information and fitting-out contract information to facilitate landlord inspections.

- III) Promote the use of expert determination services administrated by the HKIS in case a dispute occurs.
- IV) Support the formation of a "whitelist" accredited by a reliable and creditable organisation.

The BSD & QSD will work together to review and update the Standard Form of Contract for Decoration, Repair and Maintenance Works in the next few months.

The BS Connect series started with a happy hour gathering on 28 February. Over 40 students, professionals, and fellow members representing different companies joined the event. Everyone enjoyed socialising and sharing ways to promote and strengthen the roles of building surveyors.

Enhancing Valuation Standards: IVS Updates and the GPD's Commitment

The International Valuation Standards (IVS), utilised by valuation professionals in over 100 countries, have become instrumental in enhancing the quality, comparability, and transparency of valuations for various assets and liabilities. These standards play a pivotal role in our complex and interconnected markets. The latest edition of IVS was recently published on 31 January and will take effect on 31 January 2025.

Recognising the fundamental role that asset valuation plays in the financial and real estate markets, the HKIS and GPD acknowledge the importance of aligning their own valuation standards with internationally-recognised practices. A working group will form under the GPD's Valuation Standards Panel to review the most recent HKIS Valuation Standards 2020 and ensure that changes to IVS will be reflected in their versions. This update, shaped by extensive collaboration, represents a significant milestone in valuation practices. The Valuation Standards Panel Committee has been instrumental in supporting this update and the GPD appreciates its valuable input.

On a side note, the highly-anticipated IVSC Hong Kong Conference is scheduled for 20-22 November 2024. This prestigious three-day event will gather industry leaders and experts from around the world and provide an exceptional platform for collaboration, knowledge exchange, and professional growth. The Conference presents an extraordinary opportunity to demonstrate leadership and cultivate collaboration within the global valuation

profession. It also promises to deliver engaging discussions, thought-provoking presentations, and invaluable networking opportunities with esteemed professionals in the field.

The GPD will keep members updated on any new development regarding the Conference as it approaches.

The Role of the Land Surveyor Expands

 Professional Services Advancement Support Scheme (PASS): Promote Land Surveying Technological Services to Belt-and-Road Countries

The LSD has collaborated with different Beltand-Road countries under a funded Professional Services Advancement Support Scheme (PASS) project that aims to promote Hong Kong's land surveying services and enhance exchanges between Hong Kong and Belt-and-Road countries. Its final event was held via Zoom on 7 February.

2. Geospatial Data

Land surveyors are no longer limited to common land surveying professions, but can also work with geospatial data. Many are equipped to discuss geo-referenced spatial data captures and data quality, along with their analysis and management. On 25 January, the LSD invited Prof John SHI of PolyU to give a CPD on this topic.

PASS

The Project commenced on 1 April 2018 with four main deliverables:

- I. Four exhibitions on land surveying services in Mainland China, Pakistan, Kazakhstan, and Sri Lanka and visits to relevant organisations in these countries
- II. Four translations/summaries of these countries' surveying laws and regulations
- III. One conference on land surveying technology in Hong Kong
- IV. Three workshops on technology transfers and surveying industry information in Hong Kong

Throughout the project period, the LSD's project team members fulfilled most of the designated deliverables including exhibiting and promoting Hong Kong's land surveying services in Pakistan and Kazakhstan. But then Covid-19 appeared and forced the project team to change its original plan from face-to-face interactions to online communications. Still, the team successfully hosted all collaborative workshops with the selected Belt-and-Road country representatives. Furthermore, it hosted a one-day conference in hybrid mode, which allowed land surveying experts from Hong Kong and the four Belt-and-Road countries to share advanced land surveying technologies.

Thanks to the LSD Council, the LSD PASS team was able to present an exhibit in Guangdong Province and conduct technical exchanges with their Mainland counterparts. Recently, the project team completed the final event under PASS: a technology exchange as an online CPD with its Sri Lankan counterparts on 7 February. During the event, four Sri Lankan land surveying experts and two Hong Kong professional land surveyors shared their perspectives on land surveying services including the latest land surveying technologies, surveying legislation, and the surveying profession in Hong Kong and Sri Lanka. Details of their exchange and the names of the speakers are as follows.

Geospatial Data CPD Highlights

Advances in Digital Twinning Technologies for Smart Cities

The LSD had the pleasure to invite fellow member Sr Prof John SHI, Director of PolyU's Otto Poon Charitable Foundation Smart Cities Research Institute and Chair Professor in Geographic Information Science and Remote Sensing, to deliver a CPD, "Advances in Digital Twinning Technologies for Smart Cities," on 25 January.

Prof SHI introduced the framework of urban informatics, which is an emergent transdiscipline that integrates urban science, computer science, and geoinformatics and aims to develop more efficient and sustainable cities. He then highlighted three recent advancements in digital twinning technologies for smart cities:


- a) A multi-platform and multi-sensor mobile mapping system for generating digital twins
- b) Quality control technologies for photorealistic 3D models for ensuring the quality of digital twins
- c) A smart city platform for managing the data and analytics of digital twins.

The talk concluded with a prediction on the future of digital twinning and a summary of the latest developments in urban informatics.


After the presentation, Sr Edmond LAM moderated a Q&A session between Prof SHI and participants, which featured insightful discussions on the governance of 3D data standardisation and the interoperability of the data captured by profound urban sensors.

On behalf of the LSD, I express gratitude to Prof SHI for taking members on a fascinating journey to build a smarter Hong Kong through the application of various advanced digital

twinning technologies including the latest urban sensory devices, standardised 2D/3D spatial data, and an interoperable city data platform for collecting and analysing static and dynamic city data. Moreover, I highly appreciate Sr Prof SHI's generosity for offering his textbook, Urban Informatics, for free download. As of this writing, it has been downloaded over 1.5 million times! I encourage all HKIS members to acquire a copy of it to capture Sr Prof SHI's knowhow and insights into urban informatics. Last, but not least, I thank Sr ZHANG Haodong for helping to host this event.



They included attending government briefing sessions, commenting on consultation papers regarding proposed legal amendments, meeting with their Mainland counterparts, exploring water seepage insurance, communicating with the media, and continuing to organise QPFMA 2024 in addition to their routine affairs. PFMD Honorary Secretary Sr Patrick Leung has been updating the PFMD website, so members may consult it to find out the latest information.

CPD on the Proposed Amendments to the Noise Control Ordinance, Cap 400, CPD & Consultation by the EPD

Reported by Sr Dr Kenny Chan, PFMD Chairman and Moderator

The PFMD was delighted to invite Ir Andrew Cheung and Carmen Cheung of the Environmental Protection Department (EPD) to introduce a proposed amendment to the NCO (Cap 400) relating to the noise control of mechanical equipment in domestic renovations on 25 January. An interesting Q&A session and polling interaction exercise between the speakers and participants followed the CPD and featured the following questions:

- Do you agree that there is a need to tighten the controls over domestic renovation noise?
- Should the proposed total number of days for renovations using percussive breakers be restricted to five or eight working days?
- To which operational hours do you think percussive breakers in renovations should be restricted?
- ➤ Should the notification fee be set at \$100 or \$500?
- ➤ Is it necessary to further control how the permitted working days are allocated for the use of percussive breakers within the first two months?
- ➤ What should the specified hours for using percussive drills during a workday be?
- Is it appropriate to set a fixed penalty at \$10,000?
- Can prior notification on the renovation schedule of nearby households help you devise a plan that can minimise your exposure to renovation noise?

Vice Chairman Sr Dick Li and I also commented on the above consultation paper to the EPD before its consultation period ended on 17 February. The proposed amendment will be submitted for LegCo's scrutiny by early 2025.

Transport Department Traffic and Transport Strategy Study Briefing Session with Professional Institutes

Maxine joined the "Traffic and Transport Strategy Study-Briefing Session with Professional Institutes, Agreement No. CE 51/2021 (TT)" with fellow surveyors on 31 January. The Transport Department is currently conducting the Traffic Transport Strategy Study (TTSS), which aims to map out a long-term transport strategy for Hong Kong (https://www.ttss.gov.hk). During the meeting, the Transport Department introduced three principal strategies and seven major directions, which extended its vision of "Transforming travel to people-centric, efficient and green journeys connecting daily lives" and elaborating on the three major strategies of "enjoyable journeys," "a well-connected city," and "healthy mobility," which were guided by the preliminary findings of the Travel Characteristics Survey 2022. Among them, the introduction of "On-Demand Public Transport Modes," "Smart Motorways," "Autonomous Vehicles," and "Support for Electric Mobility Devices" drew the most attention.

Mobile Telecommunications Service Coverage to Lifts – **EMSD** Consultation

We expressed some comments regarding the consultations over "Mobile Telecommunications Service Coverage to Lifts" advocated by the EMSD, which ended on 16 February. The PFMD welcomes the EMSD's initiative to consider facilitating the expansion of the territory's 5G infrastructure to further strengthen Hong Kong's development into a smart city. For existing lifts, related primary users/ stakeholders such as owners corporations, owners committees, and property & facility management organisations should cautiously consider adopting 5G coverage/feasibility/ increased budgets per law (such as Cap 344 BMO), so as to keep up with major societal trends. It's prudent for responsibility to be clearly established among RPs, TCPs, RCs, QPs, and even licenced PMCs/PMPs (per Cap 626 PMSO) if there are hiccups/incidents during the implementation/installation/maintenance of the 5G infrastructure.

Other Matters

PFMD Council members Sr Charles Hung, Sr Kays Wong, Sr Denny Yeung, Sr Jonathan Lee, and Sr Louis Lee hosted a fruitful Zoom meeting on 17 January with Vice Chairman Mr J Yau of the Hong Kong Federate of Insurance (also the council member of the Insurance Complaint Bureau) regarding water seepage insurance and the detailed arrangements for "home insurance" handling and claim issues.

- Vice Chairman Sr Louis Lee and I joined the HKIS Media Luncheon with fellow surveyors on 23 January, during which we had constructive communications with various media/news agencies, especially regarding hot PFM topics.
- Congratulations to PFMD Honorary Secretary Sr Patrick Leung, who was nominated as Community and Charity Services Committee Chairman for the 2024 Council year at the GC meeting on 24 January.
- Shenzhen Property Management Association representatives visited the HKIS on 25 January and were well received by PFMD OBs Sr Louis Lee, Sr Patrick Leung, and me. The PFMD anticipates more cooperative opportunities between the two organisations in the near future.
- I was invited for a live interview by i-Cable/ Hoy TV on 31 January regarding the Municipal Solid Waste Charging Scheme, scheduled to be launched on 1 August 2024. I covered some crucial topics relating to general education, training, refuse collection applications, designated bags/labels, resources allocation, legal management fee adjustments/increases as per Cap 344 Building Management Ordinance, etc, for various properties from a professional PFM perspective. I anticipate to promote a more holistic/practical approach for tackling those concurrent issues that would most concern the general public. - PFMD Council members Sr Danny Leung and Sr Jonathan Lee joined a sharing session with fellow surveyors regarding DevB's "Roadmap on Adoption of Building Information Modelling (BIM) for Building plan Preparation and Submission" on 2 February. The PFMD expects to conduct more trainings for surveyors to become qualified BIM managers.
- The QPFMA OC held its third meeting on 7 February to deliberate on the following issues:

- Constructive discussions regarding award type/category, judging criteria, and submission guidelines, especially towards the main theme



Procurement Strategy and Contractual Arrangement (29 January 2024)


For his talk, KC discussed procurement strategy and contractual arrangements for construction works including contract types and standard forms, contract packaging, and considerations for risk-sharing. Then he showed participants how to improve their procurement skills, which is an issue that quantity surveyors face every day.



Specialisation Series 2024: The Role of Quantity Surveyors in Construction Arbitration, Adjudication, and Mediation (5 February 2024)

Another PQSL event by QSD Vice Chairman Sr Eric Ting occurred before the Chinese New Year and focused on a specialised aspect of quantity surveying. Eric is an experienced QS in the construction industry, specialising in dispute resolution and contract advice. He divided his talk into three sessions.

Finally, he highlighted the four key roles played by QS professionals in dispute resolution including contract advice and conducting case analyses.




